
CLOSURE OF ROAD

MELBOURNE CRICKET GROUND (OPERATION OF FLOODLIGHTS) ORDER NO. 4/1999

I, Marie Tehan, Minister for Conservation and Land Management, make the following Order:

MARIE TEHAN Minister for Conservation and Land Management

Dated 4 October 1999.

1. Title

This Order may be cited as the Melbourne Cricket Ground (Operation of Floodlights) Order No. 4/1999.

2. Objectives

The objectives of this Order are to -

- (a) specify the days and times during which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be used; and
- (b) specify the purposes for which the floodlights may be used on those days;
- (c) make provision in relation to vehicle entry into the Yarra Park Reserve.

3. Authorising provision

This Order is made under section 3 of the Melbourne Cricket Ground Act 1984.

4. Floodlights may be used on certain days at certain times and for certain purposes

The floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be used -

- (a) on 6 October 1999 and 7 October 1999 for all purposes relating to training sessions in respect of the International Football Rules Series - Australia v Ireland between 5.30 p.m. and 10.30 p.m.; and
- (b) between 8.00 a.m. and 5.30 p.m. for the purpose of aligning, testing or repairing of the floodlights, on the days specified in sub-clause (a).

5. Yarra Park Reserve - Entry of Vehicles

On any day on which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground are permitted to be used for the purposes specified in clause 4(a) and (b), vehicular traffic is not permitted to enter the Yarra Park Reserve by way of Vale Street after 5.00 p.m.
