Subordinate Legislation Act 1994 OCCUPATIONAL HEALTH AND SAFETY (MAJOR HAZARD FACILITIES) REGULATIONS 1999

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994**, that a regulatory impact statement (RIS) has been prepared in relation to the proposed Occupational Health and Safety (Major Hazard Facilities) Regulations 1999.

The objective of the proposed Regulations is to introduce a comprehensive, performance-based approach to promote the safe operation of major hazard facilities (MHFs). The proposed Regulations will give effect to the *National Standard for the Control of major hazard facilities* in Victoria. The National Standard has been endorsed by the National Occupational Health and Safety Commission following comprehensive national development and public comment processes.

The proposed Regulations will require MHFs as defined to be registered and licensed, and for those purposes the operators of the facilities will be required to prepare a safety/property assessment and implement controls (including establishing and maintaining a safety management system and preparation of emergency plans) associated with the operation of a MHF. In addition, operators of MHFs will also be required to prepare and submit a safety case to the Authority.

The costs and benefits of the proposed Regulations are outlined in the RIS. The RIS concludes that the benefits of the proposed Regulations are likely to outweigh the costs and will assist in preventing and mitigating the effects of major incidents.

Two alternatives to the proposed Regulations are considered in the RIS. The first alternative considered involves the use of a Code of Practice with reliance on the general duties under the **Occupational Health and Safety Act 1985**. As there are no mandatory requirements under codes, this alternative was rejected as it is considered that the nature of the problem requires a mandatory approach via regulation rather than reliance upon voluntary compliance. The second alternative considered increasing or reducing the regulatory scope and increasing or reducing the range of regulatory duties. This alternative was rejected as it was considered not capable of meeting the objective of the proposed Regulations and would lead to a diminution of any benefits achievable under a nationally uniform approach.
