Melbourne City Link Act 1995

ORDER REVOKING TEMPORARY RESERVATIONS OF LAND FOR THE PURPOSES OF THE MELBOURNE CITY LINK PROJECT

The Governor in Council, on the recommendation of the Minister for Transport (being the Minister administering the **Melbourne City Link Act 1995**) that the temporary reservation of all licensed land (including the land specified in the Schedule) be revoked on the termination of the licences as to that land, under section 59 (2) of that Act —

- (a) revokes the reservations under the **Crown Land (Reserves) Act 1978** of all licensed land, and
- (b) without limiting the generality of paragraph (a), revokes the reservations under the **Crown Land (Reserves) Act 1978** of the licensed land described in the Schedule.
