
Melbourne City Link Act 1995 NOTICE TO PUBLIC BODIES

In accordance with section 46 of the **Melbourne City Link Act 1995** ("the Act") notice is given of the proposal to issue a licence or licences under section 56 of the Act in respect of the land described in the Schedule below.

Amendment L325

The Minister for Planning and Local Government has approved Amendment L325 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment inserts an incorporated document into the Schedule of Site Specific Controls to Clause 314 A-9 and to Clause 343-5 of the Scheme to allow a roof top airconditioning plant at Cliveden Hill Private Hospital at 29 Simpson Street, East Melbourne, in accordance with the conditions contained in the document.
