DECLARATION UNDER SECTION 45 OF THE HEALTH SERVICES ACT 1988 - COMMUNITY HEALTH CENTRES

I, Brian Joyce, Regional Director, Southern Metropolitan Region and delegate to the Secretary to the Department of Human Services, pursuant to section 45 of the **Health Services Act 1988** (the "Act"):

revoke, under section 45(2)(b) of the Act, the declaration of Heathlands Community Health Service Incorporated as a community health centre, which declaration was made on 4 August 1997 pursuant to section 45(1) of the Act; and

declare, under section 45(1)(c) of the Act, Central Bayside Community Health Services Incorporated, to be a community health centre; and

declare, under section 45(1)(d) of the Act, the area being that part of the Cities of Bayside, Kingston and Greater Dandenong as bounded by Port Phillip Bay and South, Bluff, Wickham, Chesterville, Keys, Warrigal and Kingston Roads, Boundary, Lower Dandenong, Springvale Roads and the Mordialloc Main Drain and Perry, Worsley, Thompsons Roads, the Mornington Freeway and Eel Race Roads, to be the area served by Central Bayside Community Health Services Incorporated.

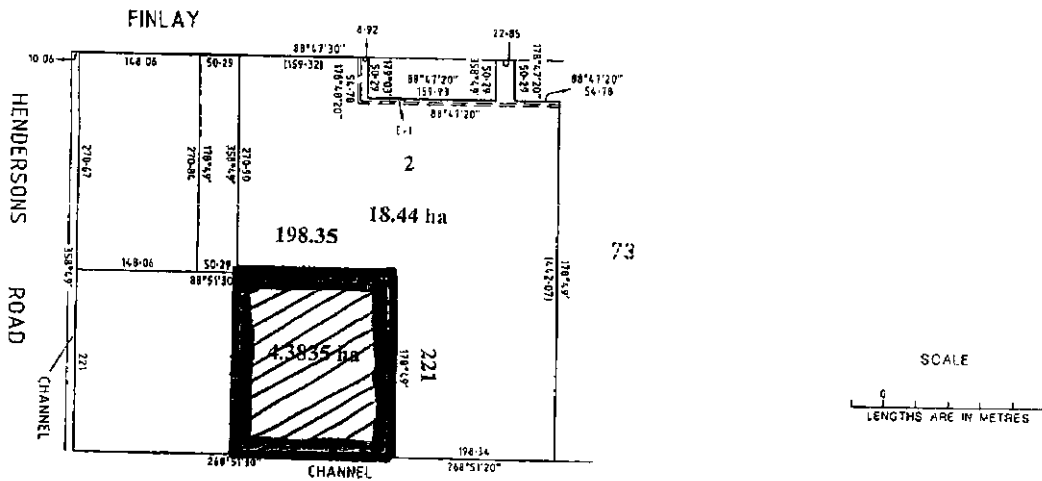
