3- Once the suspension of registrations are removed, the nurse's registrations be subject to conditions that he may not work on night shift, nor work in single-client nursing.

On 16 April 1998, the nurse filed with the Administrative Appeals Tribunal an application to review the finding and determination of the panel. On 11 February 1999, that application was by leave withdrawn.

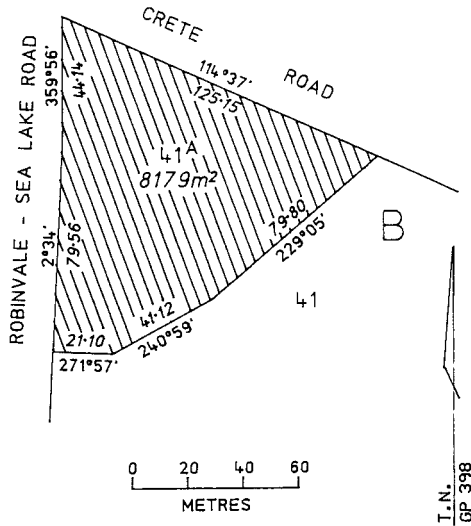
