Notice of Approval of Amendment

Amendment L58

The Minister for Planning and Local Government has approved Amendment L58 to the Hume Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment rezones land at the south west corner of Station and Evans Streets, Sunbury from part Restricted Business and part Restricted Light Industrial (Bulla) zone to Business 1 zone and introduces specific matters to be considered when deciding on an application for permit.
