## Wildlife Act 1975

### WILDLIFE (CONTROL OF HUNTING) NOTICE NO. 1/1999

I, Marie Tehan, Minister for Conservation and Land Management, make the following Notice:

#### 1. *Objective*

The objective of this Notice is to prohibit absolutely the taking, destroying or hunting in Victoria of certain taxa of duck during the specified periods.

#### 2. *Authorising provision*

This Notice is made under section 86 of the **Wildlife Act 1975**.

#### 3. *Commencement*

This Notice takes effect on 20 March 1999.

#### 4. *Hunting of duck prohibited*

The taking, destroying or hunting of any taxa of duck listed in the Schedule to this Notice is prohibited in Victoria absolutely during the periods from the beginning of the first Saturday of the 1999 duck open season (20 March) until 7:10 a.m. east of the line of longitude at 146°30' east, 7:20 a.m. between the line of longitude 146°30' east and the line of longitude at 142°30' east and 7:30 a.m. west of the line of longitude at 142°30' east, on that day.

#### 5. *Penalty*

Any person who contravenes this Notice is guilty of an offence and liable to a penalty not exceeding 25 penalty units.

**Wildlife (Control of Hunting) Notice No. 2/1999****1. Title**

This Notice may be cited as the Wildlife (Control of Hunting) Notice No. 2/1999.

**2. Objective**

The objective of this Notice is to prohibit absolutely the taking, destroying and hunting of the taxa of duck specified in Schedule 1 below in the areas of Victoria specified in Schedules 2, 3 and 4 below during the period commencing on Saturday 20 March 1999 and ending on Monday 14 June 1999 (both dates inclusive).

**3. Authorising provision**

This notice is made under section 86 of the **Wildlife Act 1975**.

**4. Hunting of wildlife prohibited**

The taking, destroying and hunting of the taxa of duck specified in Schedule 1 is prohibited absolutely -

- (a) in the area described in Schedule 2 below; and
- (b) in the area described in Schedule 3 below; and
- (c) in the area described in Schedule 4 below -

during the period commencing on Saturday 20 March 1999 and ending on Monday 14 June 1999 (both dates inclusive).

**5. Penalty**

Any person who contravenes this Notice is guilty of an offence and liable to a penalty of 25 penalty units.

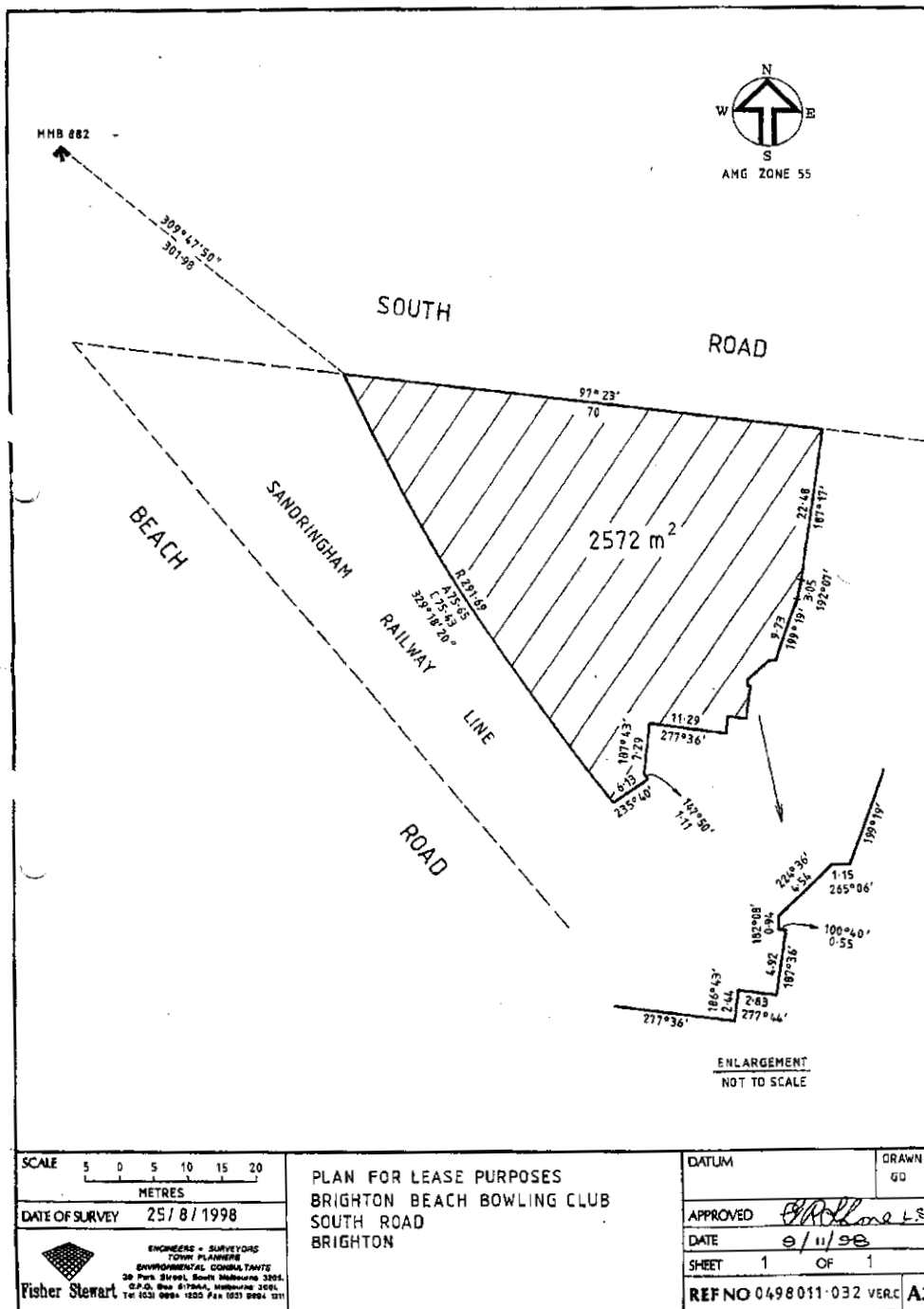
**Crown Land (Reserves) Act 1978****ORDER GIVING APPROVAL TO THE GRANT OF LEASE**

Under sections 17D(1) and 17DA of the **Crown Land (Reserves) Act 1978**, I, Marie Tehan, Minister for Conservation and Land Management, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease to the Brighton Beach Bowls Club Inc. by the Bayside City Council for the playing of bowls and associated social activities on part of the Brighton Beach Reserve described in the Schedule below and, in accordance with section 17D(3) of the **Crown Land (Reserves) Act 1978**, state that:

- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.
