NOTICE TO PUBLIC BODIES

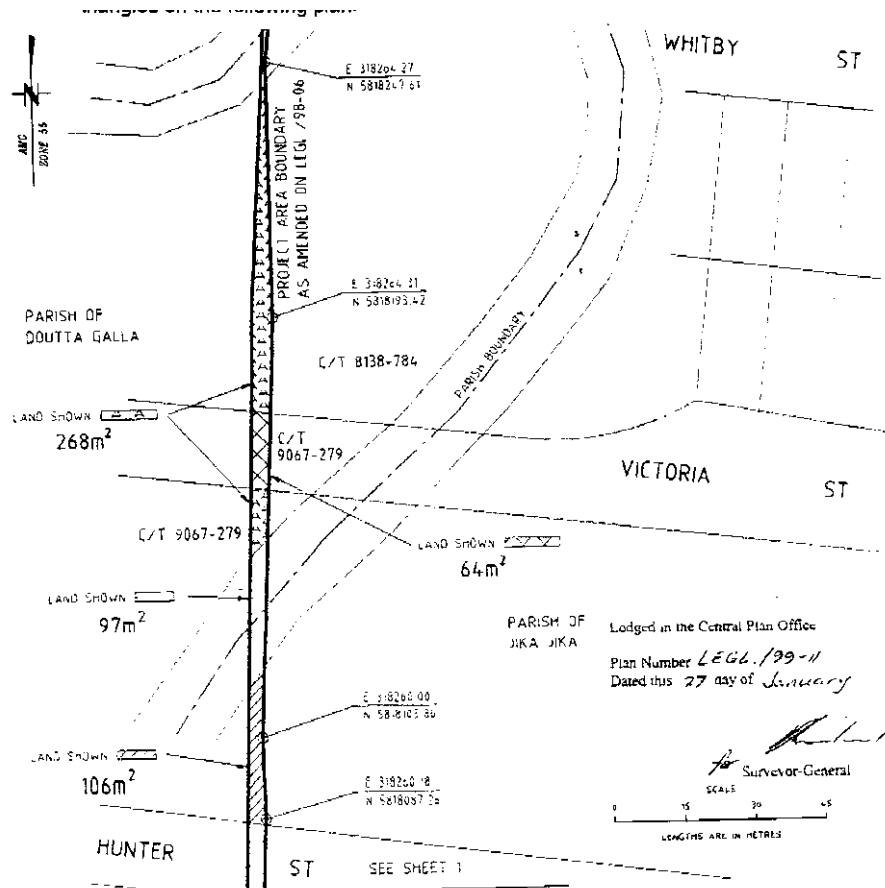

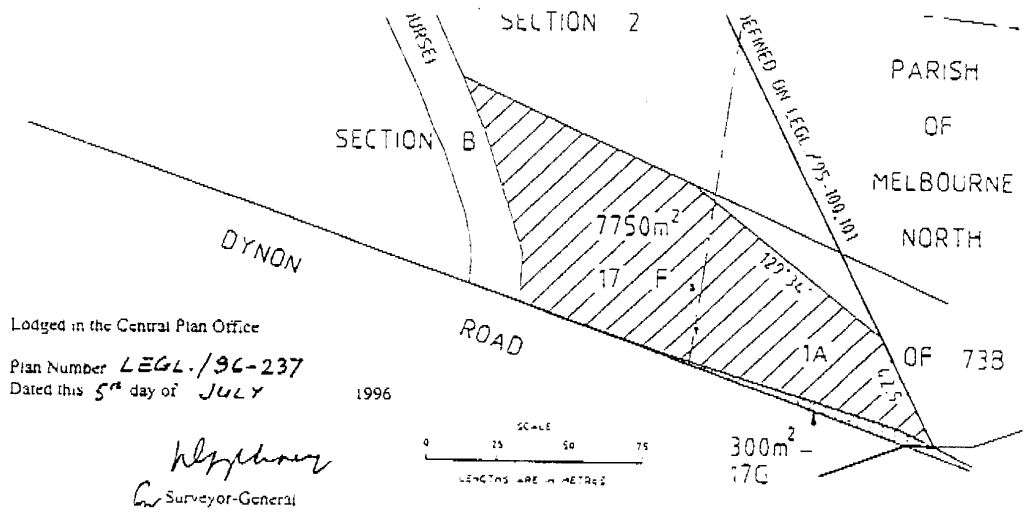

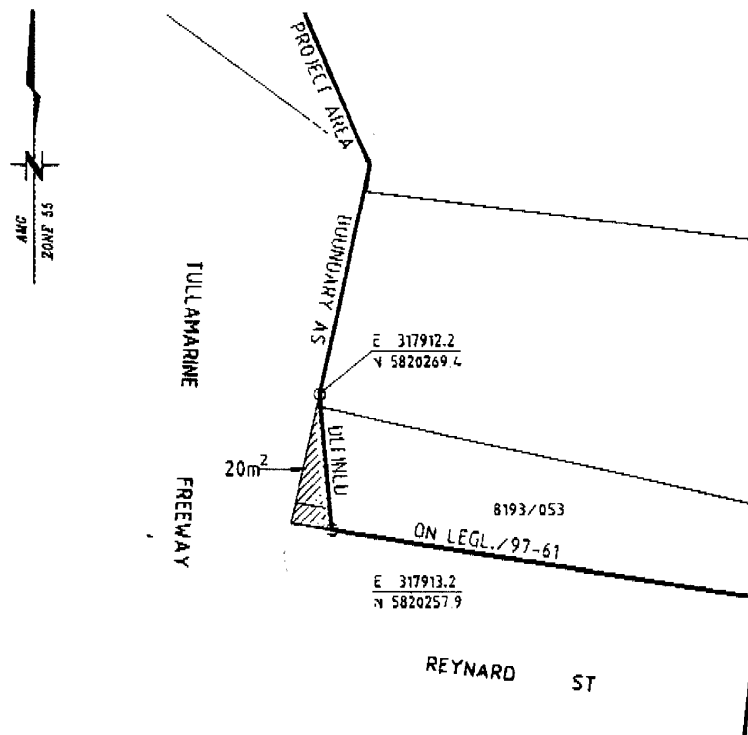
The land shown diagonally hatched, cross hatched, stippled and hatched with triangles on the following plan:



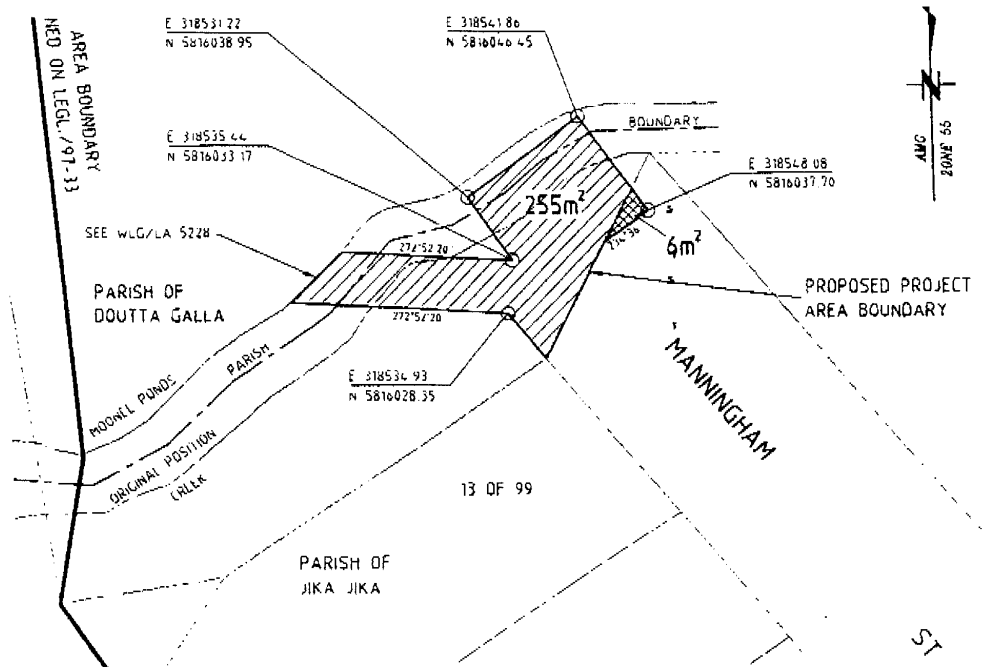
The land shown stippled and of 300 metres square on the following plan:



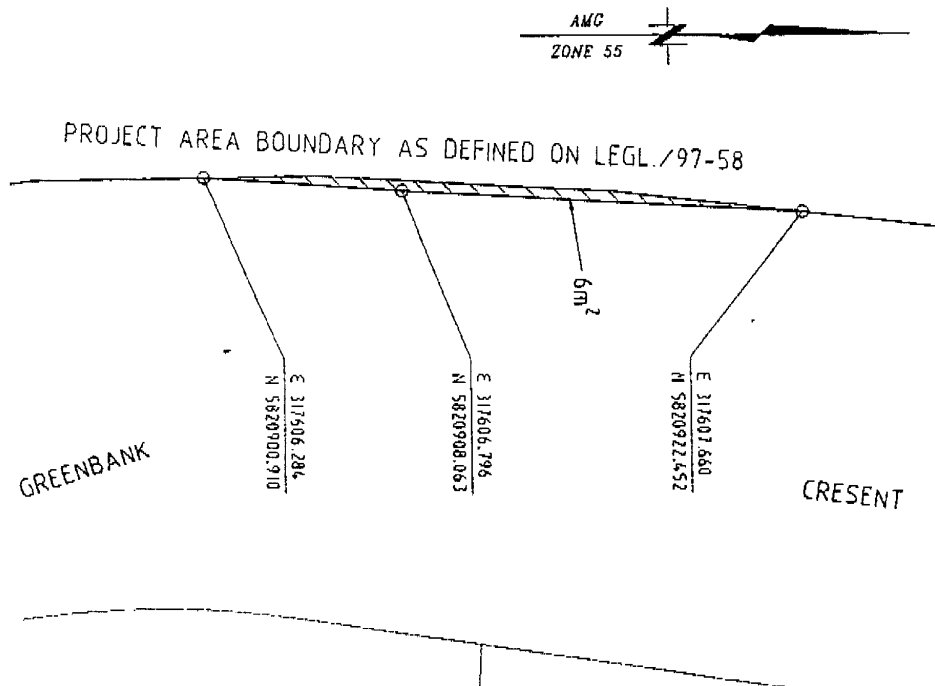
The land shown diagonally hatched on the following plan:



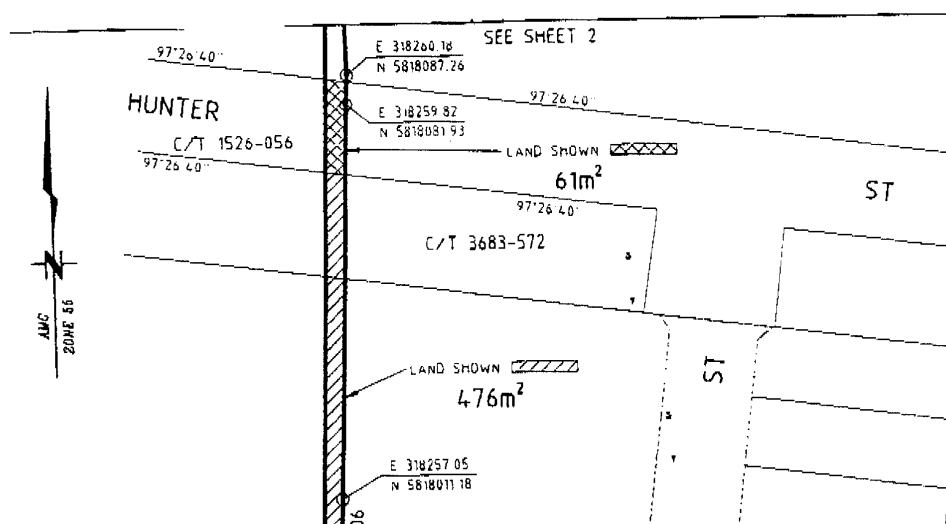
The land shown diagonally hatched and cross hatched on the following plan:



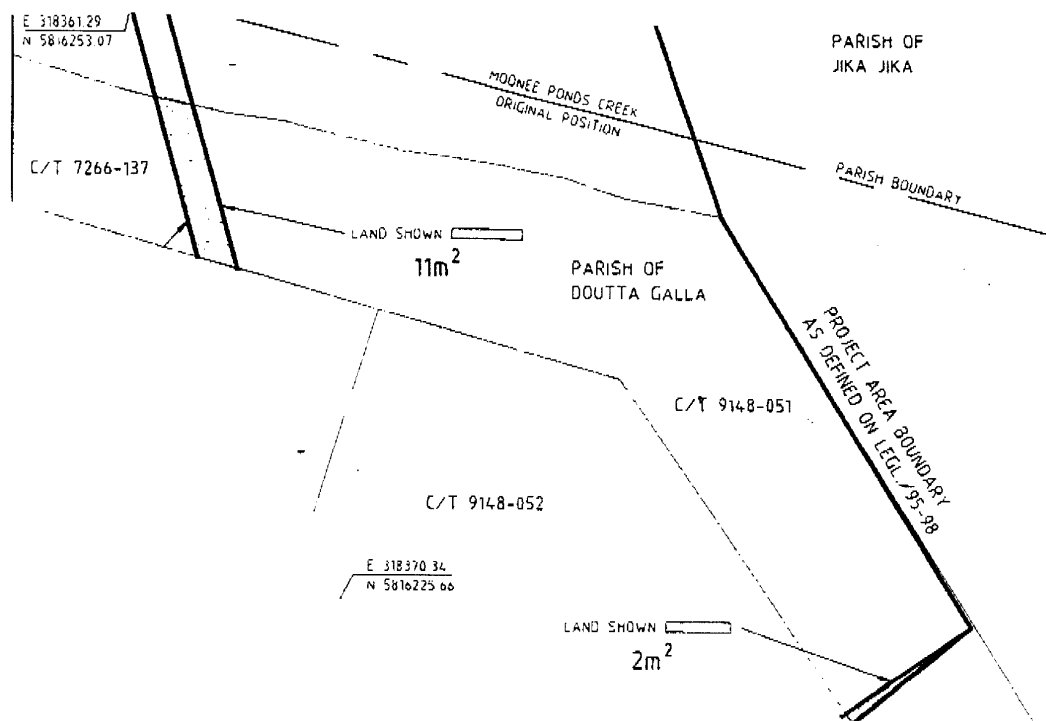
The land shown diagonally hatched on the following plan:

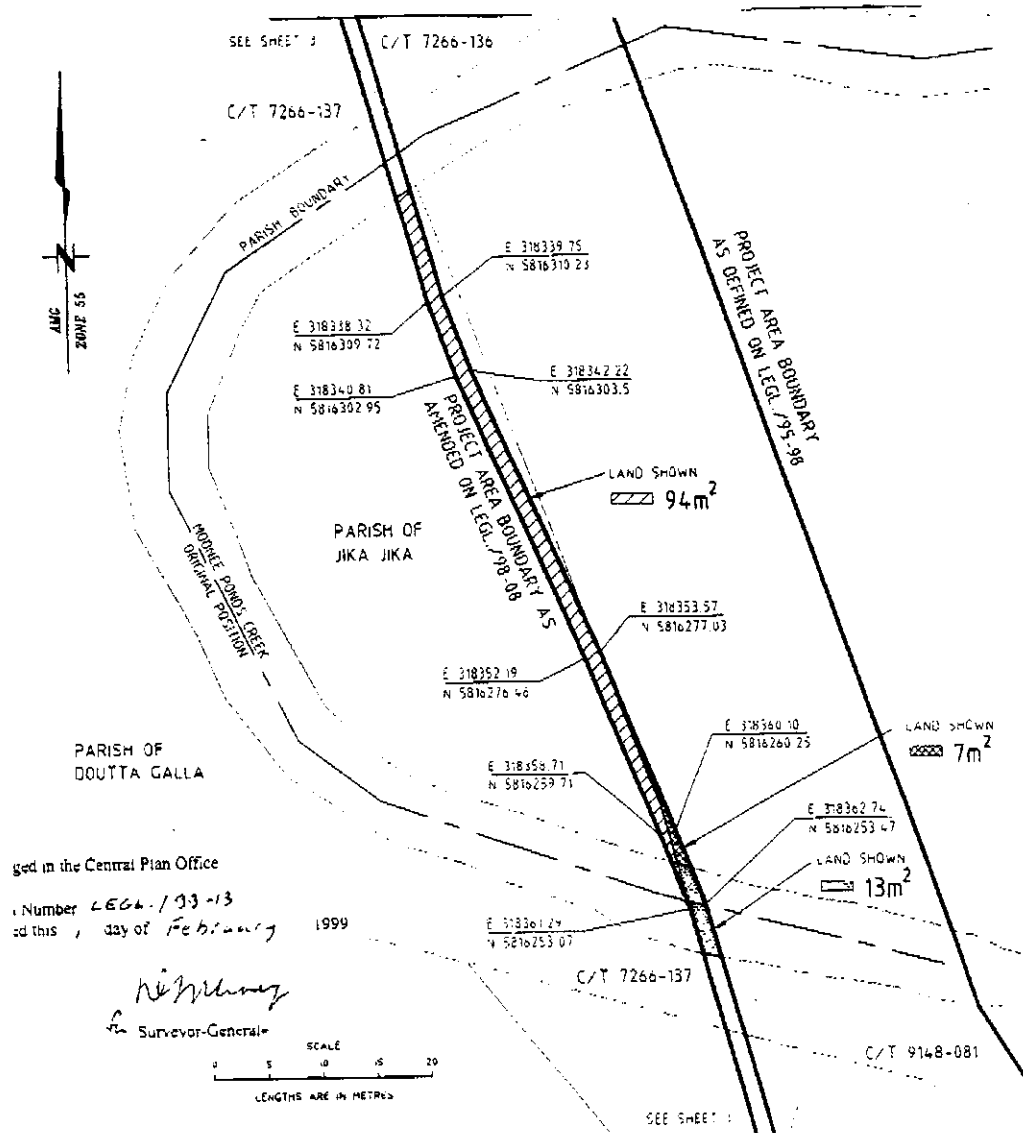

PARISH BOUNDARY

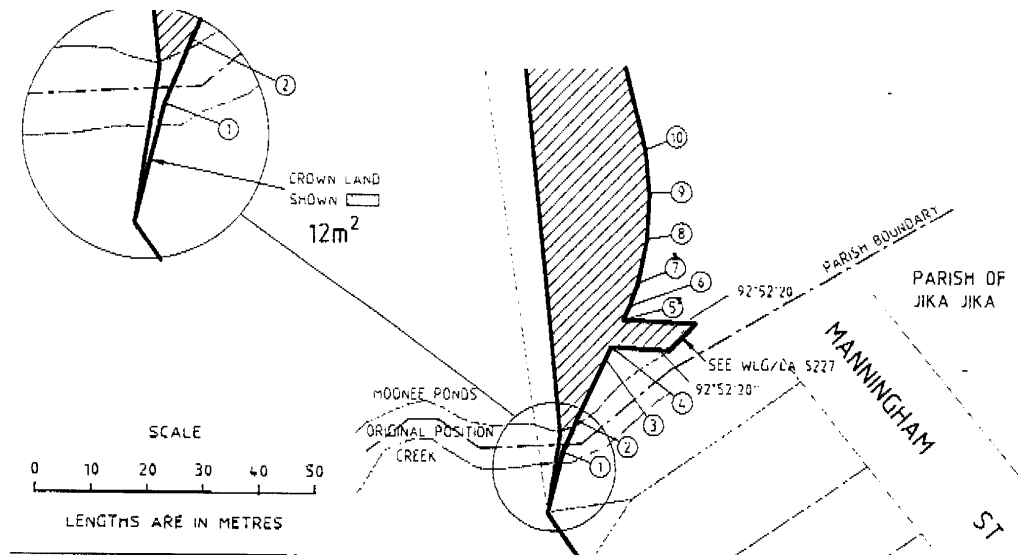
PARISH OF

AS DEFINED ON LEGAL 95-88

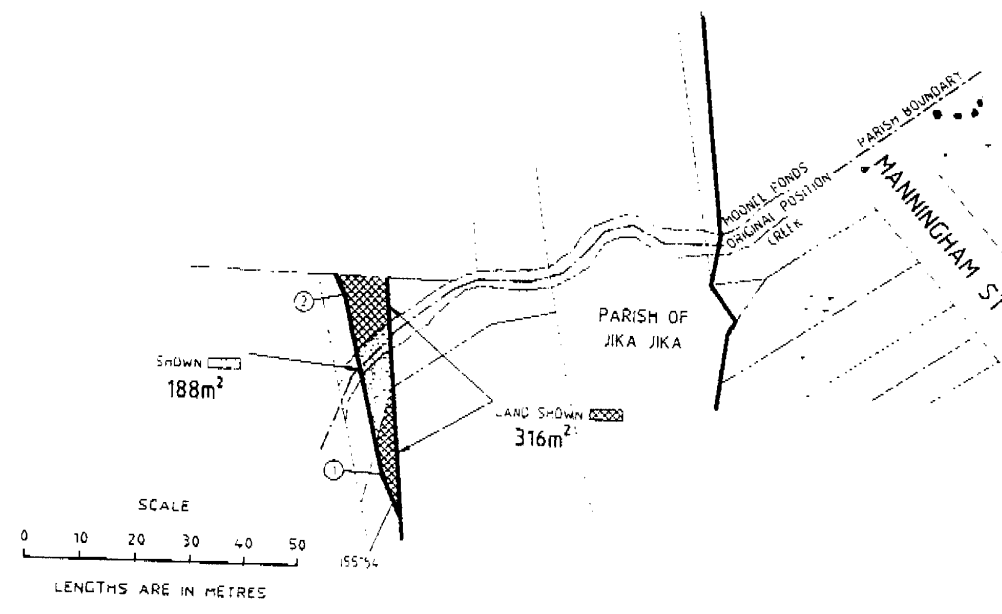
The land shown diagonally hatched, cross hatched and stippled on the following plan:



The land shown stippled and of 12 metres square on the following plan:

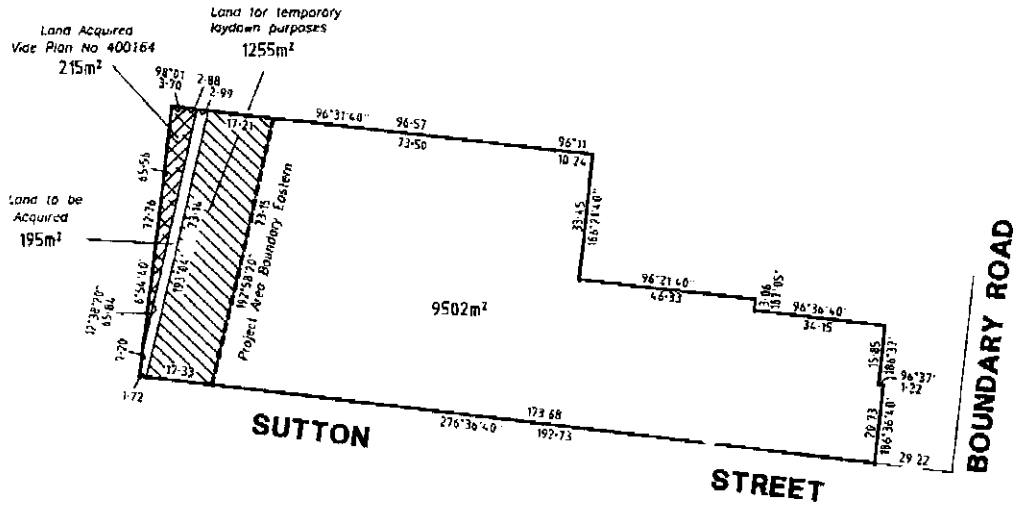


The land shown square hatched and stippled on the following plan:
