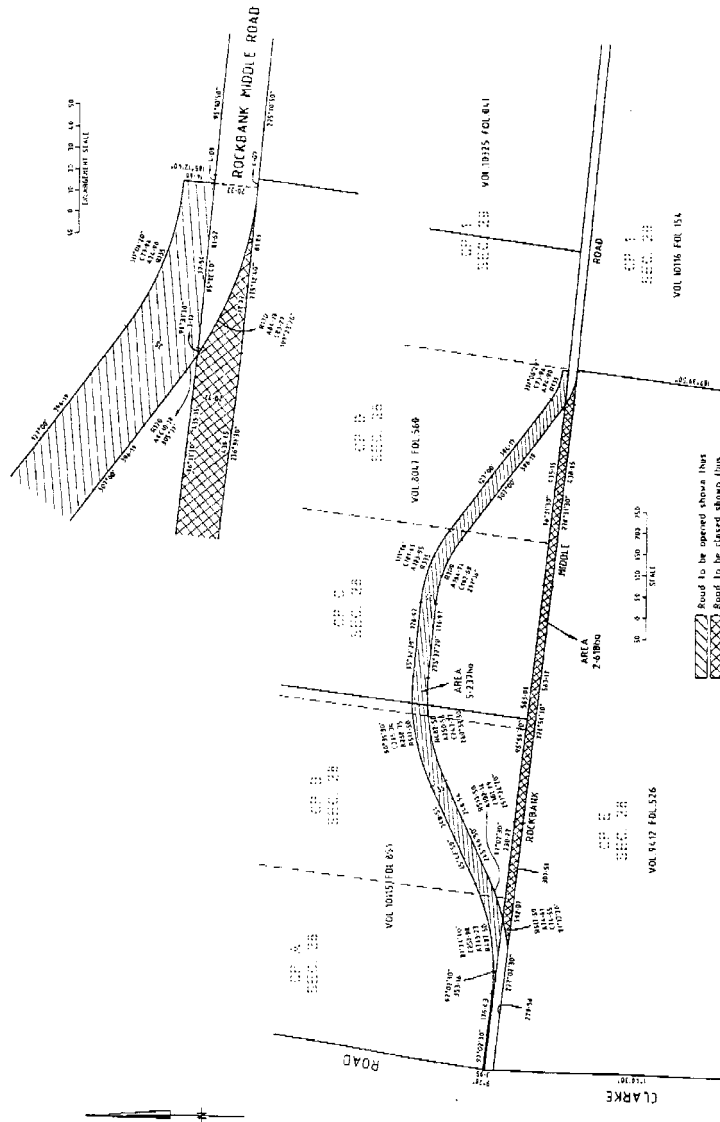

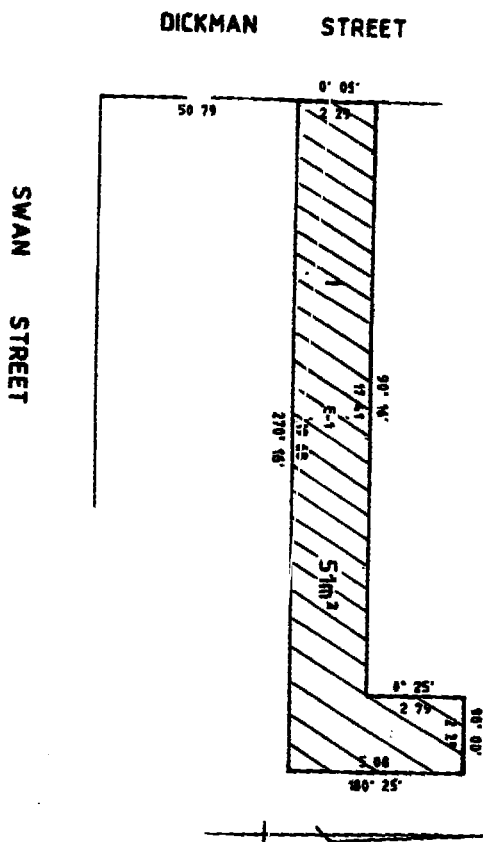

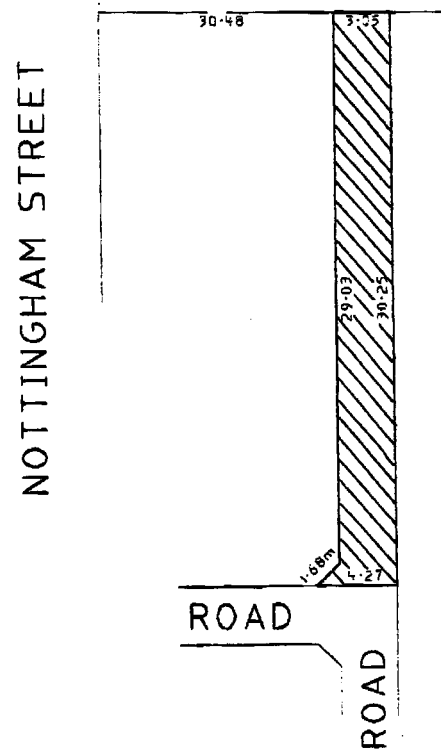

**RACECOURSE ROAD**

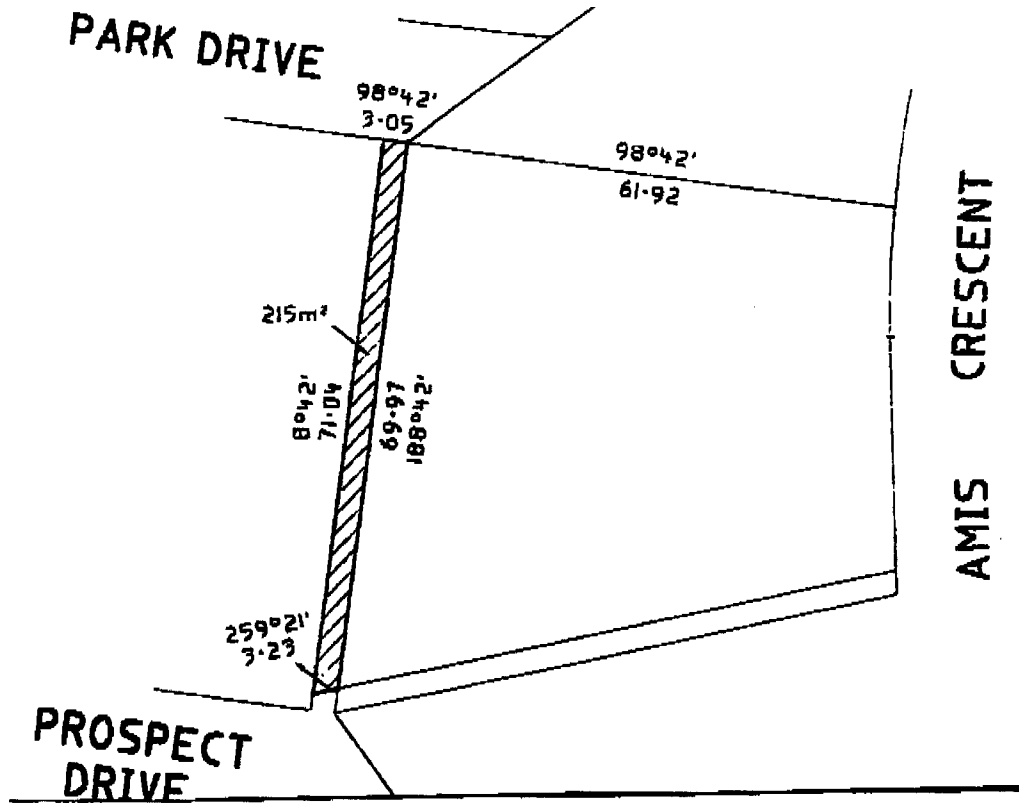
