





Notice is hereby given in accordance with Section 119 of the Local Government Act 1989 that the Bass Coast Shire Council, at its meeting on 21 April 1999, resolved to make Local Law No. 8 entitles Council Roads and Land Local Law and Local Law No. 9 entitled Environment and Amenity Local Law.

Local Law No. 8 - Council Roads and Land

The purpose of the Local Law is to provide for the peace, order, and good government of the Bass Coast Shire in a way that is complimentary to the goals in the Council's Community Plan by:-

- (a) managing the uses and activities on roads and Council land so that the council is aware of uses or activities which may:-
 - interfere with the safety and convenience of people travelling on or using the road or Council land; and
 - impede free and safe access for people, in particular those with sight and movement impairment or disabilities; and
 - cause damage to Council and community assets; and
 - create a danger or expose others to risk; and
 - be detrimental to the amenity of the area or the enjoyment of facilities on roads or council land.
- (b) identifying activities and uses on roads and Council land where a permit is not required but conditions are applicable to the use so that the purposes identified in paragraph (a) are achieved;
- (c) identifying activities an duses that are not permitted on roads and Council land;
- (d) providing for the administration of the Council's powers and functions.

The general purport of the Local Law is to:-

- specify that a permit must be obtained from the Council before a person uses a road or Council land for the following activities:-
 - (a) constructing or altering a vehicle crossing;
 - (b) installing a temporary vehicle crossing;

- (c) using a heavy vehicle contrary to a signed restriction;
- (d) grazing livestock;
- (e) droving livestock through the municipal district;
- (f) placing directional signs;
- (g) placing advertising signs in business and industrial areas:
- (h) trading from a vehicle;
- (i) trading from door to door;
- (j) displaying goods and services for sale or hire;
- (k) placing tables and chairs;
- (l) placing bulk rubbish containers;
- (m) occupying the road for works;
- (n) having a street party, festival or procession;
- (o) collecting money, gifts or subscriptions
- (p) busking;
- (q) placing posters, signs or advertisements or graffiti on Council buildings and fixtures; and
- (r) landscaping, planting trees, shrubs and other vegetation on Council land.
- specify that a person must observe the requirements applied in the Local Law to:-
 - (a) the location of trees, plants and signs on a person's property which obstruct or interfere with pedestrians or vehicular traffic;
 - (b) the display of property numbers;
 - (c) naming a road;
 - (d) vehicle crossings for vehicle access;
 - (e) redundant vehicle crossings;
 - (f) fencing to contain livestock;
 - (g) using toy vehicles;
 - (h) moving livestock from one property to another in the municipal district.
- specify that the following activities are not permitted on Council roads or Council land:-
 - (a) trading from another person's designated site;
 - (b) using toy vehicles in prohibited areas;
 - (c) riding or leading a horse on a road or Council land if the activity is causing a

- nuisance to pedestrians or vehicles or damage to the road or Council land;
- (d) leaving a shopping trolley anywhere other than in an area or at a collection point designated for the return of shopping trolleys;
- (e) dismantling, painting, carrying out maintenance or repairs on a vehicle on a road except where it is necessary to enable the vehicle to be removed;
- (f) damaging roads or Council land;
- (g) boisterous or harmful behaviour interfering with the quiet enjoyment of Council land by other people;
- (h) smoking in smoke free areas.
- providing for the issue of permits and infringement notices by Council.

Local Law No. 9 - Environment and Amenity

The purpose of the Local Law is to provide for the peace, order, and good government of the Bass Coast Shire in a way that is complimentary to the goals in the Council's Community Plan by:-

- (a) managing activities and uses on roads and Council land which may be dangerous, cause a nuisance or be detrimental to the amenity of the area or the environment;
- (b) regulating and controlling activities to maintain a healthy and safe environment in the municipal district for residents and visitors;
- (c) identifying requirements or conditions that must be observed to ensure that a safe, healthy and enjoyable environment for residents and visitors is maintained;
- (d) providing for the administration of the Council's powers and functions.

The general purport of the Local Law is to:-

- specify that a permit must be obtained from the Council before a person undertakes any of the following activities:-
 - (a) using a recreational vehicle on Council land or private land;
 - (b) using the Council's designated boat ramps;
 - (c) camping on Council land or public land;
 - (d) camping on private vacant land;
 - (e) conducting carnivals and festivals;

- (f) scavenging at the resource recovery centre;
- (g) connecting into Council drains;
- (h) lighting fires in the open air in a built up area;
- (i) lighting fires on Council land;
- (j) interfering with or removing native vegetation from Council land.
- specify the activities or uses where a person must observe the conditions applied to them in this Local Law:-
 - (a) floodlighting on properties;
 - (b) adequate animal shelters;
 - (c) waste and recyclable materials;
 - (d) commercial and industrial trade waste;
 - (e) transportation of wastes;
 - (f) use of resource recovery centre;
 - (g) dumping of refrigerators and ice chests.
- specify the activities and uses not permitted:-
 - (a) the keeping of land in dangerous or undightly manner;
 - (b) playing a musical instrument, shouting, singing or haranguing in a public place in a way that it is objectionable to other people;
 - (c) placing household, commercial or industrial waste in Council litter bins on any Council land or road;
 - (d) removing recyclable material left for collection;
 - (e) allowing a nuisance fire to remain alight;
 - (f) burning certain substances;
 - (g) taking of glass into a designated glass drink container free zone; and
 - (h) using a recreation vehicle on a Total Fire Ban Day.
- providing for the issue of permits and infringement notices by Council.

Council also prepared a Local Laws Policy and Procedures Manual which includes:-

 procedures applying to the exercise of Council's powers in relation to roads and traffic under the Local Government Act 1989; and • a Signage in Public Places Policy.

The proposed Local Laws should be read in conjunction with the Manual.



Electricity Safety Act 1998

DECLARATION UNDER SECTION 4

Order In Council

The Governor in Council under section 4 of the **Electricity Safety Act 1998** declares that such of the provisions of this Act specified in this Order do not have effect to such extent as is specified -

Part 1

Section 4(1)(a) of the Electricity Safety Act 1998 Electrical contractors and electrical workers

- 1. Sections 30 and 36 of the Act do not have effect in relation to an **electrical contractor** engaged in contracts relating to -
 - (a) design, building, construction, renovation or maintenance in the building and construction industry; or
 - (b) the supply of electrical equipment

where as part of the contract the contractor sub-lets the contract to a registered electrical contractor

- 2. Sections 30 and 36 of the Act do not have effect in relation to an **electrical contractor** if he or she contracts or undertakes to carry out the following electrical installation work -
 - (a) work carried out by a licensed electrician from time to time for no financial profit and on gratuitous basis on condition that prior to the commencement of the work the contractor advises the person for whom the work will be carried out that he or she is not a registered electrical contractor and does not hold the prescribed insurance;
 - (b) work at premises which the contractor occupies for residential purposes carried out by the contractor under the conditions of his or her licence under section 38(a) of the Act to carry out the electrical installation work at those premises;
 - (c) work permitted under a disconnect/reconnect worker's licence under regulation [305] of the Electricity Safety (Installations) Regulations 1999;
 - (d) work that involves the repair or maintenance of an electrical installation following disconnection under a disconnect/reconnect worker's licence under regulations [305] of the Electricity Safety (Installations) Regulations 1999;
 - (e) work that involves the installation or alteration of a cold-cathode illumination system from or commencing at the control panel or terminals of the equipment or at the transformer at which the final subcircuit which supplies the equipment terminates but does not include any part of the wiring of the final subcircuit which supplies the relevant equipment or transformer.
- 3. Sections 36 and 38(a) of the Act do not have effect in relation to an **electrical installation** worker if he or she carries out the following electrical installation work -
 - (a) work under the effective supervision of a licensed electrician within the period of 3 months from completion of an apprenticeship in that class of electrical work under section 39 of the Act;
 - (b) work under the effective supervision of a licensed electrician during the course of a contract of training, an examination or assessment but other than permanent electrical installation work;
 - (c) work on low voltage fixed electrical equipment, except cold-cathode illumination systems and wiring of final subcircuits, that involves the repair or maintenance of the electrical equipment or a component of that electrical equipment following disconnection of the equipment on condition that disconnection and reconnection of the equipment is carried out by a person holding a disconnect/reconnect worker's licence for that electrical equipment under regulation [305] of the Electricity Safety (Installations) Regulations 1999.
- 4. (a) Sections 36 and 38(a) of the Act do not have effect in relation to an **electrical installation worker** if he or she carries out the following electrical installation work and is certified in accordance with paragraph (b) -
 - (i) work carried out by a person who has satisfactorily completed a course or practical assessment in cold-cathode illumination systems that involves the installation of a cold-cathode illumination system from or commencing at the control panel or terminals of the equipment or at the transformer at which the final subcircuit which supplies the equipment terminates in accordance with Australian/New Zealand Standard, 'Electrical installations- Cold-cathode illumination systems', AS/NZS 3832:1998, but does not include any part of the wiring of the final subcircuit which supplies relevant equipment or transformer; or
 - (ii) work carried out by a person who has satisfactorily completed a course or practical assessment in cold-cathode illumination systems that involves the alteration, repair or maintenance of a cold-cathode illumination system in accordance with

Australian/New Zealand Standard, 'Electrical installations- Cold-cathode illumination systems', AS/NZS 3832:1998, following disconnection of the system on condition that disconnection and reconnection of the system is carried out by a person holding a disconnect/reconnect worker's licence for that electrical equipment under regulation [305] of the Electricity Safety (Installations) Regulations 1999 but does not include any part of the wiring of the final subcircuit.

- (b) An employer of a person referred to in paragraph (a) may certify that the person is competent to perform the relevant work, if the employer is satisfied that the person -
 - (i) possesses the qualifications, proficiency and experience to enable that person to perform that work; and
 - (ii) has been properly trained in the safety aspects and limitations in relation to that work.
- 5. (a) Sections 36 and 38(a) of the Act do not have effect in relation to an **electrical installation worker** if he or she carries out the following electrical installation work and is certified in accordance with paragraph (b) -
 - (i) work on electrical equipment that is used as part of a railway or tramway system within the meaning of section 93(1) of the **Transport Act 1983** or for signalling purposes within such a system;
 - (ii) work carried out under the effective supervision of a licensed electrician by a person who has completed a contract of training as an electric lineworker that involves -
 - A. the repair or replacement, for the purpose of maintenance of restoring electricity supply to a consumer, of apparatus installed at the junction between an electricity supplier's conductors and a consumer's conductors or on a panel provided solely for an electricity supplier's metering and control equipment; or
 - B. electrical installation work on outdoor lighting that has been installed for the safety of the general public on land controlled by a government department, municipal council or body established for a public purpose by an Act of Parliament of Victoria or the Commonwealth; or
 - electrical installation work on high voltage aerial and underground electric lines in an electrical installation and associated substations and equipment; or
 - electrical installation work on low voltage aerial electric lines in an electrical installation and associated equipment installed for the control or protection of those lines; or
 - E. electrical installation work comprising the jointing of underground wiring; or
 - (iii) work carried out under the effective supervision of a licensed electrician by a person who has completed a contract of training as an electrical fitter at a substation in an electrical installation; or
 - (iv) work on wiring supports and enclosures under the effective supervision of a licensed electrician; or
 - (v) telecommunications work by a telecommunications worker.
 - (b) An employer of a person referred to in paragraph (a) or a licensed electrician may certify that the employee or person is competent to perform the relevant work, if the employer or electrician is satisfied that the person -
 - possesses the qualifications, proficiency and experience to enable that person to perform that work;
 - (ii) has been properly trained in the safety aspects and limitations in relation to that work.
- 6. Section 38(b) of the Act does not have effect in relation to an **electrical inspector** if he or she carries out electrical inspection work under the effective supervision of a licensed electrician or licensed electrical inspector during the course of a contract of training, an examination or assessment but other than inspection work for the purposes of section 45 of the Act.

7. Section 38(b) of the Act does not have effect in relation to an **electrical inspector** if he or she carries out testing or inspection of electrical equipment that is not related to the carrying out or completion installation work.

Part 2

Section 4(1)(b) of the Electricity Safety Act 1998

Electrical equipment

1. Divisions 1, 2 and 3 (with the exception of section 43) of Part 3 of the Act do not have effect in relation to the following **electrical installations** -

Electrical installations -

- (a) upstream of the point of supply except electrical installations used for the consumption of electricity by the electricity supplier;
- (b) comprising of connections to consumers terminals for the purpose of providing electricity supply;
- (c) owned by an electricity supplier for metering or the control or protection of metered or metering circuits;
- (d) used in the operation of mining under licence within the meaning of the **Mineral** Resources Development Act 1990;
- (e) comprising of fixed electrical equipment designed to be easily transportable connected to the electricity supply by the insertion of a plug into a socket designed for such a plug;
- (f) used in a cathodic protection system or a mitigation system.
- 2. Sections 54 and 57(1) of the Act do not have effect in relation to the supply of second hand **electrical equipment** on condition that -
 - (a) the electrical equipment is not subject to a withdrawal of approval or a prohibition of supply or a recall of electrical equipment by the Office or by a prescribed authority under Part 4 of the Act or subject to a direction under section 141 of the Act; and
 - (b) the person supplying the second hand equipment in the course of business ensures that -
 - (i) the equipment on inspection and testing complies with Australian/New Zealand Standard, 'In-service safety inspection and testing of electrical equipment', AS/NZS 3760:1996, and is labelled to show compliance; or
 - (ii) the equipment is clearly marked "DANGER DO NOT USE OR CONNECT TO SUPPLY THIS ELECTRICAL EQUIPMENT MAY BE FAULTY AND SHOULD BE INSPECTED AND TESTED BY A COMPETENT PERSON IN ACCORDANCE WITH AS 3760"; and
 - (iii) a label is attached to the equipment stating that the equipment is second hand.
- 3. Sections 54 and 57(1) of the Act do not have effect in relation to the supply of second hand **electrical equipment** on condition that the person supplying the second hand equipment -
 - (a) is not supplying the equipment in the course of business; and
 - (b) ensures that a label is attached to the equipment stating that the equipment is second hand.
- 4. Section 68(1) of the Act does not have effect in relation to the supply of the following proclaimed **electrical equipment** manufactured or imported prior to 30 September 1999 for the period from 1 October 1999 to 30 September 2000 -
 - (a) refrigerating appliances registered or deemed to be registered under the Electricity Safety (Equipment Efficiency) Regulations 1999 until 30 September 1999 which do not comply with with the minimum energy performance standards set out in clause 3.5 of Australian/ New Zealand Standard, 'Performance of household electrical appliances - Refrigerating appliances - Part 2: Energy labelling and minimum energy performance standard requirements, AS/NZS 4474.2:1997, on condition that the appliances are labelled in accordance with that expired registration; and

(b) storage water heaters - unvented without an attached feed tank which do not comply with the minimum energy requirements set out in clause 2.4 of Australian Standard, 'Storage water heaters - Part 1: General Requirements', AS 1056.1:1991.

Part 3

Section 4(1)(c) of the Electricity Safety Act 1998 Electrical work

Divisions 1, 2 and 3 (with the exception of section 43) of Part 3 of the Act do not have effect in relation to the following electrical installation work -

Electrical installation work -

- (a) on any electrical installation in the process of manufacture at a place other than the land where it is to be fixed;
- (b) on any electrical installation in the course of repair or maintenance at a place other than the land where it is to be fixed;
- (c) involving the insertion or removal of -
 - (i) a plug into or from a socket designed for such a plug; or
 - (ii) a light globe, fluorescent tube or starter for a fluorescent tube, where access to live parts is not required; or
 - (iii) a fuse element.
- (d) involving the installation or removal of listening devices or radio frequency transmission equipment carried out by a serving member of the Victorian Police Force who has satisfactorily completed a training course approved by the Office and in conjunction with a warrant granted under the **Listening Devices Act 1969**.

Except where expressions are defined in the Act, expressions used in this Order have the same meaning as they have in the **Electricity Safety (Installations) Regulations 1999**.

 - (c) has a rated cooling capacity of up to 7.5 kW;
 - (d) is of the non-ducted type; and
 - (e) has a single refrigeration circuit with one evaporator and one condenser.

PART 2

- 1. "Storage water heater" an electrical appliance which -
