NOTICE TO PUBLIC BODIES

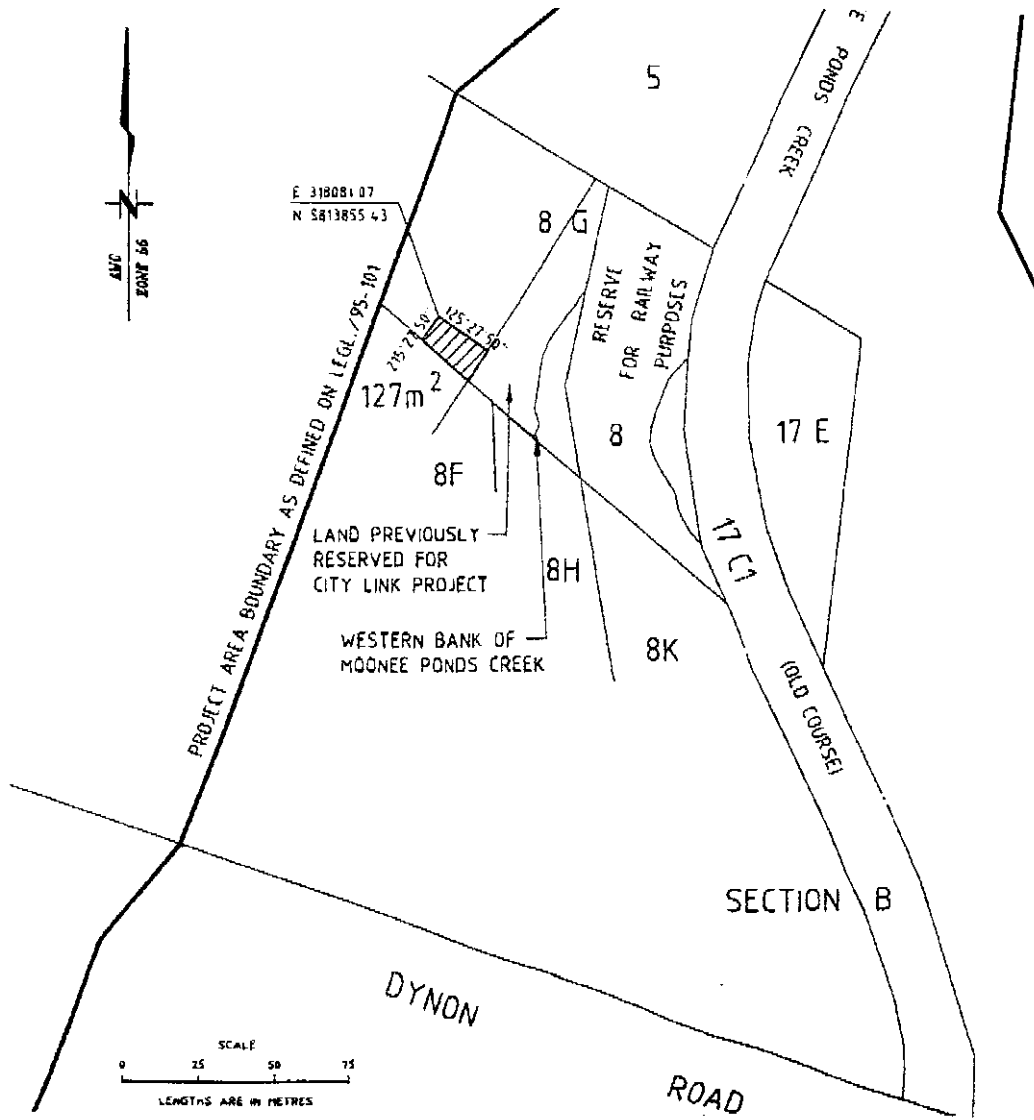

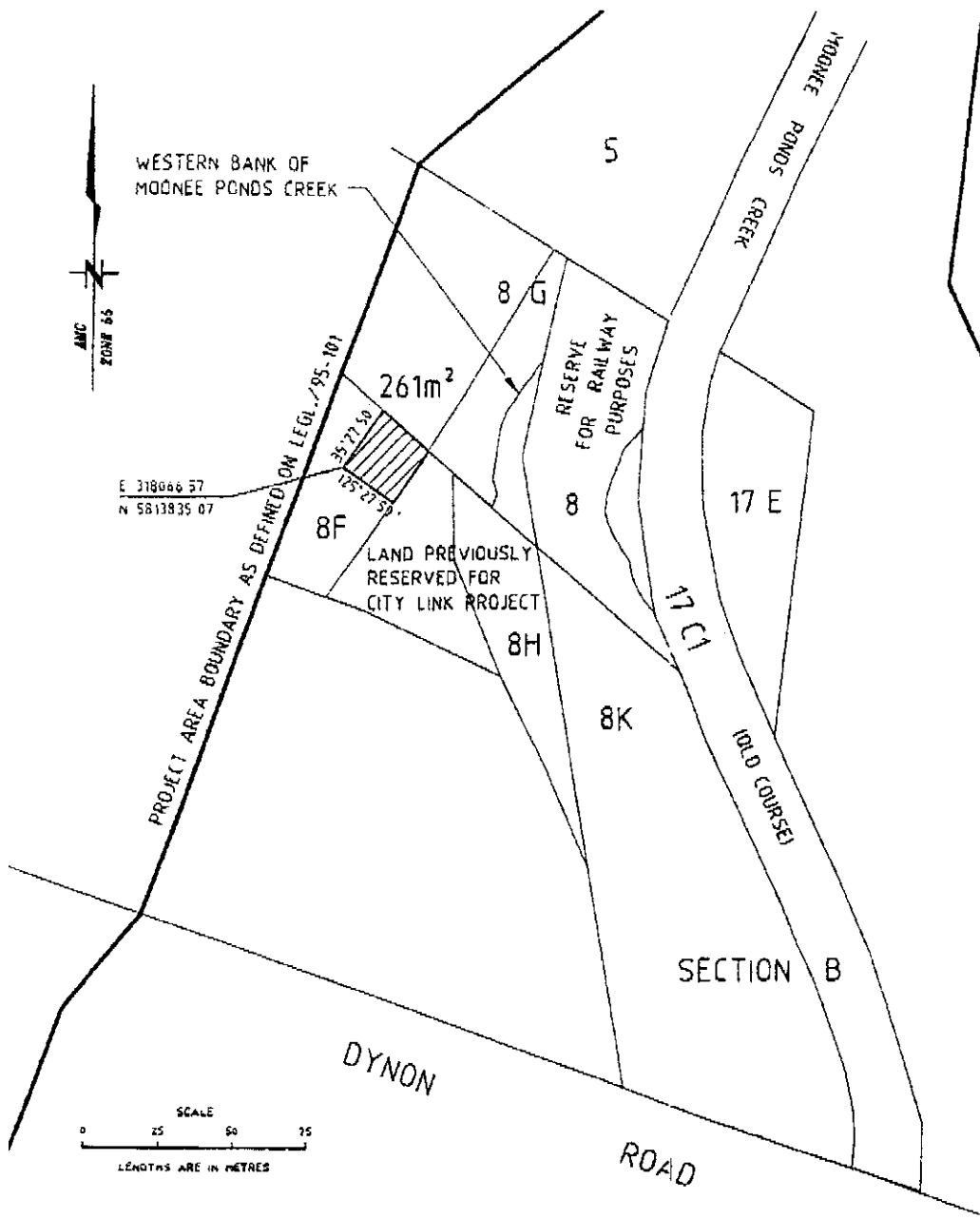

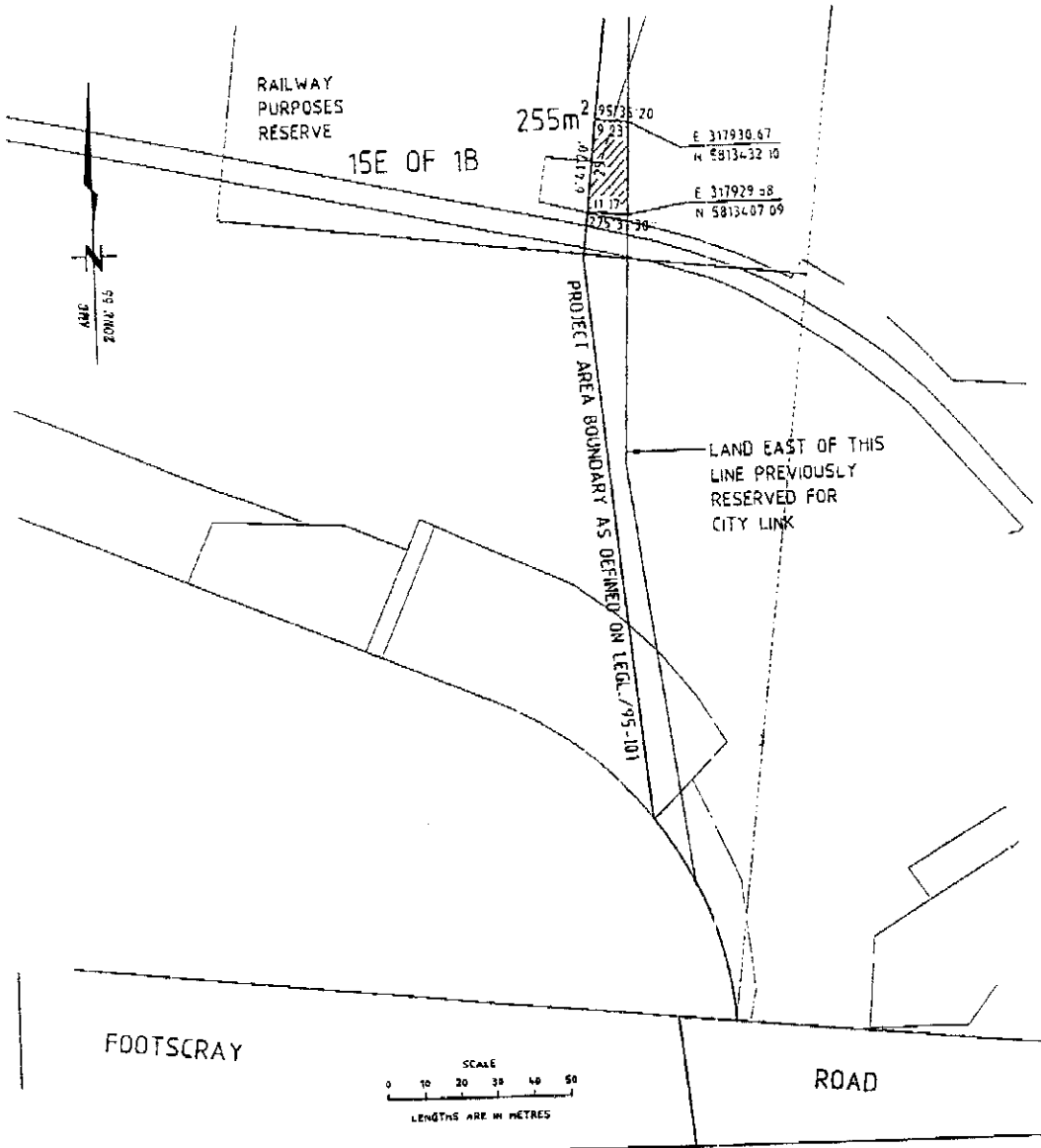
The land shown diagonally hatched on the following plan:



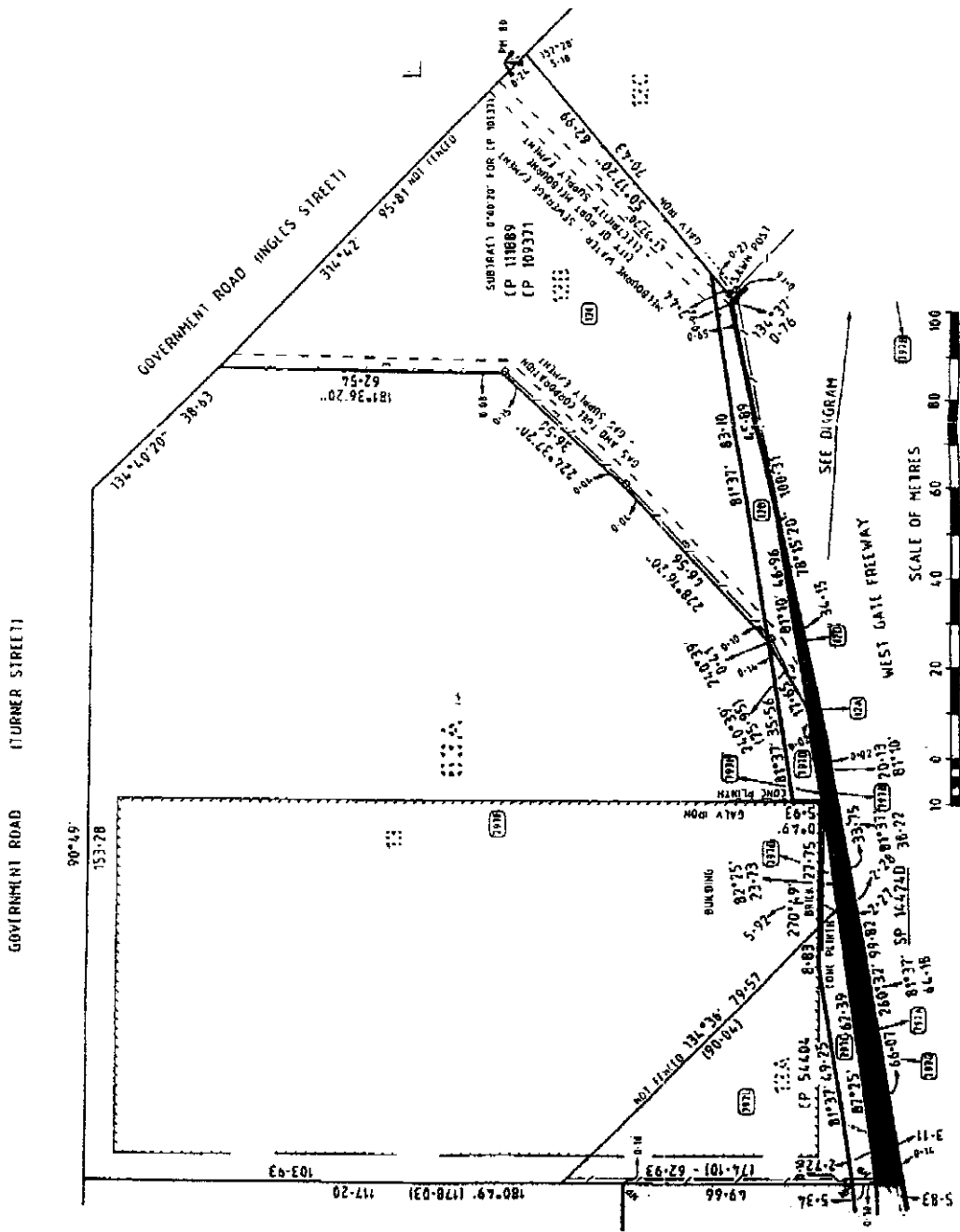
The land shown diagonally hatched on the following plan:



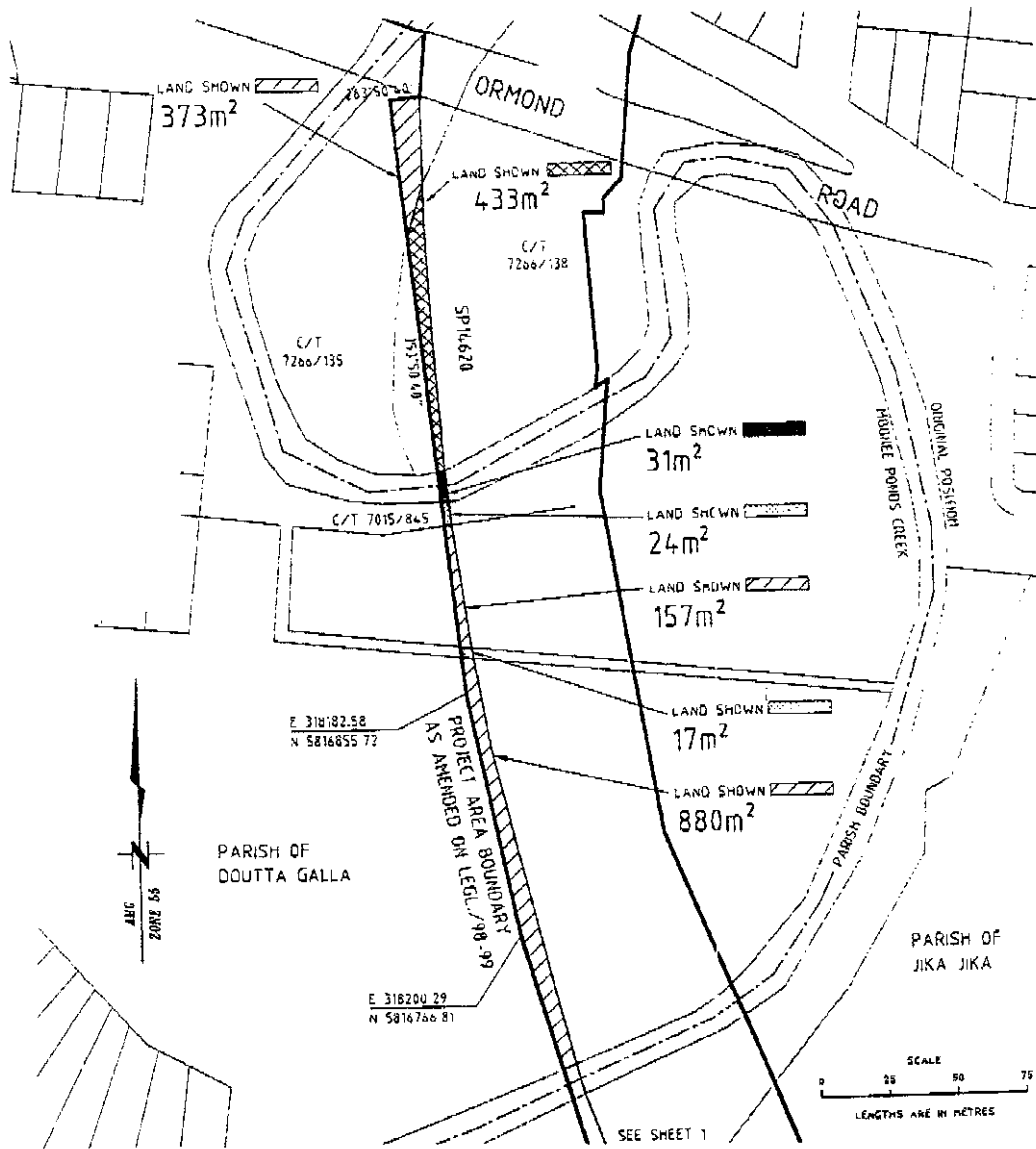
The land shown diagonally hatched on the following plan:



The land shown shaded on the following plan:



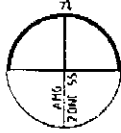
The land shown cross hatched on the following plan:

NOTICE PURSUANT TO SECTION 41

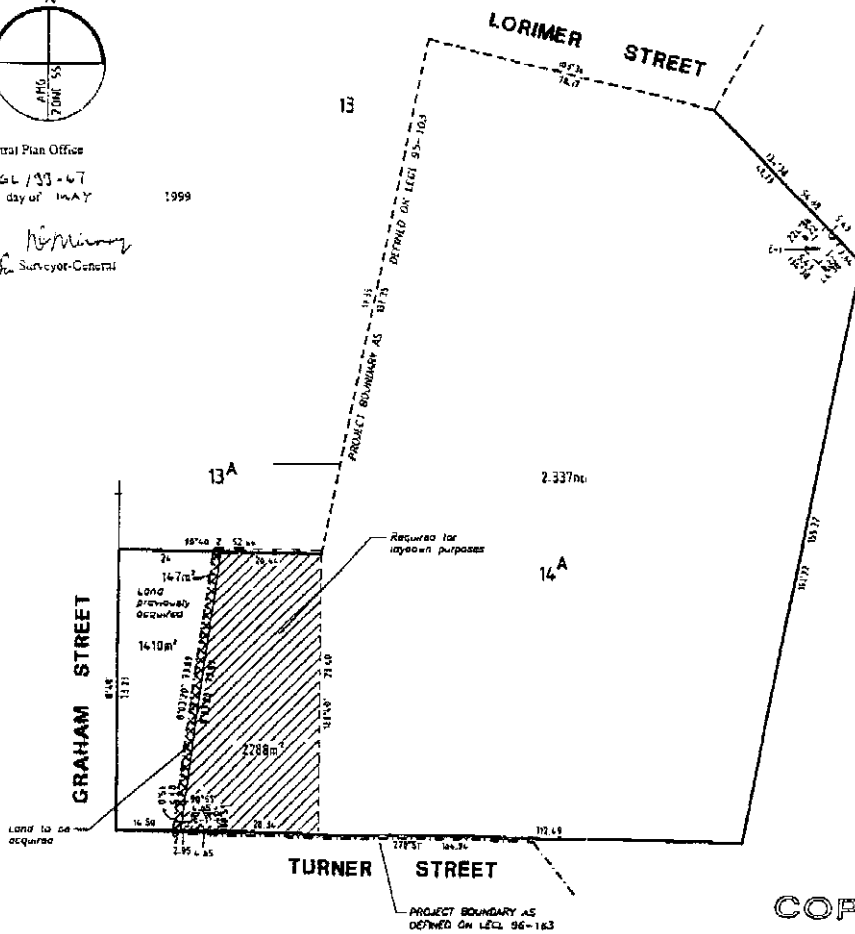
