Amendment C2

The Minister for Planning and Local Government has approved Amendment C2 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment includes the former Royal Park Psychiatric Hospital, Oak Street, Parkville within the Heritage Overlay and amends Heritage Overlay 422, covering the Alfred Hospital site, Punt Road, South Yarra, by deleting Building 16 and Ward 22. This seeks to facilitate the development of Alfred Medical Research and Education Precinct and to reflect the previous demolition of Ward 22.
