Road Safety (Vehicles) Regulations 1999

CLASS 3 NOTICE FOR GLIDER TRAILERS

Regulation 515 (2) of the Road Safety (Vehicles) Regulations 1999 provides that the Corporation may by notice published in the Government Gazette declare a category of vehicles to be class 3 vehicles.

Clause 40 of Schedule 3 to the Regulations provides that the dimension limits for a vehicle in a category of vehicles declared by the Corporation under regulation 515(2) are the relevant dimension limits for that vehicle set out in Division 2 of Part 4 of the Regulations except to the extent that the Corporation specifies otherwise in the declaration.

In accordance with those provisions, I, Geoff Kloot, delegate of the Roads Corporation, declare that combinations consisting of a motor vehicle and trailer built to transport a glider are Class 3 vehicles if the trailer has a rear overhang that exceeds the maximum overhang permitted by regulation 412(3) of the Regulations, namely:

- “(a) the length of the load carrying area, or body, ahead of the rear overhang lines; or
(b) 3.7 metres -
whichever is the lesser.”

This Notice is subject to the following conditions:

- (a) the rear overhang of the trailer must not exceed 5.0 metres; and
- (b) the trailer must exert a positive downward force on the towing vehicle's trailer coupling; and
- (c) the width of the load carrying-area, or body, of the trailer must not exceed 2 metres; and
- (d) the trailer must only be used to transport a glider, glider accessories associated with gliding, ballast to maintain a positive downward force on the towing vehicle's trailer coupling or for empty travel; and
- (e) the registered operator of the motor vehicle must ensure that the combination can be safely operated on its intended routes.

This Notice operates from the date of its publication in the Government Gazette until 30 June 2004.

Road Safety (Vehicles) Regulations 1999

CLASS 3 NOTICE FOR LOG TRUCKS

Regulation 516 of the Road Safety (Vehicles) Regulations 1999 provides that the Roads Corporation may, by notice published in the Government Gazette, exempt a category of class 3 vehicles from a mass or dimension limit set out in Schedule 3 to the Regulations.

Under that regulation, I, Geoff Kloot, delegate of the Roads Corporation, exempt a 3 axle truck connected to a 4 axle dog trailer, transporting logs, from the dimension limits prescribed in clause 11 of Schedule 3 to those Regulations to the extent that that clause requires compliance with the length of 19 metres prescribed by regulation 411 of those Regulations.

This Notice is subject to the following conditions:

- (a) that the combination consisting of the truck and dog trailer does not exceed 22.0 metres in length; and
- (b) that the registered operator of the truck ensures that the combination can be safely operated on its intended routes.

This Notice operates from the date of its publication in the Victoria Government Gazette until 30 June 2004.

SCHEME
Notice of Approval of Amendment
Amendment C1

The Minister for Planning and Local Government has approved Amendment C1 to the Mornington Peninsula Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment alters Clause 2 of Schedules 2, 4, 6 and 7 to the Design and Development Overlay by indicating that no permit is required to construct a building or construct or carry out works associated with a single dwelling, dwelling extensions, an outbuilding or a fence provided particular requirements are met. If the requirements can not be met then a permit can be applied to vary such requirements.

The Amendment alters Clause 2 of Schedules 2, 3, 4, and 5 to the Design and Development Overlay by indicating that a permit can be applied to vary the maximum building height stipulated for new development.

The Amendment also corrects a number of minor anomalies created when approving the new Mornington Peninsula Planning Scheme.
