Crown Land (Reserves) Act 1978

ORDER GIVING APPROVAL TO GRANT OF LEASE

Pursuant to sections 17D(1) and 17DA of the **Crown Land (Reserves) Act 1978** I, Marie Tehan, Minister for Conservation and Land Management, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease by Parks Victoria to Lord Somers Camp and Powerhouse over part of Albert Park described in the Schedule below for the purpose of sporting clubrooms, offices and facilities for the recreation, education and development of young people in Australia, together with commercial functions, reception centre, fund raising events and associated and related activities and, in accordance with section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that:-

- a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

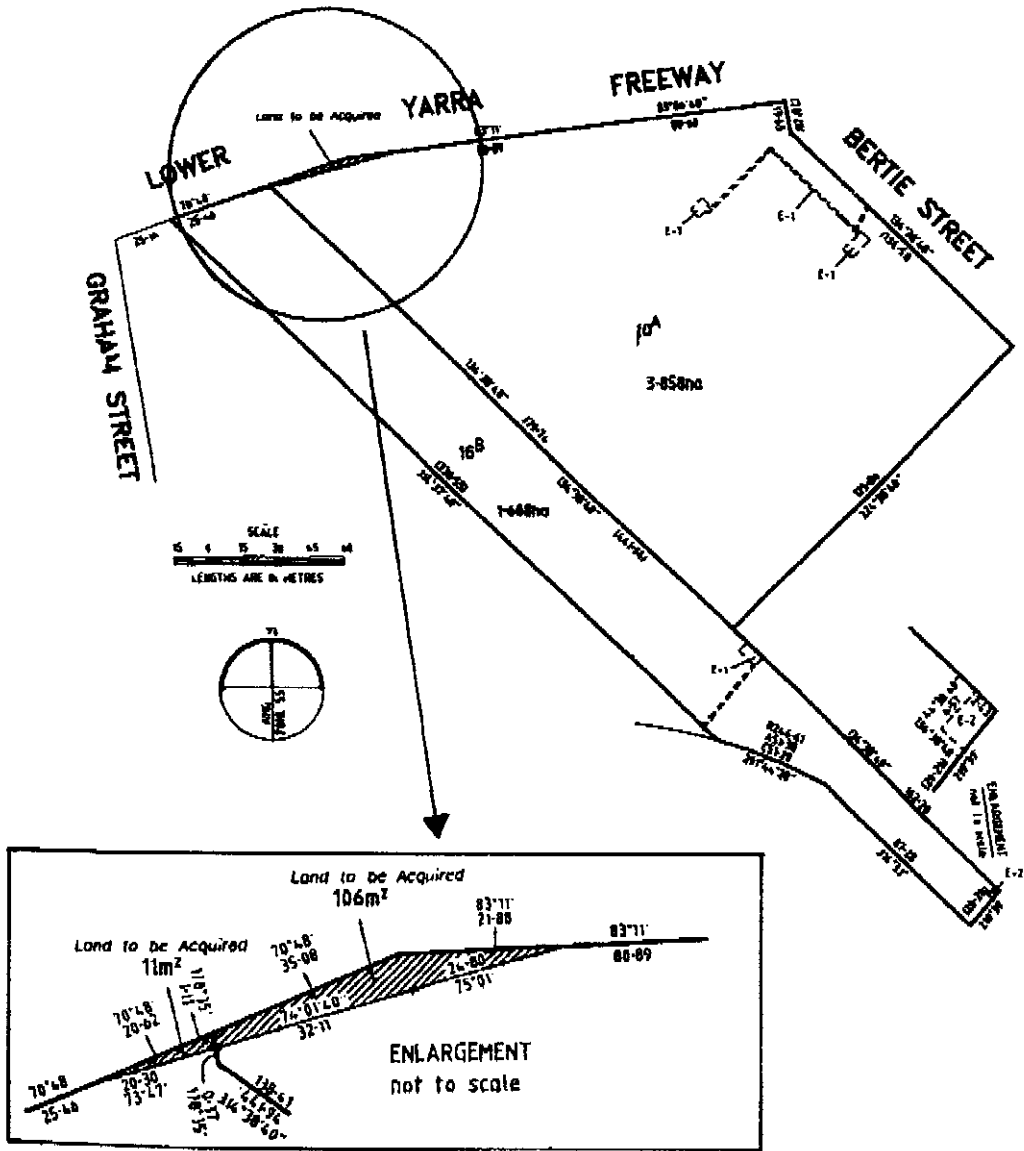

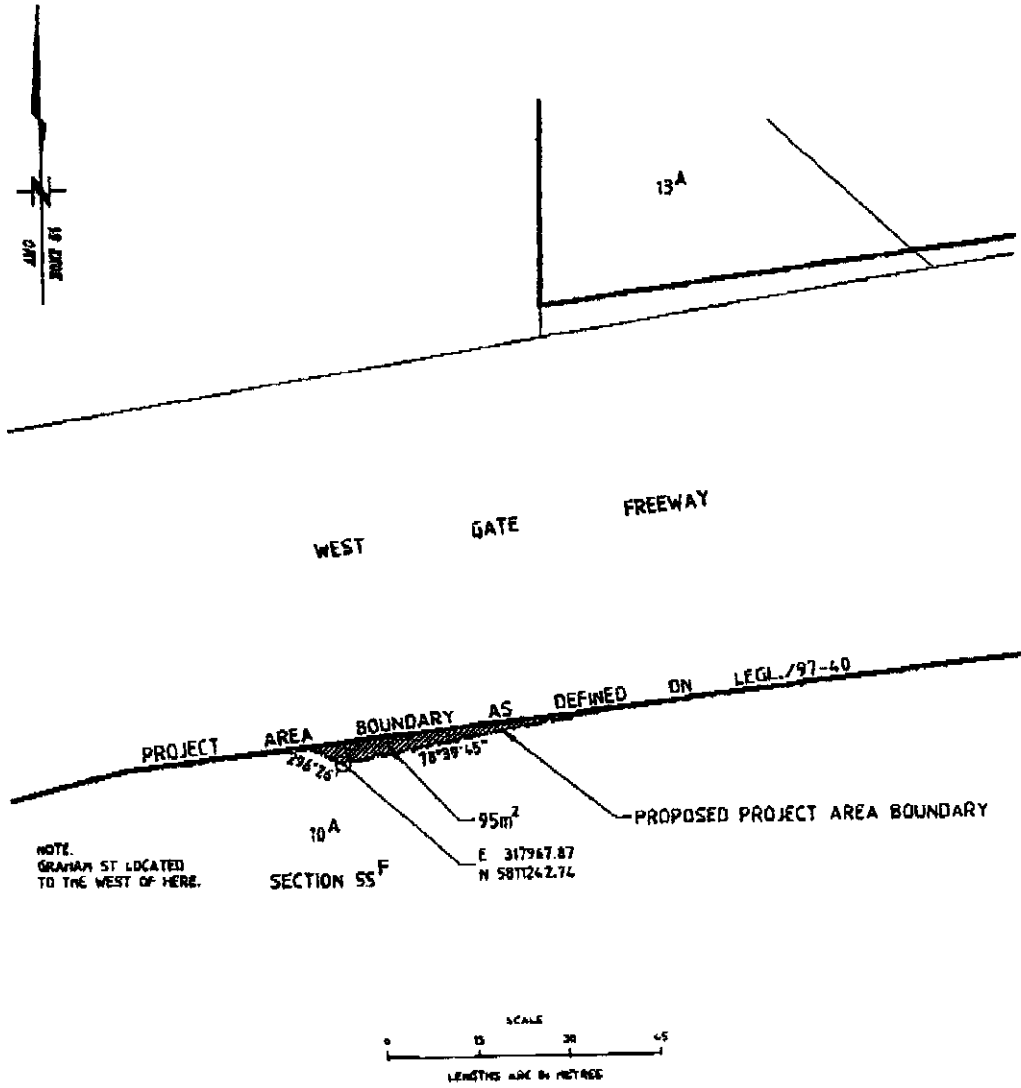

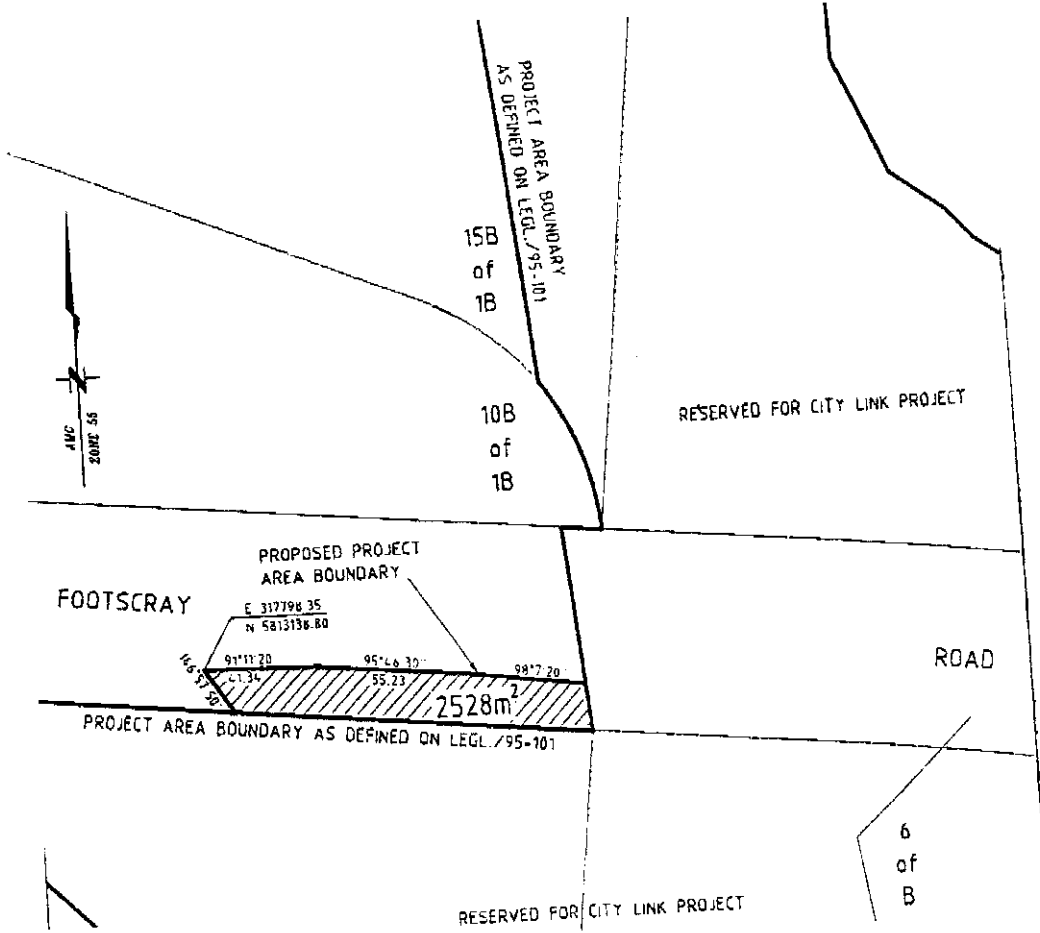
The land shown diagonally hatched on the following plan:



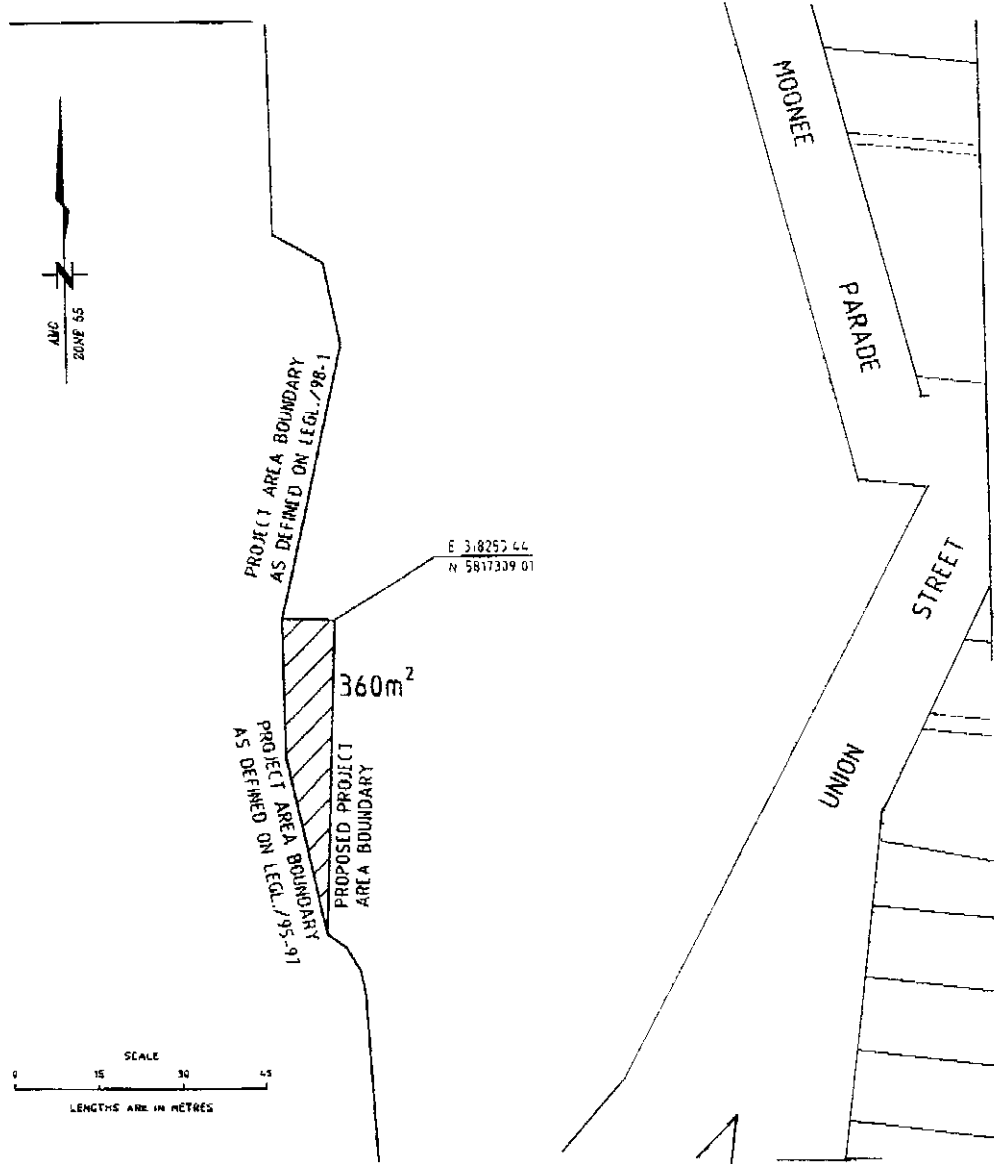
The land shown diagonally hatched on the following plan:



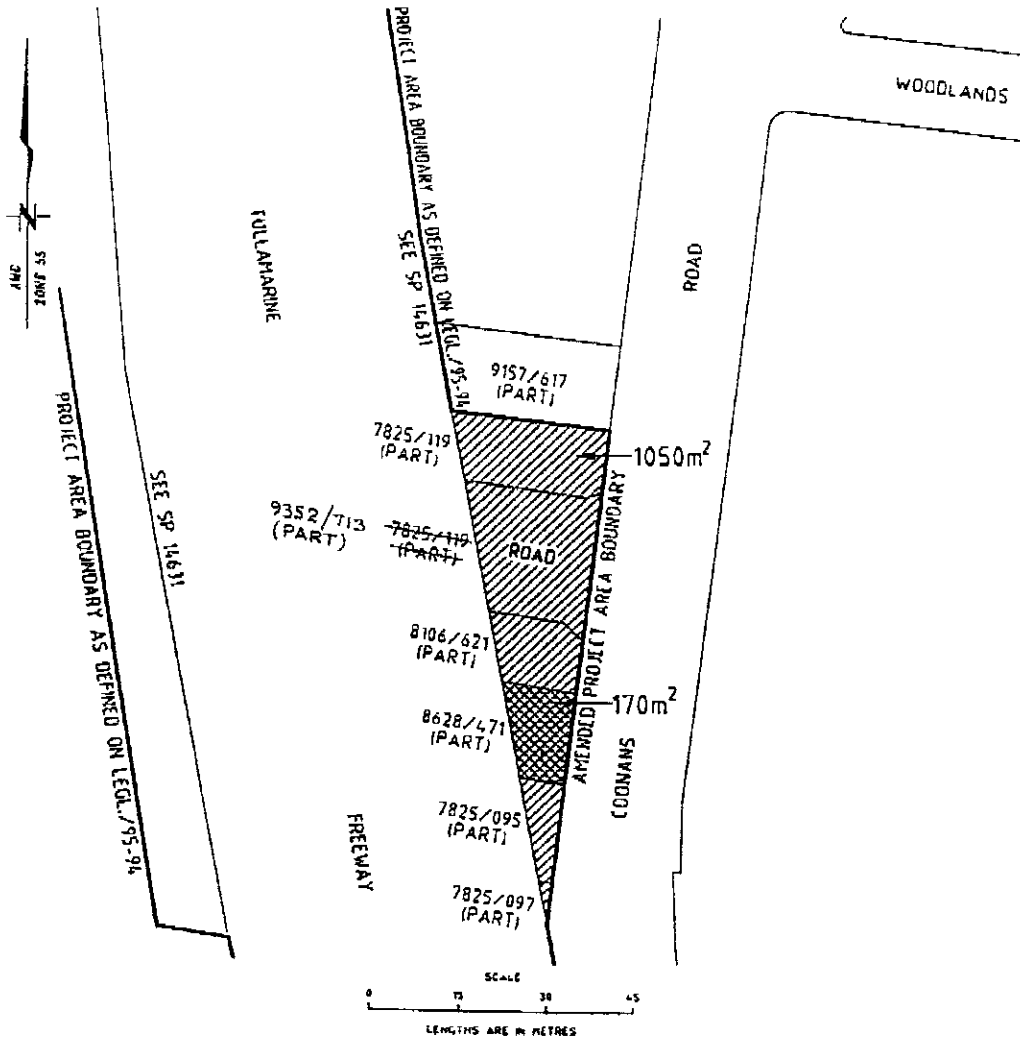

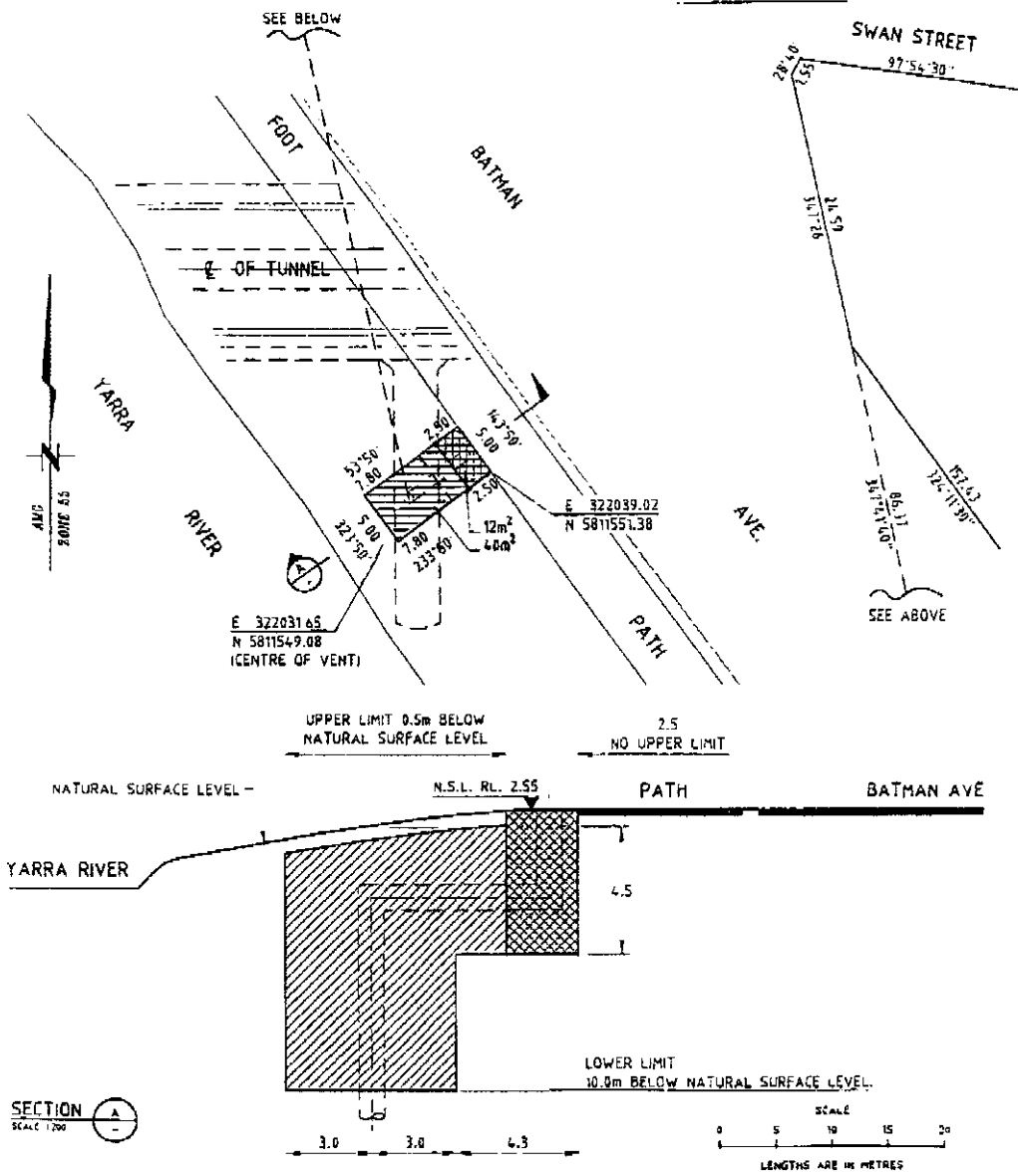

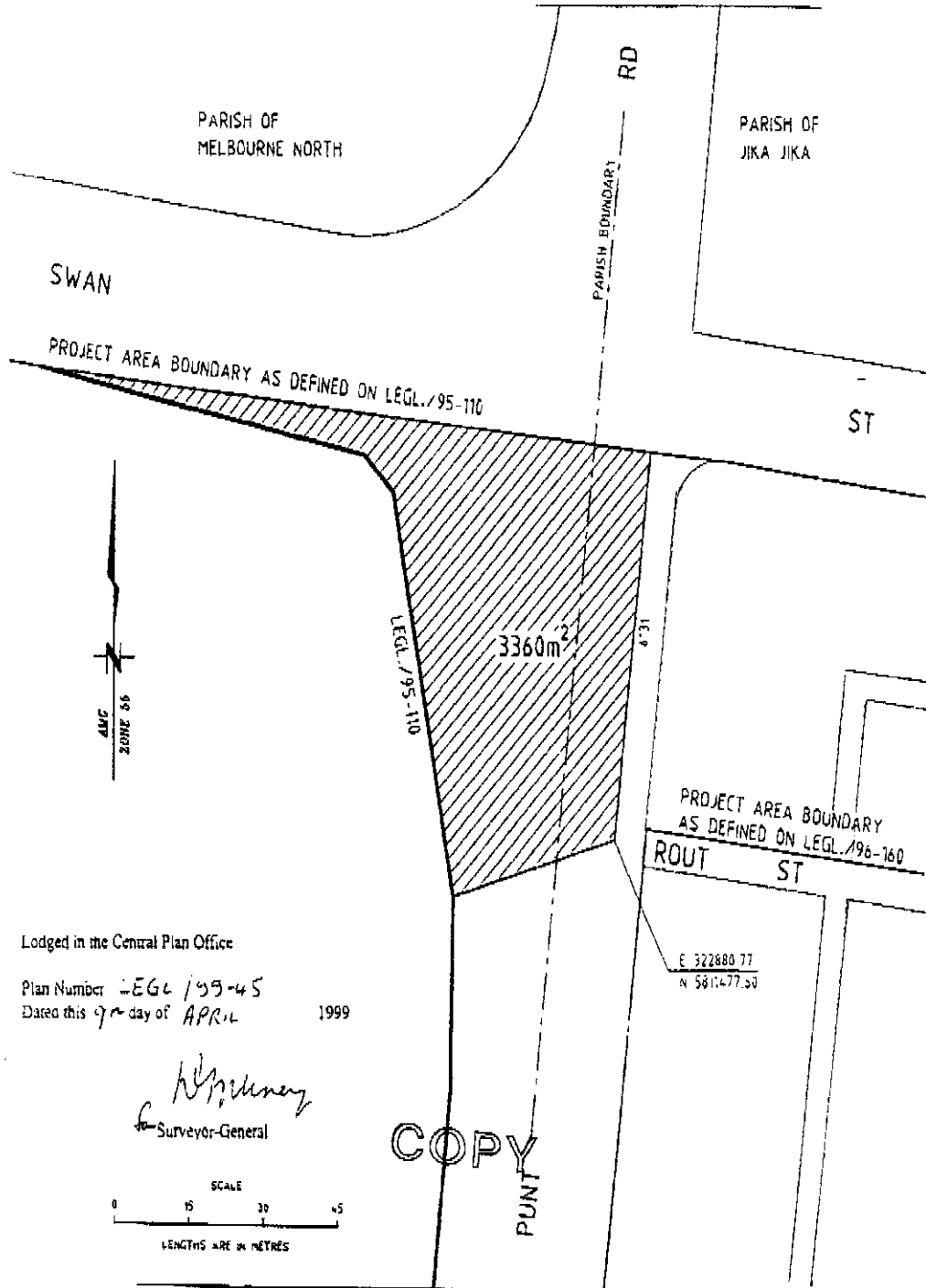
The land shown diagonally hatched and cross hatched on the following plan:
