NOTICE OF DECISION

Fundraising Appeals Regulations 1999

I, Jan Wade, Minister for Fair Trading, give notice under section 12 of the **Subordinate Legislation Act 1994** as follows:

A Regulatory Impact Statement (RIS) was released for public comment on 26 May 1999 in relation to the proposed Fundraising Appeals Regulations 1999. Four submissions were received in response to the RIS.

After considering the submissions, I have decided that the proposed regulations should be made without amendment.

ELECTRICITY SAFETY (ELECTRIC LINE CLEARANCE) REGULATIONS 1999

Notice of Regulatory Impact Statement

In accordance with the **Subordinate Legislation Act 1994**, notice is given that a Regulatory Impact Statement has been prepared in relation to the proposed Electricity Safety (Electric Line Clearance) Regulations 1999.

The proposed regulations will be made under sections 89, 151 and 157 of the **Electricity Safety Act 1998**.

The primary objective of the proposed regulations is to minimise the risk to public safety and property resulting from fire ignition caused by contact between electric lines and vegetation. The proposed regulations prescribe the Code of Practice for Electric Line Clearance. The Code of Practice provides for standards and practices to be adopted and observed in tree pruning or clearing in the vicinity of electric lines; management procedures to minimise danger of electric lines causing fire or electrocution; and other matters for or with respect to the maintenance of electric lines. The regulations prescribe the penalty provisions of the Code and provide for the preparation and

approval of management plans relating to compliance with the Code and for other matters authorised under the Act relating to electric line clearance.

The Regulatory Impact Statement examines the appropriate level of regulation so that community expectations for fire safety and the conservation of the environment are met. The Regulatory Impact Statement concludes that the proposed regulated scheme provides the most cost effective means of achieving the objectives and provides for safe standards of clearance between electric lines and vegetation.

The general purport of the Local Law is as follows:

(a) Clause 12 (d) of the Local Law provides for the Council to be able to fix the quorum for meetings of each of its delegated special committees after receiving a recommendation from each committee for that purpose.
