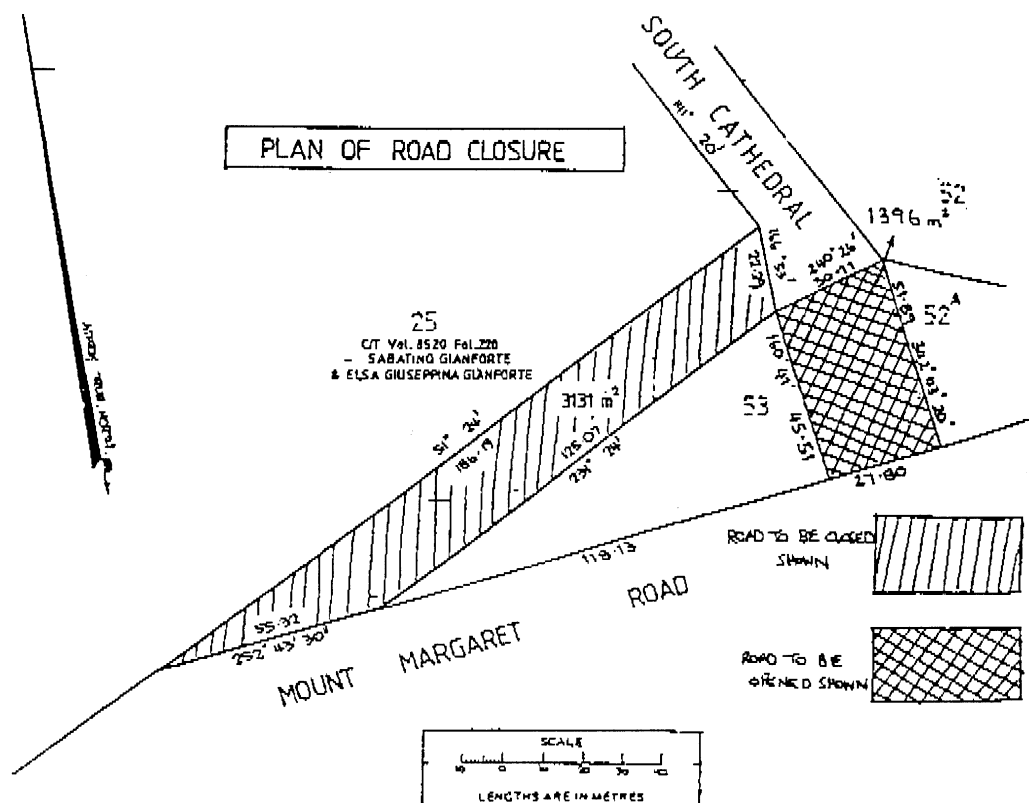

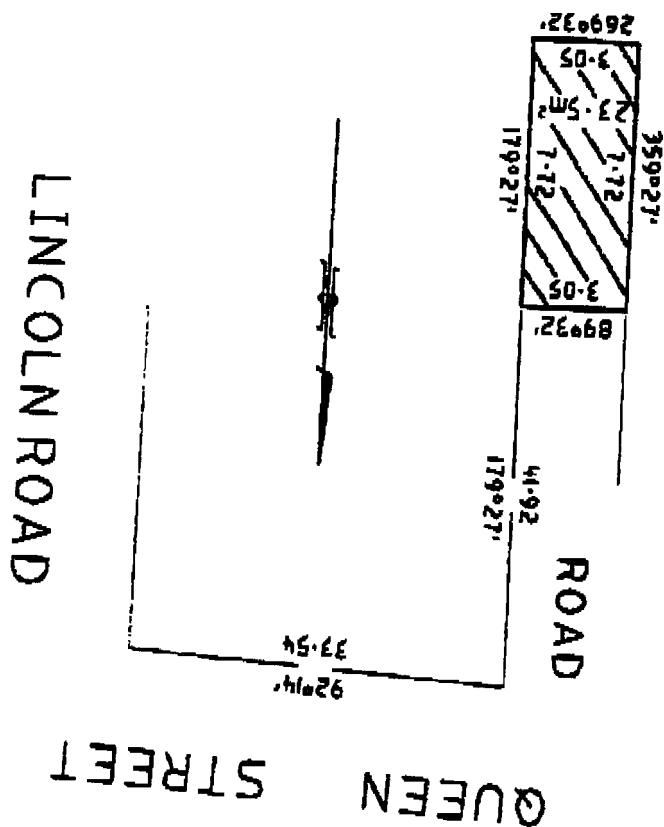

The Council wishes to give notice that, at its meeting on Wednesday 26th May 1999, it resolved to give notice of its intention to make a local law.

The purpose of the local law is to provide for the:

- (a) peace, order and good government of the municipality;
- (b) a safe and healthy environment so that the community within the municipality can enjoy a quality of life that meets its expectations;
- (c) safe and fair use of public spaces;
- (d) protection and enhancement of the amenity and environment of the municipality;
- (e) fair and reasonable use and enjoyment of private land; and
- (f) uniform and fair administration of the local law.

The local law is divided into parts. The general purport of each part is summarised below.

Part 1 General preliminary information including:

- the authority under which the local law is made;
- the objectives of the local law;
- the commencement date of the local law;

- revocation of Community Local Law No. 1 upon the commencement of this local law;
- the application of the local law; and
- definition of terms and words contained in the local law.

Part 2 Animals including:

- restrictions on the number and type of animals which can be kept on land of 1 hectare or less. The proposed restrictions relate to dogs, cats, chickens, ducks, geese, pheasants, turkeys, pigeons, rabbits, guinea pigs, ferrets, sheep, goats, horses, cattle, bees, pigs and roosters;
- a requirement that a person in charge of a dog will not allow any part of the dog's excrement to remain on the road or in any public place and that a facility for the effective removal of excrement be carried by a person in charge of a dog in a public place;
- a requirement that fencing on land where livestock is kept be adequate to ensure that the livestock do not escape; and
- a requirement that a permit be obtained prior to droving any livestock on a road.

Part 3 Environment including:

- a requirement that the conditions of service for the Council's waste collection and recycling service be complied with by users of the service;
- a requirement that land be maintained in a condition that is not unsightly or detrimental to the general amenity of the neighbourhood;
- restrictions on the use of caravans for the purposes of sleeping on private land.
- restrictions on lighting open fires in all residential (including low density residential), business or industrial areas except for the purposes of preparing food; and
- restrictions on the placement of fill or excavation of material from land when it is not approved by a building permit issued under the **Building Act 1993**.

Part 4 Public Places – General including:

- restrict behaviour in a public place so that such behaviour does not interfere with the reasonable use and enjoyment of that public place or endanger health, life or property;
- a requirement that any sign erected by the Council in a public place must be complied with;
- restrictions on the carrying of open containers of alcohol and the consumption of alcohol on roads and in public places;
- a requirement that the owner or occupier of land must ensure that no vehicle crossings or footpaths are damaged in connection with any construction works being undertaken on the land; and
- a restriction on cutting down or removing live or dead standing trees from the road.

Part 5 Public Places – Permit Required including:

- restrictions on the use of amplified speech, music or any other sound and spruiking or calling out from premises in the business or industrial zones for the purposes of attracting trade;
- restrictions on busking, public speaking and the use of amplification equipment in a public place;
- restrictions on the selling or offering of goods for sale from a temporary location, from place to place or from a vehicle;
- restrictions on the placement of advertising signs or goods for display or sale or any structure for the purpose of selling goods or services on a road;
- restrictions on the sale of goods or services from private land or a public place adjacent to a road to any person on that road or in that public place;
- restrictions on the placement of tables and chairs and/or associated equipment for the purposes of allowing food or drink to be consumed by customers;

- restrictions on the collection or soliciting of any money or gifts from a public place; and
- restrictions on the distribution of handbills or other printed material or advertising material in a public place.

Part 6 Administration including:

- provisions authorising authorised officers to give reasonable directions to comply with the provisions of the local law and to act in urgent circumstances;
- provisions relating to permit applications; and
- provisions providing for the impounding of any item that encroaches or obstructs the free use of a public place.

Part 7 Enforcement including:

- offences;
- infringement notices;
- penalties; and
- appeal processes.

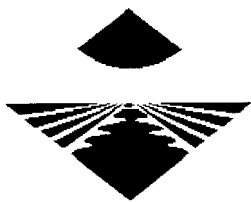

The exemption is subject to the following conditions:-

1. The exemption does not apply to boys who wish to enrol at the College at year 7 level and for whom the college is the closest State Secondary School to their permanent residential address.
2. This exemption does not apply to any boy who wishes to enrol at the College at year 7 level and whose older brother or sister already attends the College.
3. This exemption does not affect any power to refuse enrolment at the College conferred on any person by or under the **Education Act 1958**.
4. If a direction or guideline is issued under section 14A of the **Education Act 1958**, or the Educational Services Agreement is varied to include a provision, which requires the Council of the College to follow a policy different from the policy expressed in this exemption, the Council must advise the Tribunal of that requirement within 7 days after becoming aware of it.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 2 June 2002.

NURSES BOARD OF VICTORIA

On 3 May 1999 a panel appointed by the Nurses Board of Victoria held a formal hearing into the professional conduct of Melissa Nicole Domburg of 66 Edgar Street, Portland, Victoria, identification number 1522296, date of birth 23 February 1970, registered in division 2. On 27 May 1999, the panel found that Miss Domburg had engaged in unprofessional conduct of a serious nature and determined that:-

- 1- Pursuant to s. 48(2)(g) **Nurses Act 1993**, the nurse's registration be suspended for a three month period with effect from 7 June 1999 until 6 September 1999.
- 2- After 6 September 1999, the nurse may apply in writing to remove the suspension of her registration, but only if the following conditions are and have been observed.
 - (a) From 7 June 1999, until the suspension is removed, the nurse must not work in any capacity, for:-
 - (i) a registered funded agency, or
 - (ii) a health service establishment,
 as those terms are defined in s.3 **Health Services Act 1988** of Victoria, or as or for a nurse's agent, as defined in s.3 **Nurses Act 1993**.
 - (b) The nurse must provide written evidence satisfactory to the Board that she has commenced the counselling directed under paragraph 3 of this determination.
- 3- Pursuant to s. 48(2)(a) **Nurses Act 1993** the nurse undergo counselling and consultations for at least 12 months with a psychiatrist approved in writing by the Board, such consultations to commence by 5 July 1999 and to occur at least once a month, or more frequently, if the psychiatrist so recommends. Within one month of the anniversary of the first consultation, the nurse must provide the Board with a written report from the psychiatrist of the counselling and consultations, which report must be satisfactory to the Board.
- 4- Pursuant to s. 48(2)(d) **Nurses Act 1993**, the nurse enroll in, and by 31 December 2000 provide the Board with written evidence of satisfactory completion of a course module in professional ethics, the course module and institution to be approved in writing by the Board before the course commences.

CODE OF PRACTICE FOR THE CARE AND USE OF ANIMALS FOR SCIENTIFIC PROCEDURES (1998 Revision)

Purpose of Code

The purpose of the Code of Practice for the Care and Use of Animals for Scientific Procedures (1998 Revision) (the Code) is to ensure the humane care of animals used in scientific procedures

Authority

The Code is made under section 7 of the **Prevention of Cruelty to Animals Act 1986** (the Act).

Status of Code

It is an offence under section 32 of the Act for a person to carry out a scientific procedure except in accordance with the Code.

It is a defence to any proceedings under the Act that the act complained of was carried out in accordance with the Code.

Definition of Terms Used in the Code

The terms "animal", "scientific procedure", "scientific establishment" and "breeding establishment" have the same definitions as contained in the Act.

A reference to the National Code of Practice is a reference to the "Australian Code of Practice for the Care and Use of Animals for

Scientific Purposes”, 6th Edition 1997 prepared by a joint working party of the National Health and Medical Research Council, CSIRO, Agriculture Resource Management Council of Australia and New Zealand, Australian Research Council, Australian Vice-Chancellors Committee and representatives of the State and territory Governments of Australia and welfare organisations (RSPCA and ANZFAS) and published by the Australian Government Publishing Service, Canberra 1997.

General

The-

- (a) care or use of animals on which or in connection with which scientific procedures are carried out; and
 - (b) keeping, care, treatment, handling or use of animals at or on the premises, facilities, equipment or conditions at any scientific establishment or breeding establishment-
- must be in compliance with the National Code of Practice.

It may be noted that the National Code of Practice covers fish. Fish do not fall within the scope of this Code.

Scientific Establishments

Scientific establishments at which animals are used for scientific procedures must observe the following:

- (a) Each establishment must have an Animal Ethics Committee (AEC)
- (b) All experiments must be properly designed, and detailed proposals of the experimentation should be approved by the AEC before any work is commenced.
- (c) Proper care should be given to the selection of the species of animals to be used, and all animals to be used in scientific procedures should be healthy and properly housed and maintained.
- (d) All staff involved in the care and maintenance of animals, or in carrying out scientific procedures of animals, should be properly supervised.

Breeding Establishments

Breeding establishments should ensure that-

- (a) all animals at the premises are healthy and properly housed and maintained; and

- (b) all staff involved in either the care or maintenance of animals are properly trained or supervised.
