





BAW BAW SHIRE COUNCIL New Community Local Law

The Council wishes to give notice that, at its meeting on Wednesday 23 June 1999, it resolved to make a new local law to be known as the Baw Baw Shire Council Community Local Law 1999. It is to come into effect from 1 July 1999.

The purpose of the local law is to provide for the:

- (a) peace, order and good government of the municipality;
- (b) a safe and healthy environment so that the community within the municipality can enjoy a quality of life that meets its expectations;
- (c) safe and fair use of public spaces;
- (d) protection and enhancement of the amenity and environment of the municipality;
- (e) fair and reasonable use and enjoyment of private land; and
- (f) uniform and fair administration of the local law.

The local law is divided in to parts. The general purport of each part is summarised below.

Part 1 General preliminary information including:

- the authority under which the local law is made;
- the objectives of the local law;
- the commencement date of the local law.
- revocation of Community Local Law No. 1 upon the commencement of this local law;
- the application of the local law; and
- definition of terms and words contained in the local law.

Part 2 Animals including:

 restrictions on the number and tupe of animals which can be kept on land of 1 hectare or less. The proposed restrictions relate to dogs, cats, hens, ducks, geese, pheasants, turkeys, pigeons, rabbits, guinea pigs, ferrets, sheep, goats, horses, cattle, bees, pigs and roosters;

- a requirement that a person in charge of a dog will not allow any part of the dog's excrement to remain on the road or in any public place and that a facility for the effective removal of excrement be carried by a person in charge of a dog in a public place;
- a requirement that fencing on land where livestock is kept be adequate to ensure that the livestock do not escape; and
- a requirement that a permit be obtained prior to droving any livestock on a road.

Part 3 Environment including:

- a requirement that the conditions of service for the Council's waste collection and recycling service be complied with by users of the service:
- a requirement that land be maintained in a condition that is not unsightly or detrimental to the general amenity of the neighbourhood;
- restrictions on the use of caravans for the purposes of sleeping on private land;
- restrictions on lighting open fires in all residential (including low density residential), business or industrial areas except for the purposes of preparing food; and
- restrictions on the placement of fill or excavation of material from land when it is not approved by a building permit issued under the Building Act 1993.

Part 4 Public Places – General including:

- restrictions on behaviour in a public place so that such behaviour does not interfere with the reasonable use and enjoyment of that public place or endanger health, life or property;
- a requirement that any sign erected by the Council in a public place must be complied with;
- restrictions on the carrying of open containers of alcohol and the consumption of alcohol on roads and in public places;

- a requirement that the owner or occupier of land must ensure that no vehicle crossings or footpaths are damaged in connection with any construction works being undertaken on the land; and
- a restriction on cutting down or removing live or dead standing trees from the road.

Part 5 Public Places - Permit Required including:

- restrictions on the use of amplified speech, music or any other sound and spruiking or calling out from premises in the business or industrial zones for the purposes of attracting trade:
- restrictions on busking, public speaking and the use of amplification equipment in a public place;
- restrictions on the selling or offering of goods for sale from a temporary location, from place to place or from a vehicle;
- restrictions on the placement of advertising signs or goods for display or sale or any structure for the purpose of selling goods or services on a road;
- restrictions on the sale of goods or services from private land or a public place adjacent to a road to any person on that road or in that public place;
- restrictions on the placement of tables and chairs and/or associated equipment for the purposes of allowing food or drink to be consumed by customers;
- restrictions on the collection or soliciting of any money or gifts from a public place; and
- restrictions on the distribution of handbills or other printed material or advertising material in a public place.

Part 6 Administration including:

 provisions authorising authorised officers to give reasonable directions to comply with the provisions of the local law and to act in urgent circumstances;

- provisions relating to permit applications; and
- provisions providing for the impounding of any item that encroaches or obstructs the free use of a public place.

Part 7 Enforcement including:

- offences;
- infringement notices;
- penalties; and
- appeal processes.

Domestic (Feral and Nuisance) Animals Act 1994

Section 26(2)

Order of Hobsons Bay City Council

1. Dogs must be on leashes

The owner of any dog must keep the dog on a chain, cord or leash not exceeding 1.5 metres in length when the dog is in any reserve not designated under this Order or any public place in the municipality.

2. Owner's Obligations

A dog may be exercised off a chain, cord or leash in a Designated Reserve if the owner:

- carries a chain, cord or leash not exceeding 1.5 metres in length, sufficient to bring the dog under effective control if the dog behaves in a manner which threatens any person or animal;
- remains in effective voice or hand control of the dog so as to be able to promptly place the dog on a chain, cord or leash not exceeding 1.5 metres in length, if that becomes necessary; and

- does not allow the dog to worry or threaten any person or animal.
- **3.** If a dog is off a chain, cord or leash, it must be brought under effective control by means of a chain, cord or leash not exceeding 1.5 metres in length if the dog is, or is likely to be, within 20 metres of:
- the principal location of an organised sporting event;
- an occupied children's play equipment area;
- the principal location of an organised public meeting; or
- an occupied permanent barbecue or picnic area.

4. Meaning of Words

In this Order:

- "owner" has the same meaning as the Domestic (Feral and Nuisance) Animals Act 1994; and
- "Designated Reserve" means any of the following reserves, or part of the following reserves:
 - Cyril Curtain Reserve bounded by Cole & Twyford Streets, Williamstown;
 - 2. Clement Reserve bounded by Ross Road, Mills Street and Gilligan Road, Altona East;
 - 3. Hosken Reserve, bounded by Kororoit Creek Road, Grieve Parade and Blackshaws Road, Altona North;
 - 4. Doug Grant Reserve, bounded by Queen Street, Apex Park and the Melbourne Water Drainage Channel, Altona;
 - AB Shaw Reserve, bounded by Victoria Street, Hall Avenue and the Railway Line, Altona Meadows;
 - 6. Burns Reserve, bounded by the Altona Coastal Park, Altona Road and the Altona Workers Club, Altona;
 - 7. Pipeline Reserve, bounded by Shane Avenue and Point Cook Road, Laverton;
 - 8. Bladin Street Park, opposite McCormack Park south side of the creek to the cyclone wire fence;
 - 9. Gloucester Reserve, The Esplanade, Williamstown;
 - 10. Riverside Park, Newport;

- 11. The Warmies (the spit area), narrow land adjoining the eastern side of the Warmies, Newport;
- 12. Newport Lakes Arboretum and north west tip area, Margaret Street, Newport;
- 13. Greenwich Reserve, (the Oceanariam site until developed), The Strand, Newport;
- 14. Newport Park (area of land running east west at the north side of the Athletics Track and north south adjacent to Douglas Parade and the Athletics track to a point at the southern end located at the drainage outfall in line with the main strait of the Athletics track).

"Designated Reserves with Time Restrictions" means the following reserves are only off-leash areas at the times indicated, all other times the area remains an on leash area.

- N.B. Dogs permitted off leash before 9.00 a.m. and after 9.00 p.m.
 - Edwards Reserve, bounded by Truman, Brunel and Greene Streets, Spotswood;
 N.B. Dogs permitted off leash before 9.00 a.m. and after 9.00 p.m.

5. Dogs on Beaches

Dogs will be restricted from the following beaches, seven days a week from 10.00 a.m. to 9.30 p.m. from the 1 November to 30 April each year. All other times dogs must be on a leash. The beaches are:

- Williamstown Beach, between the Life Saving Club and Sirens Restaurant;
- Altona Beach, between Romawi and Mount Streets.

Electricity Industry Act 1993

EXEMPTION ORDER UNDER S160 -METROPOLITAN TRAM AND TRAIN NETWORK

Order in Council

The Governor in Council acting under section 160 of the **Electricity Industry Act 1993** (the Act) makes the following Order:

1. Exemption

- a) Public Transport Corporation (established under the **Transport Act 1983**) and each of Met Train 1, Met Train 2, Met Tram 1, Met Tram 2, V/Line Passenger Corporation and Victorian Rail Track (each established under the **Rail Corporations Act 1996**) are exempt from the requirement to obtain a licence in respect of:
 - i/ the transmission, distribution, supply or sale of electricity to each other in connection with the provision of rail services; and

- ii/ the transmission, distribution, supply or sale of electricity for traction power to any person in connection with the provision of access to train or tram infrastructure operated or controlled by the exempt entities; and
- b) Met Train 1 is exempt from the requirement to obtain a licence in respect of the transmission, distribution, supply or sale of electricity to the occupiers or users of Newport Workshops, Champion Road, Newport; and
- c) Met Train 2 is exempt from the requirement to obtain a licence in respect of the transmission, distribution, supply or sale of electricity to the occupiers or users of the Preston Workshops, 211-243 Plenty Road, Preston; and
- d) Victorian Rail Track is exempt from the requirement to obtain a licence in respect of the transmission, distribution, supply or sale of electricity to the occupiers or users of West Tower, Dudley Street, West Melbourne.

2. Conditions

The exemption contained in this Order commences on 1 July 1999 and is subject to the following conditions:

- a) Public Transport Corporation and each of Met Train 1, Met Train 2, Met Tram 1, Met Tram 2, V/Line Passenger Corporation and Victorian Rail Track must:
 - i/ transmit, distribute, supply or sell electricity on a not for profit basis only;
 - ii/ observe all applicable industry regulatory requirements, including all applicable provisions of the Distribution Code and the Tariff Order;
 - iii/ not take any action which prevents any person from purchasing electricity from a retailer of its choice;
 - iv/ not take any action which prevents a retailer from selling electricity directly to any person; and
 - v/ provide to the Minister or Office of the Regulator-General any information it may require for the reasonable administration of this Order.
- b) the exemption set out in Clause 1(b) to (d)
 of this Order ceases to apply in respect of a
 Site where:

- i/ there is a material change in the use of the Site to the extent that it is no longer predominantly used for the provision of rail related maintenance services; or
- ii/ the Site is no longer owned by Public Transport Corporation or Victorian Rail Track.

3. Definitions

In this Order the following terms have the following meaning unless the contrary intention

Distribution Code means any code of that name from time to time approved by the Office of the Regulator General;

Site means one of the sites set out in Clause 1(b) to (d) of this Order; and

Tariff Order means an Order made under section 158A of the Act.
