Health Services Act 1988

AN ORDER PURSUANT TO SECTIONS 11(1), 11(1A), 71(1)(a)(iii) 71(1)(c)(iii) AND 83(1)(b) OF THE **HEALTH SERVICES ACT 1988** (THE ACT) IN RELATION TO THE EXEMPTION OF DAY PROCEDURE CENTRES AND PRIVATE HOSPITALS FROM THE OPERATION OF SECTIONS 71(1)(a)(iii), 71(1)(c)(iii) AND 83(1)(b) OF THE ACT

The ${\bf GOVERNOR}$ IN ${\bf COUNCIL}$ by this Order -

- (a) **Declares**, under section 11(1) and 11(1A) of the Act that Proposed Day Procedure Centres and Day Procedure Centres registered under the Act, which is applying for approval in principle pursuant to section 70 of the Act or for variation or transfer of a certificate pursuant to section 74 of the Act are exempt from the criteria contained in section 71(1)(a)(iii);
- (b) **Declares**, under section 11(1) and 11(1A) of the Act that Day Procedure Centres registered under the Act, which are applying for approval in principle pursuant to section 70 of the Act or for variation or transfer of a certificate pursuant to section 74 of the Act, are exempt from the criteria contained in section 71(1)(c)(iii);
- (c) **Declares**, under section 11(1) and 11(1A) of the Act that Proposed Day Procedure Centres, which are applying for registration pursuant to section 82 of the Act, are exempt from the criteria contained in section 83(1)(b);
- (d) **Declares**, under section 11(1) and 11(1A) of the Act that Proposed Private Hospitals and Private Hospitals registered under the Act, which are applying for approval in principle pursuant to section 70 of the Act or for variation or transfer of a certificate pursuant to section 74 of the Act in respect of beds to be used for the following prescribed health services
 - medical
 - surgical

- in cirumstances where persons to whom such treatment is provided are reasonably expected to be admitted and discharged on the same date, are exempt from the criteria contained in section 71(1)(a)(iii);
- (e) **Declares**, under section 11(1) and 11(1A) of the Act that Private Hospitals registered under the Act, which are applying for approval in principle pursuant to section 70 of the Act or for variation or transfer of a certificate pursuant to section 74 of the Act, in respect of beds to be used for the following prescribed health services -
 - medical
 - surgical
 - in cirumstances where persons to whom such treatment is provided are reasonably expected to be admitted and discharged on the same date, are exempt from the criteria contained in section 71(1)(c)(iii);
- (f) **Declares**, under section 11(1) and 11(1A) of the Act that Proposed Private Hospitals, which are applying for registration pursuant to section 82 of the Act in respect of beds to be used for the following prescribed health services -
 - medical
 - surgical
 - in cirumstances where persons to whom such treatment is provided are reasonably expected to be admitted and discharged on the same date, are exempt from the criteria contained in section 83(1)(b);
- (g) **Declares**, under section 11(1) and 11(1A) of the Act that Day Procedure Centres registered under the Act, which are applying for registration pursuant to section 92 of the Act, are exempt from the criteria contained in sections 71(1)(a)(iii), 71(1)(c)(iii) and 83(1(b); and
- (h) **Declares**, under section 11(1) and 11(1A) of the Act that Private Hospitals registered under the Act, which are applying for registration pursuant to section 92 of the Act, in respect of beds to be used for the following prescribed health services -

medical

- surgical
- in cirumstances where persons to whom such treatment is provided are reasonably expected to be admitted and discharged on the same date, are exempt from the criteria contained in section 71(1)(a)(iii), 71(1)(c)(iii) and 83(1)(b);
- for a period of 12 months.

This Order is to be made to take effect from 22 July 1999.
