#### Melbourne City Link Act 1995 TERMINATION OF LICENCES ISSUED PURSUANT TO SECTION 56

#### 1. Purpose

The purpose of this Instrument is to terminate the licences issued pursuant to section 56 of the **Melbourne City Link Act 1995** ("the Act") in relation to the Western Link Section of the City Link.

#### 2. Authority for Instrument

This Instrument is made under section 56(6)(a) of the Act and in accordance with the terms of the Agreement, in particular—

- a. the State has received a notice under clause 9.3 (b) of the Agreement in respect of the relevant land and the State is required under clause 4.13 (a) of the Agreement (as amended by the Eighth Amending Deed) to terminate the licences, and
- b. the Agent has, for the purposes of clause 10 of the Master Security Deed, by a Notice dated 6 August 1999 and confirmed by a Notice dated 12 August 1999, provided written consent to the termination of the licences as to the relevant land.

#### **3.** Termination of Licences

The Authority terminates all licences issued under section 56(1) of the Act in respect of the land and strata of land the subject of the Order in Council dated 27 July, 1999 and published in Government Gazette on 29 July 1999 (Gazette No. G 30, pages 1790 to 1812) ("Revocation Order") to the extent that those licences relate to that land and those strata, with effect on and from 13 August, 1999.

Without limiting the generality of the foregoing, the Authority revokes the licences issued under section 56(1) of the Act that are specified in Column 2 of the Attachment insofar as those licences relate to the land and strata of land described in Column 3 of the Attachment, with effect on and from 13 August, 1999.

By operation of section 59(3) of the Act and the Revocation Order, the reservations of that land for the purposes of the Project under the **Crown Land (Reserves) Act 1978** are also revoked as from the termination of these licences (see cross-references to the Revocation Order detailed in Column 4 of the Attachment).

#### 4. Definitions

Any word, expression, reference or term used in this Instrument which is defined or given a special meaning in the Agreement, the Act or the licences, shall, unless the context otherwise requires, have the same meaning in this Instrument.
