Melbourne City Link Act 1995

NOTICE OF DECLARATION OF LINK ROAD—WESTERN LINK

I, Robert Maclellan, Minister for Planning and Local Government and Minister administering the **Melbourne City Link Act 1995** ("the Act"), in accordance with section 61(3) of the Act, give notice that I have today made a declaration under section 61(1) of the Act. A copy of that declaration is printed with this notice.

By operation of the definition of "Link road" in section 3 of the Act, the land the subject of the declaration is part of the Link road.

On the publication of this notice in the Government Gazette, by operation of section 61(4) of the Act, the road specified in the declaration is deemed to be—

- (a) a declared road within the meaning of the **Transport Act 1983**; and
- (b) a road open to and for use by the public for passage with vehicles; and
- (c) a highway within the meaning of the Road Safety Act 1986.

The declaration applies to the land comprised in the Crown Allotments listed in Schedule 1 to the declaration, as shown on the plans listed in that Schedule and lodged at the Central Plan Office of the Department of Natural Resources and Environment. Copies of these plans are available from the Land and Survey Information Centre, Department of Natural Resources and Environment, Ground Floor, 456 Lonsdale Street, Melbourne, 3000.

Overview plans and diagrams of the Western Link are also published with this notice for information purposes only.

DECLARATION OF LINK ROAD-WESTERN LINK

I, Robert Maclellan, Minister for Planning and Local Government and Minister administering the **Melbourne City Link Act 1995** ("the Act"), acting under section 61(1) of the Act—

- (a) declare to be a road the land and strata of land comprised in the Crown Allotments listed in Schedule 1, being land to which section 61(1)(b) of the Act applies; and
- (b) state that—

- (i) the parts of the road shown hatched and cross-hatched on plans LEGL./99-122 to LEGL./99-132 in Schedule 2 (the originals of which are lodged in the Central Plan Office) are to be treated as State Highways, and
- (ii) the remainder of the road the subject of this instrument is to be treated as a freeway.




PARISH OF DOUTTA GALLA





