CASINO RULES NOTICE NO. 13 OF 1999

Rules of the Game—Blackjack

By this notice, the Victorian Casino and Gaming Authority amends the Rules in respect of the game "Blackjack" (approved by notice published in the Victoria Government Gazette on 24 April 1997 (S44) and amended by notice dated 30 April 1998 (G17) and Casino Rules Notice No. 1 of 1999 published on 18 March 1999 (S39)) as set out in the Schedule.

This notice operates with effect from 4.00am on 1 September 1999.

Schedule

1. Insertion of rules for "Madness 21"

Insert a new rule 23 as follows:

'23 Madness 21

- 23.1 Where the version of Blackjack in play is "Madness 21" the approved rules of Blackjack shall apply, except where the rules are inconsistent with the rules of "Madness 21", in which case the rules of "Madness 21" shall prevail.
- 23.2 Equipment
 - 23.2.1 The table cloth shall be marked in a manner similar to that shown in Diagram J with:
 - 23.2.1.1 areas for wagers, the number of betting areas being seven,
 - 23.2.1.2 areas for "Madness 21" wagers, the number of betting areas being seven, and
 - 23.2.1.3 inscriptions to the effect that:
 - 23.2.1.3.1 Blackjack pays 3 to 2.
 - 23.2.1.3.2 The Dealer must stand on 17 and must draw to 16.
 - 23.2.1.3.3 Insurance pays 2 to 1.
 - 23.2.1.3.4 "Madness 21".
 - 23.2.2 the name and or logo of the casino imprinted thereon.
 - 23.2.3 a jackpot button.
 - 23.2.4 an electronic meter which displays bonus prizes.
- 23.3 Additional Definitions
 - 23.3.1 In these rules the following meanings apply:
 - "Madness 21 wager" is a wager that may be made in addition to a players original wager in the corresponding space provided for "Madness 21" wagers. Once placed this wager entitles the player to a bonus prize when dealt a Blackjack.
 - 23.3.1.2 "Jackpot Button" is a device offered to each winning Madness 21 playing area which, when activated randomly selects a bonus prize payable to each player in the playing area with a "Madness 21" wager.

23.3.1.3 "Madness 21 Bonus Meter" is an electronic meter display used to display bonus prizes.

23.4 Wagers

- 23.4.1 Prior to the first card being dealt for each round of play players shall be given the opportunity to place a "Madness 21" wager by placing a chip on the appropriate area of the table layout.
- 23.4.2 A player may only place a "Madness 21" wager if they have already placed a Blackjack wager.
- 23.4.3 A player may wager on more than one Blackjack playing area and shall be entitled to place a "Madness 21" wager for each Blackjack wager.
- 23.4.4 The cost of a "Madness 21" wager shall be displayed on a sign at the table.
- 23.4.5 A "Madness 21" wager shall win if the player(s) hand is a Blackjack as defined in rule 1.1.1.
- 23.4.6 A ""Madness 21" wager shall lose if the player(s) hand is not Blackjack as defined in rule 1.1.1.
- 23.4.7 Where a dealer and a player both achieve Blackjack "Madness 21" wagers shall be paid.

23.5 Madness 21 Payments

23.5.1 Every hand that receives a Blackjack as defined in rule 1.1.1 shall qualify for payment of a bonus prize. To be eligible to win a bonus prize as described in Table 1, a player must place an original wager on a Blackjack playing area as well as a "Madness 21" wager in the "Madness 21" betting area.

* Bonus prizes listed above are for a \$1.00 'Madness 21' wager.									

- 23.5.2 When more than one player wagers on a Blackjack playing area, the player who controls the playing area according to rule 5.6 shall have the right to press the jackpot button.
 - 23.5.2.1 If that player declines the jackpot button, they may nominate another player with a valid "Madness 21" wager in the same Blackjack playing area.
 - 23.5.2.2 If no decision can be reached the dealer shall activate the button.
- 23.5.3 Once the prize has been established by activating the jackpot button all persons playing in that Blackjack playing area who have a "Madness 21" wager shall receive the prize individually.


23.6 Electronic Failure

- 23.6.1 In the event of electronic failure, the "Madness 21" wager will not be offered to patrons and a regular Blackjack game will be conducted.
- 23.6.2 Where an electronic failure occurs during a round of play any winning "Madness 21" wagers shall be settled with a payout that is equivalent to the minimum wager for the Blackjack playing area.'.

SWAN HILL SHIRE PLANNING SCHEME

Notice of Approval of Amendment Amendment L26

The Minister for Planning and Local Government has approved Amendment L26 to the Swan Hill Shire Planning Scheme.

The amendment adds clause 18(5) to the Rural (General Farming) Zone, allowing consideration of a proposed subdivision of lot 8 of lodged plan 66244 into not more than four lots, in order to facilitate development for irrigated agriculture. Lot 8 comprises 201.5 hectares and is located in Bulga Road, Woorinen South.
