### Melbourne City Link Act 1995

NOTICE OF INSTRUMENT OF DELEGATION

Under section 12 of the **Melbourne City Link Act 1995** ("the Act"), Transurban City Link Limited ACN 070 810 678, the Link corporation, gives notice that, by instrument dated 13 August 1999, it delegated to Translink Operations Pty Ltd ACN 069 691 574 (the Link operator referred to in section 11 of the Act):

- (a) all road operation and management powers within the meaning of section 62 of the Act conferred on the Link corporation;
- (b) all of its powers and functions under Part 4 of the Act, except section 71 of the Act;
- (c) all of its powers and functions under the regulations made under section 56 of the Transport Act 1983 (Vic); and
- (d) all of its powers and functions under section 183B(4) of the **Transport Act 1983** (Vic). In this notice:
- (a) the terms "Link corporation" and "Link operator" have the same meaning as in the Act; and
- (b) a reference to:
  - (i) the Act, any provision of the Act, or to any other statute or to any provision of any other statute, includes all regulations, proclamations, ordinances and by-laws (each a Subordinate Instrument), issued under the Act or the statute;
  - (ii) the Act, any provision of the Act, or to any other statute or to any provision of any other statute, or to a Subordinate Instrument or provision of a Subordinate Instrument shall, unless the contrary intention appears, be construed:
    - if the Act, statute, Subordinate Instrument, or provision in question has been amended, as a reference to the Act, statute, Subordinate Instrument, or provision as amended and in force for the time being;
    - (2) if the Act, statute, Subordinate Instrument, or provision in question has been re-enacted or re-made (with or without modification), as a

- reference to the Act, statute, Subordinate Instrument, or provision as re-enacted or re-made and in force for the time being;
- (3) if the Act, statute, Subordinate Instrument, or provision in question has been re-enacted or re-made (with or without modification) and subsequently amended, as a reference to the Act, statute, Subordinate Instrument, or provision as re-enacted or re-made and as subsequently amended and in force for the time being; and
- (4) if the Act, statute, Subordinate Instrument, or provision in question has been repealed and not re-enacted or re-made, as a reference to the Act, statute, Subordinate Instrument, or provision as in force immediately before its repeal.

### Melbourne City Link Act 1995

### DECLARATION EXCLUDING LAND FROM INTERIM OPERATION PROVISIONS

- I, Robert Maclellan, Minister for Planning and Local Government and Minister administering the **Melbourne City Link Act** 1995 ("the Act"), acting under the power conferred by section 60A (2) of the Act, by this Order declare that:
- (a) Subject to paragraph (b), section 60A of the Act no longer applies to the land and strata of land shown as excised in the plans in Schedule 2, the originals of which are lodged in the Central Plan Office;
- (b) Paragraph (a) does not apply to any land forming part of the Western Link of the "Link Road", being the land and strata of land comprised in the Crown Allotments listed in Schedule 1.

This Order takes effect on and from the date it is published in the Government Gazette.

# LORIMER STREET MAIN ROAD



EXCISE STRATA UNDER LINK ROAD


















### Planning and Environment Act 1987 VICTORIA PLANNING PROVISIONS Notice of Approval of Amendment

### Amendment VC7

The Minister for Planning and Local Government has approved Amendment VC7 to the Victoria Planning Provisions.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- Amends the State Planning Policy Framework to update document references in Clause 18.04 to reflect the approval of the Melbourne Airport Master Plan in December 1998 and the Melbourne Airport Ultimate Capacity (1998) Australian Noise Exposure Forecast by the Commonwealth Government in September 1998.
- Amends Airport Environs Overlay to clariful that, for Melbourne Airport:
  - Responsible authorities should consider the views of the lessee of the airport lease approved in accordance with the Commonwealth Airports Act 1996 when deciding on an application
  - The referral authority will be the lessee of the airport lease approved in accordance with the Commonwealth Airports Act 1996.
- Amends the State Planning Policy Framework to include a policy in Clause 19.04 relating to brothels. The aim is to ensure improved coordination of decisions under the **Planning and Environment Act** 1987 in relation to brothels with Part 4 of the **Prostitution Control Act 1994**. It particularly aims to correct an anomaly by confirming that it is policy that the provisions of that Part apply not only to applications for permit but also to applications or requests to amend permits for brothels.
- Amends the Public Park and Recreation Zone and the Public Conservation and Resource Zone to clarify that land identified in a schedule to the zones may be used and developed in accordance with the schedule or the specific controls contained in an incorporated document corresponding to the land

- Introduces a new State Resources Overlay, which is designed to protect areas of mineral, stone and other resources of State significance from development that would prejudice the current or future productive use of the resource.
- Amends Clause 52.05 to establish an equitable position for major promotion signs for which a permit was granted prior to Amendment VC5 in relation to major promotion signs permitted after Amendment VC5.
- Introduces a new definition of Sexual services in accordance with the **Prostitution**Control (Amendment) Act 1999 and establishes consistency in the definitions of Prostitution and Brothel between the VPP and the Prostitution Control (Amendment) Act 1999.

The Amendment relevant makes corresponding changes to the Alpine Resorts Planning Scheme, Ballarat Planning Scheme, Banyule Planning Scheme, Baw Baw Planning Scheme, Brimbank Planning Scheme, Campaspe Planning Scheme, Colac Otway Planning Scheme, Glen Eira Planning Scheme, Glenelg Planning Scheme, Golden Plains Planning Scheme, Greater Dandenong Planning Scheme, Greater Shepparton Planning Scheme, Horsham Planning Scheme, Indigo Planning Scheme, Melbourne Planning Scheme, Melton Planning Scheme, Mitchell Planning Scheme, Moonee Valley Planning Scheme, Mornington Peninsula Planning Scheme, Mount Alexander Planning Scheme, Murrindindi Planning Scheme, Port Phillip Planning Scheme, Pyrenees Planning Scheme, Queenscliffe Scheme, Southern Grampians Planning Planning Scheme, Towong Planning Scheme, Wangaratta Planning Scheme, Warrnambool Planning Scheme, Whitehorse Planning Scheme, Whittlesea Planning Scheme. Wyndham Planning Scheme, Yarra Planning Scheme.

Notice of Approval of Amendment
Amendment S83

The Minister for Planning and Local Government has approved Amendment S83 to all Planning Schemes in Victoria.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- 1. Amends and inserts definitions of prostitution, brothel and sexual services in clause 2-1 of the State section of consistency with the **Prostitution Control Act 1994**.
- 2. Inserts a new clause 3-18 to set out policy in relation to brothels, the aim of which is to improve coordination of decisions under the **Planning and Environment Act 1987** in relation to brothels with Part 4 of the **Prostitution Control Act 1994**.
- 3. Amends clause 7-6 to make specific provision for certain major promotion signs.
