Pipelines Act 1967

VARIATION TO LICENCE TO CONSTRUCT AND OPERATE PIPELINE 175

I, the Minister for Energy and Resources for the State of Victoria, hereby give notice in accordance with the provisions of Section 28A (1) of the **Pipelines Act 1967**, that the Licence to Construct and Operate a Pipeline 175 owned by Duke Eastern Gas Pipeline Pty Ltd and DEI Eastern Gas Pipeline Pty Ltd is varied by the:-

DELETION of Condition 1. Pipeline Specification in the Schedule of Pipeline Licence 175 and SUBSTITUTION OF

1. Pipeline Specification.

The pipeline shall, unless approved otherwise, be designed, constructed, operated, and maintained in accordance with Australian Standard AS 2885-Parts 1 & 3-1997 and AS 2885-Part 2-1995, and subsequent versions of these Standards, as well as the Permittee's licence application and accompanying specifications dated 6 November 1998, and additional information by letter of 13 February 1999, and any variations approved from time to time by the Minister, and the risk to be managed by ALARP.

Except as otherwise provided in Section 3 of this Schedule the pipeline shall have the following features:-

- (a) Maximum Allowable Operating Pressure:- 14,900kPa.
- (b) Contents:- Gaseous hydrocarbons.
- (c) Length:- 278 km.
- (d) Nominal diameter:- 450 mm and 610 mm.
- (e) Steel grades:- API 5L Grade X65 and Grade X70.
- (f) Wall thickness:- 9.8 mm, 11.6 mm, 11.8mm and 14.1 mm.
- (g) Coating:- Fusion Bonded Epoxy (FBE) 0.40 mm thick (minimum).
- (h) Depth of burial:- 750 mm minimum in R1 and R2 areas as per alignment drawings. Once identified, depths of burial of "Special Risk Areas" are subject to Ministerial approval.
- (i) A pressure control system.

- (j) A cathodic protection system.
- (k) Pigging facilities.
- (l) The ability to pass an intelligent pig.
- (m) A telemetry monitoring and control system to facilitate emergency shutdown.
- (n) Two solar Taurus 60 gas turbine compressor sets.
