The Victorian Civil and Administrative Tribunal has considered an application pursuant to Section 83 of the Equal Opportunity Act 1995 by Hamilton Jones & Koller Pty Ltd. The application for exemption is to enable the applicant to advertise for placements to fill positions of Legal Practitioner, Accounting, Engineering, Food Science and Professional Consultancy in respect of which employers who are clients of the Applicant have authorised the Applicant to organise recruitment and have certified to the Applicant that the employer genuinely believes that the nature of the position reasonably requires the person who fills it to have a specified minimum level of experience in the field and to include in those advertisements reference to the minimum levels of experience in the field mentioned in those certifications.

In this exemption this conduct is called the exempt conduct.

Upon reading the material submitted in support of the application, the Tribunal is satisfied that it is appropriate to grant an Act to enable the applicant to engage in the exempt conduct.

In granting this exemption, the Tribunal noted:

- The applicant is a recruitment consultant specialising in selection to various companies who employ professionals.
- The applicant searches and advertises for potential recruits and participates in the selection of the relevant professional staff.
- The applicant wishes to advertise on behalf of its clients employers for vacancies in various professional positions and to include in those advertisements certain experience requirements, basically minimum experience levels.
- In relation to the legal practitioner professional group experience is required because of the nature and complexity of a particular position's work. Without that minimum level of experience, a solicitor or legal practitioner would simply not be able to do the work, or would not be able to do it competently.
- In relation to the accounting professional group, experience is required because of the way the accounting profession is organised. There is a very strict structure of seniority based on experience, leading through the various chartered accountancy years through supervisor and manager and eventually partner, the top of the pyramid. Experience is necessary for those positions firstly because of the increasing complexity and often size of the jobs to be undertaken; secondly because one of the key components of these professional positions is leadership of a team and thirdly because of the serious nature of the liabilities that might result, if in fact inexperience led to some major error.
- In relation to the engineering professional group, the requirement for experience exists because of the complexity of the tasks that are assigned to the various engineering positions and also because of the expensive and complex nature of the equipment with which the engineer, who is required to be experienced in this way, will have to work. The dangers of inexperience in that context are not only dangers to the machinery but dangers to the public safety and the safety of other workers.

- In relation to the food sciences professional group, which are primarily research and development positions that deal with food technology, the requirement for experience is relevant and appropriate in the senior positions in the field because of the safety issues which may arise. There is a perceived danger to public safety which may arise from inexperience in these developments because they may well be products that will be marketed commercially and widely to the public.
- In relation to the professional consultancy group an experience requirement is relevant because this field relates primarily to management consultant positions, and the tasks that those management consultants would be called upon to perform concerns often major companies and major workforce restructuring proposals, and the consequences to both the company and the workforce are so serious, if in fact inexperience leads to some major error or some major failure in the project.
- The applicant also wants to include these various experience requirements in its advertisements because it is of the view that for particular positions, the nature of the position and the nature or complexity of its work, requires a minimum level of experience.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to engage in the exempt conduct.
