FISHERIES REGULATIONS 1998

Declaration in relation to the Levy for Aquaculture (Crown Land) Type A Licences Regulation 617A

For the purposes of regulation 617A(5) of the Fisheries Regulations 1998, the Secretary to the Department of Natural Resources and Environment, being the body corporate established by Part 2 of the **Conservation, Forests and Lands Act 1987**, declares in respect of the period 1 November 2000 until 31 October 2001 (inclusive) –

- (a) the following areas to be a growing area –
- (i) Flinders Growing Area;
 - (ii) Grassy Point Growing Area;
 - (iii) Clifton Springs Growing Area;
 - (iv) Beaumaris Growing Area;
 - (v) Dromana Bay Growing Area; and

- (b) the estimated total fixed costs of the Secretary for administering Aquaculture (Crown Land) Type A Licences to be \$75,300; and
- (c) the total area in hectares of Aquaculture (Crown Land) Type A Licences, at the time of making this declaration, to be 189 hectares; and
- (d) the estimated total variable costs of the Secretary for administering Aquaculture (Crown Land) Type A Licences in each growing area to be –
 - (i) Flinders Growing Area – \$23,464;
 - (ii) Grassy Point Growing Area – 17,832;
 - (iii) Clifton Springs Growing Area – \$19,709;
 - (iv) Beaumaris Growing Area – \$15,285;
 - (v) Dromana Bay Growing Area – 19,798; and
- (e) the total area in hectares of Aquaculture (Crown Land) Type A Licences in each growing area at the time of making this declaration to be –
 - (i) Flinders Growing Area – 69 hectares;
 - (ii) Grassy Point Growing Area – 39 hectares;
 - (iii) Clifton Springs Growing Area – 75 hectares;
 - (iv) Beaumaris Growing Area – 3 hectares;
 - (v) Dromana Bay Growing Area – 3 hectares.
