Crown Land (Reserves) Act 1978

ORDER STATING INTENTION TO GRANT A LEASE

Under Sections 17D and 17DA of the **Crown Land (Reserves) Act 1978**, I Sherryl Garbutt, Minister for Environment and Conservation, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease for a term of twenty-one years for the purposes of a Tourist Information Centre, Mount Alexander Diggings Interpretive Centre and for associated community use by The National Trust of Australia (Victoria) to the Mount Alexander Shire Council over the area of Crown land described in the Schedule below and, in accordance with Section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that:—

- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

SCHEDULE

The land, being the whole of the area described as Crown Allotment 3A, Section 20, Township of Castlemaine, known as the Old Castlemaine Market Building Reserve, permanently reserved for Conservation of an area of Historic Interest, in the Township of Castlemaine, by Order in Council of 19 August 1980 published in the Government Gazette of 22 August 1980, page 2917.).

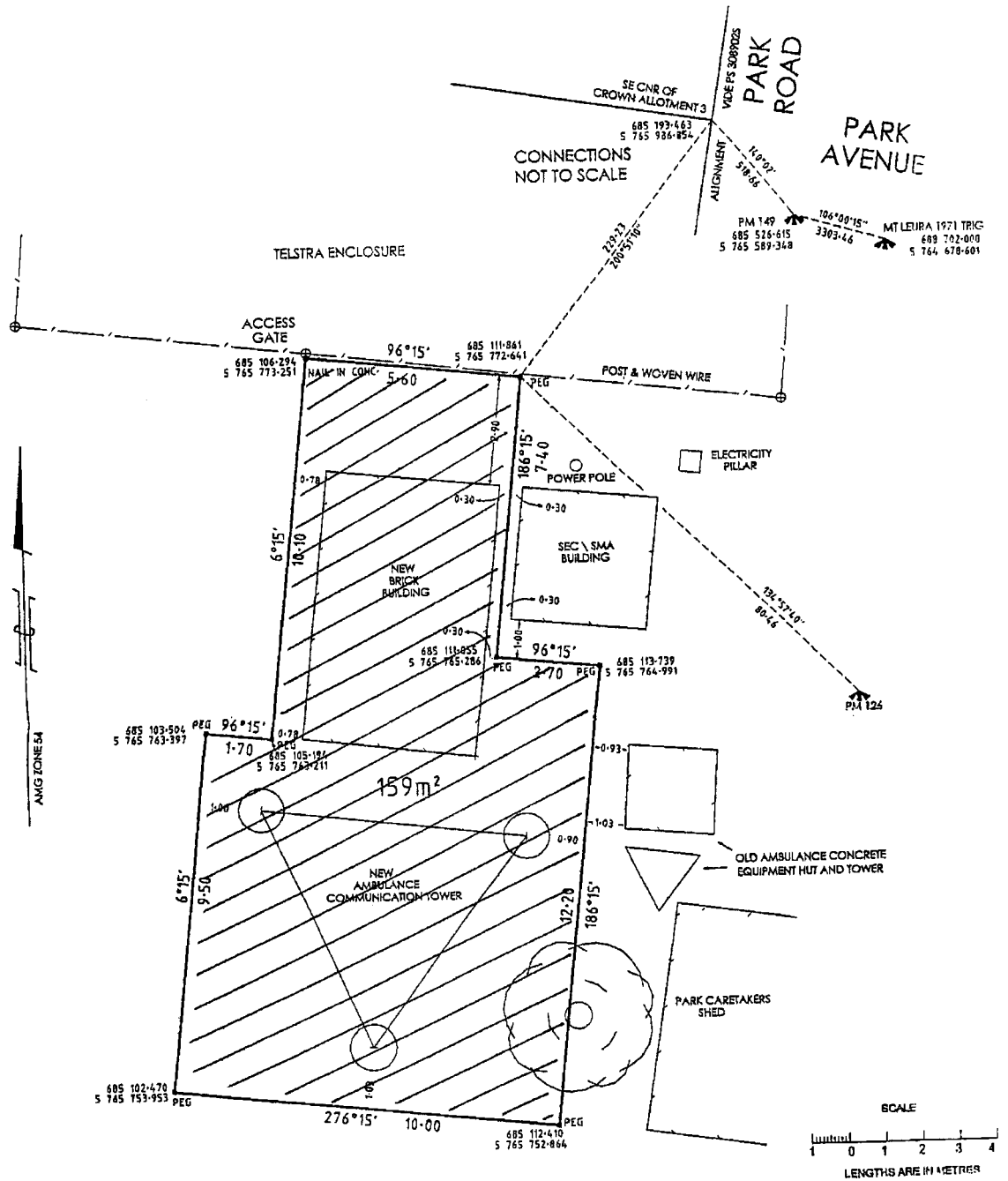
ORDER STATING INTENTION TO GRANT A LEASE

Under Sections 17D and 17DA of the **Crown Land (Reserves) Act 1978**, I Sherryl Garbutt, Minister for Environment and Conservation, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease for the purposes of “Construction and use of a Radio Transmission Tower and associated facilities” over the area of Crown land described in the schedule below and, in accordance with Section 17D(3) of the **Crown Land (Reserves) Act 1978**, state that:—

- (a) there are special reasons which make the granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.

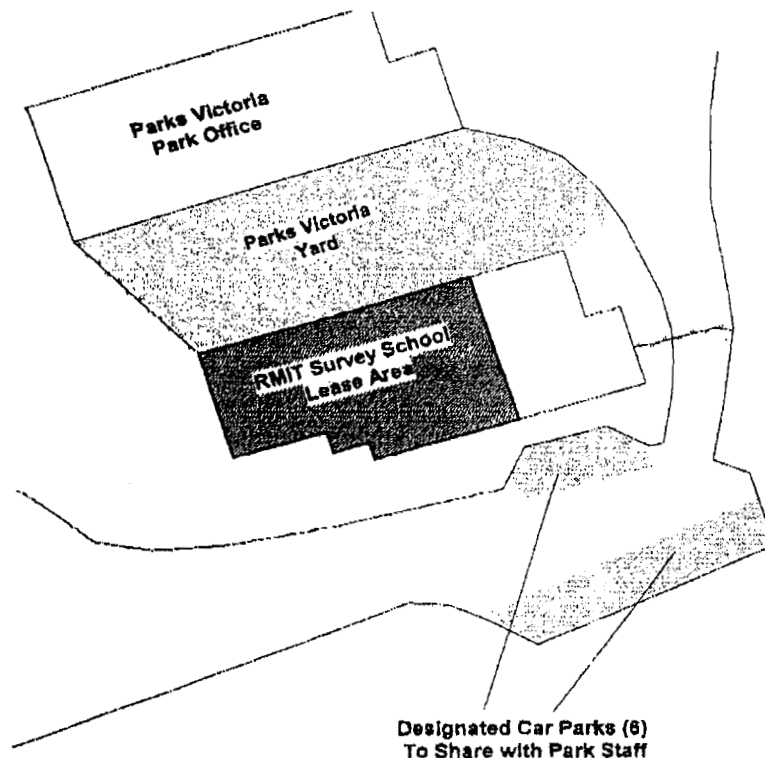
Crown Land (Reserves) Act 1978**ORDER GIVING APPROVAL TO GRANT A LEASE UNDER SECTIONS 17D AND 17DA**

Under Sections 17D and 17DA of the **Crown Land (Reserves) Act 1978**, I, Sherryl Garbutt, Minister for Environment and Conservation, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease by the Committee of Management for the purpose of a Survey School over a portion of the former Fairlea Prison Reserve described in the schedule below and, in accordance with Section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that:—

- (a) there are special reasons which make the granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.
