NOTICE OF INTENTION TO PROCEED TO MAKE REGULATIONS.

Education Regulations 2000

A Regulatory Impact Statement was published in September 2000 in relation to the proposed Education Regulations 2000.

Public comments and submissions were invited as required by section 11 (1) and (2) of the **Subordinate Legislation Act 1994**, and the comments and submissions which were received have been considered as required by section 11 (3) of that Act.

I have decided that the proposed regulations should be made with amendments. The amendments are as follows.

Regulation 24(1) has been amended to require the school council to have regard to the 'rights and responsibilities of students, parents and staff' when developing a school discipline policy.

In regulation 24(2) which deals with pupil discipline, the word "punishment" has been replaced with "sanctions".

A new regulation 26 (2) has been inserted so that a scholarship holder does not necessarily have to undertake a course of study (for example if presenting a paper at a conference).

Regulation 28(1) has been amended to enable the Minister to allow a school council to meet at least once a school term, instead of the normal requirement to meet at least twice a school term.

Regulation 40(3) has been amended to enable a parent or welfare club to have a separately identified record within the school council's bank account (rather than a separate bank account within the school council's bank account).

Regulation 45(6) has been amended to remove the express power to refuse to pay an Education Maintenance Allowance if the student's attendance at school 12 months prior to the Education Maintenance Allowance was unsatisfactory.

Part 11, dealing with transitional matters, has been deleted as it is unnecessary.
