CASINO RULES NOTICE NO. 32 OF 2000

Rules of the Game-Baccarat

By this notice, the Victorian Casino and Gaming Authority **amends** the Rules in respect of the game "Baccarat" as set out in the Schedule.

This notice operates with effect from 4.00am on 20 December 2000.

Schedule

1. Definitions

Insert, following rule 1.1.14 —

- '1.1.15 "Run" means an additional wager that may be placed on:
 - (a) a number of successive winning Player hands; or
 - (b) a number of successive winning Banker hands; or
 - (c) a number of successive winning Player/Banker hands in any combination; or
 - (d) a number of successive winning Tie hands.

A player may wager on up to a maximum of six successive hands for (a), (b) and (c) described above and on up to four successive Ties. In any sequence of (a), (b) or (c) a Tie will break that sequence. All Run wagers must be placed before the first coup of the nominated Run is dealt and a player may have more than one active Run wager at any given time.

This betting option may be offered on both Traditional Baccarat and Crown Baccarat.'.

2. Equipment

Insert, following rule 2.3 —

'2.4 Where the "Run" wager is offered, an additional betting area used to nominate and record the player's wager will be provided as described in diagram D.'.

3. Wagers

Insert, following rule 5.6.4 —

- '5.6.5 Player Run;
- 5.6.6 Banker Run;
- 5.6.7 Player/Banker Run. A wager must be placed on the player's hand or the banker's hand for each coup in the run; and
- 5.6.8 Tie Run.'.

4. Settlement

For rule 11.1.5, substitute —

'11.1.5 Wagers placed on a Run will be settled according to Table 3.

^{*}A Player Run, Banker Run or Player/Banker Run will be broken if the result of a coup is a Tie.

- 11.1.6 The commission shall be collected from a player at the time the winning payout is made, but for seated players only, it may be deferred to a later time.
 - 11.1.6.1 Deferred commission must be settled at the completion of each shoe unless a player requests an earlier settlement. When a player wishes to cease wagering before the end of a shoe any deferred commission must be settled before the player leaves the game.
 - 11.1.6.2 All outstanding commission shall be collected prior to the commencement of the next shoe and in no event shall the collection of any commission be deferred beyond such point.
 - 11.1.6.3 The amount of commission not collected prior to the time of the winning payout shall be evidenced by placing a marker button indicating the amount of the commission owed in the space provided in front of the dealer on the layout imprinted with the number of the player owing such commission.'

5. Irregularities

After Rule 12.8.4.2, insert —

'except where a wager has been placed in respect of a Run in which case the wager will remain on the table layout and the result of the Dummy Coup will have no effect on whether the Run wager wins or loses.'
