Melbourne City Link Act 1995 NOTICE OF DECLARATION OF LINK ROAD — SOUTHERN LINK

I, Peter Batchelor, Minister for Transport and Minister administering the **Melbourne City Link Act 1995** ("the Act"), in accordance with section 61 (3) of the Act, give notice that I have today made a declaration under section 61 (1) of the Act. A copy of that declaration is printed with this notice.

By operation of the definition of "Link road" in section 3 of the Act, the land the subject of the declaration is part of the Link road.

On the publication of this notice in the Government Gazette, by operation of section 61 (4) of the Act, the road specified in the declaration is deemed to be—

- a. a declared road within the meaning of the **Transport Act 1983**; and
- b. a road open to and for use by the public for passage with vehicles; and
- c. a highway within the meaning of the **Road** Safety Act 1986.

The declaration applies to the land comprised in the Crown Allotments and parts of Crown Allotments described in the declaration, as shown on the plans referred to in the declaration and lodged at the Central Plan Office of the Department of Natural Resources and Environment. Copies of these plans are available from the Land and Survey Information Centre, Department of Natural Resources and Environment, Ground Floor, 456 Lonsdale Street, Melbourne, 3000.

Overview plans and diagrams of the Southern Link are also published with this notice for information purposes only.

This declaration covers the entire Southern Link, including the Burnley Tunnel, and supersedes previous road declarations over parts of the Southern Link.

DECLARATION OF LINK ROAD — SOUTHERN LINK

I, Peter Batchelor, Minister for Transport and Minister administering the Melbourne City Link Act 1995 ("the Act"), acting under section 61 (1) of the Act and under section 27 of the Interpretation of Legislation Act 1994:

1. Repeal the following declarations of roads under section 61 (1) of the Act—

- a. the declaration made on 21 December 1999 and published In Government Gazette No. S 190 on that date, and
- b. the declaration made on 4 May 2000 and published in Government Gazette No. S 58 on that date.
- 2. Declare to be a road the land and strata of land comprised in the Crown Allotments listed in Schedule 1, being land and strata of land to which section 61 (1) (b) of the Act applies.
- 3. State that
 - a. the following parts of the road are to be treated as State highway
 - i. the land and strata of land shown hatched, cross-hatched and filled on plans LEGL./99-204 to LEGL./99-211 in Schedule 2 (the originals of which are lodged in the Central Plan Office),
 - ii. Crown Allotment 5E, Parish of Jika Jika (as shown on the plan numbered LEGL./99-198 lodged in the Central Plan Office),
 - iii. Crown Allotment 5F, Parish of Jika Jika (as shown on the plan numbered LEGL./99-198 lodged in the Central Plan Office),
 - iv. all strata of land more than 1 metre below the surface of elevated roadways on the Monash Freeway, and
 - b. the remainder of the road the subject of this instrument is to be treated as a freeway.


PARTS OF THE SOUTHERN LINK THAT ARE TO BE TREATED AS STATE HIGHWAY










