REGULATORY IMPACT STATEMENT

Proposed Health (Legionella) Regulations 2001

Notice is given as required by Section 11 of the **Subordinate Legislation Act 1994** of the proposed making of the Health (Legionella) Regulations 2001.

The objectives of the regulations, proposed to be made under the **Health Act 1958**, are to –

- (a) prescribe procedures for the maintenance and testing of cooling tower systems and warm water systems; and
- (b) require owners and persons who have the management or control of cooling tower systems and warm water systems to keep records on the maintenance and testing of those systems and to make those records available for inspection by an authorised officer on request; and
- (c) enable the Secretary of the Department of Human Services to –
 - (i) substitute different procedures in different circumstances; and
 - (ii) require additional procedures to be undertaken when a system is suspected or implicated in the spread of the prescribed infectious disease, legionellosis.

A Regulatory Impact Statement has been prepared in accordance with the **Subordinate Legislation Act 1994**. The statement examines the costs and benefits of the proposed regulations and possible alternatives. The results of the statement are that the proposed regulations are the most efficient method of achieving the objectives.

The Department of Human Services is engaging in a broad consultation process for the Regulatory Impact Statement. In addition to the statutory advertising requirements, the Department has circulated the Regulatory Impact Statement for comment to over 2500 stakeholders and will be conducting five public consultation forums.

The forums will include representatives of the Department of Human Services, Building Control Commission and Plumbing Industry Commission, and provide overviews of the Government's Legionella risk management package, this Regulatory Impact Statement and the proposed Health (Legionella) Regulations 2001.

Written submissions in connection with the Regulatory Impact Statement are invited from any interested industry or community group and from the public in relation to any matter relevant to the proposed regulations.

REGULATORY IMPACT STATEMENT

Plumbing (Cooling Towers) Regulations 2001

Notice is hereby given in accordance with section 11 of the **Subordinate Legislation Act 1994** of the proposed making of the Plumbing (Cooling Towers) Regulations 2001.

The objectives of the proposed regulations are to provide for mechanical services work on all cooling towers to be carried out by licensed and registered persons with the Plumbing Industry Commission and to set minimum standards, namely Parts 1, 2 and 3 of AS/NZS 3666 published by Standards Australia International Ltd, for the carrying out of mechanical services work on cooling towers.

A Regulatory Impact Statement has been prepared in accordance with the **Subordinate Legislation Act 1994**.

The reasons for the proposed regulations are to reduce the risk and incidence of Legionnaires' disease by reducing or preventing the growth of the harmful *Legionella* bacteria in cooling towers and reducing the spray drift from the cooling towers. The Regulatory Impact Statement examines the costs and benefits of the proposed regulations and the possible alternatives and concludes that, as part of the Government's legislative framework, the proposed regulations provide the most effective means of achieving the objectives by requiring mechanical services work on cooling towers to be carried out by competent persons complying with minimum standards.
