Rules of the Game — Baccarat

2. Crown Baccarat

- (1) In rule 1.1.12, **substitute** “Crown Baccarat” for “Modified Baccarat”.
- (2) In rule 1.2.2, **substitute** “Crown Baccarat” for “Modified Baccarat”.
- (3) In rule 11.2, **substitute** “Crown Baccarat” for “Modified Baccarat”.
