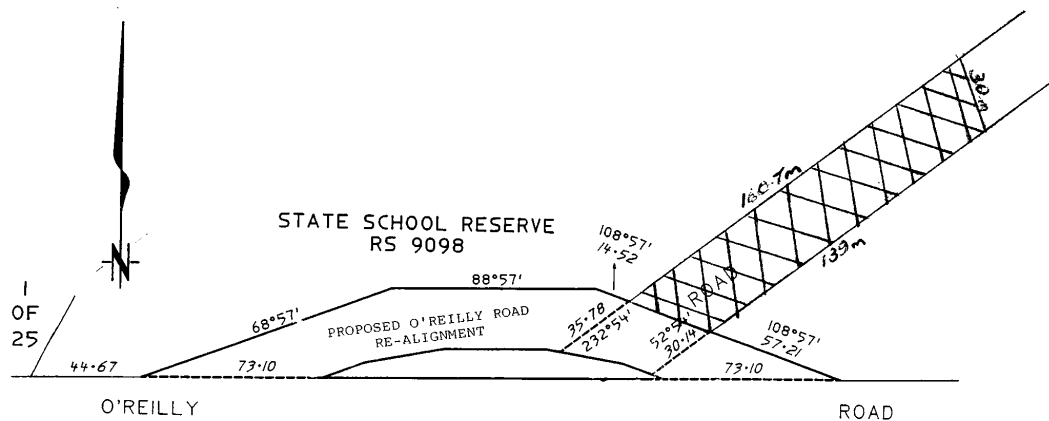

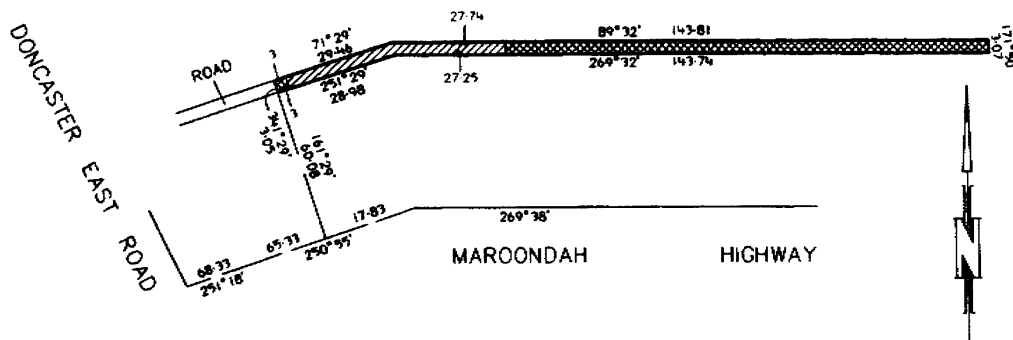

- Females generally dominate the disability service sector. In order to maintain a gender balance within the staff team specific advertising methods are sometimes required to attract suitable male applicants.
