## Electricity Industry Act 1993

### DELEGATION

Pursuant to a proclamation made by the Governor in Council on 4 February 2000 under section 47B of the **Electricity Industry Act 1993** ("the Act") and the powers vested in me under section 47E of the Act:

I, Stephen Phillip Bracks, being the Minister responsible for the Act, hereby delegate to John Perham, Deputy Secretary, Department of Treasury and Finance ("the Delegate"), the powers and functions vested in me under sections 47C of the Act, to:

1. vary the Direction made on 4 February 2000 ("the Direction"), to lessen or remove the restrictions on certain activities or classes of activities imposed by that Direction. Any such variations are to take effect from the date that they are made; and
2. exempt persons or bodies from restrictions imposed by the Direction.

This delegation takes effect from 3.30 pm on 7 February 2000.

**Electricity Industry Act 1993****DIRECTION VARIATION**

Pursuant to section 47C(6) of the **Electricity Industry Act 1993** ("the Act") I, John Perham, Deputy Secretary in the Department of Treasury and Finance, as the delegate of the Minister responsible for the Act under an instrument dated 7 February 2000, hereby vary the Direction made by the Minister on 4 February 2000 ("the Direction") by:

1. exempting from the absolute restriction on the use of air conditioners for cooling or heating of premises the following organisations to the following extent:
  - the Australian Red Cross Blood Service, Victoria, to the extent necessary to preserve blood products;
  - the Victorian Institute of Forensic Mental Health and the Victorian Institute of Forensic Medicine, to the extent necessary to preserve forensic samples; and
  - the Museum of Victoria, insofar as it consists of the Immigration Museum, to the extent necessary to preserve its collection.
2. adding the following class of person to paragraph (a) of Attachment 2 to the Direction:  
"prisoners prisoners held at the Metropolitan Assessment Prison or the Melbourne Custody Centre"
3. adding the following classes of bodies to paragraph (b) of Attachment 2 to the Direction:
  - community health services;
  - maternal and child health services;
  - day care centres for aged or disabled persons;
  - radiology and pathology services; and
  - dental services.

This Variation takes effect from 4 pm on 7 February 2000.
