Notice of Approval of Amendment Amendment C8

The Minister for Planning has approved Amendment C8 to the Greater Dandenong Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment rezones two portions of land, on the former Minster carpet site, situated at the intersection of Princes Highway, Gladstone Road and David Street, Dandenong. The Amendment rezones:

- The underdeveloped eastern portion of the site, fronting David Street, from Business 4 to Residential 1.
- The western half of the undeveloped northern portion of the site, having no street frontage, from Residential 1 to Business 4.

The amendment also applies an Environmental Audit Overlay over the portion of the land rezoned to Residential 1.

The Minister has granted the following permit under Division 5 Part 4 of the Act:
