EXEMPTION

Application No. A129 OF 2000

The Victorian Civil and Administrative Tribunal has considered an application pursuant to Section 83 of the **Equal Opportunity Act 1995** by Inner South Community Health Service Inc ("ISCHS"). The application for exemption is to enable the applicant to advertise for, and appoint a position funded under the Supported

Accommodation and Assistance Program ("SAAP") for a female worker with general responsibility as a community development worker and specifically in the area of homeless young women.

UPON READING the material tendered in support of this application the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 13, 100 & 195 of the Act to enable the applicant to advertise for, and appoint a position funded under the Supported Accommodation and Assistance Program ("SAAP") for a female worker with general responsibility as a community development worker and specifically in the area of homeless young women.

In granting this exemption the Tribunal noted:

- The ISCHS was incorporated in October 1993 following the voluntary amalgamation of Prahran, South Port and St Kilda Community Health Centres.
- The ISCHS is a major provider of community based health services in the area. The Service is committed to the delivery of health services, which reflect the needs of the community, and adheres to a comprehensive, integrated view of health. The emphasis is strongly on prevention, early intervention, rehabilitation and education to achieve good health.
- The ISCHS has recently been awarded the auspice of the former Prostitutes Collective Victoria known currently as "PCV" pending a formal name change. The ISCHS wishes to commence a proactive and extensive recruitment campaign to provide service delivery to workers in the sex industry.
- PCV provides a range of centre based and outreach services to workers in sex industries across Victoria. Services include support, education, referral and advocacy with a particular emphasis on health related education and prevention that reduces the risk of exposure to blood borne viruses such as HIV/AIDS an Hepatitis C and sexually transmitted diseases (STDs).

- The ISCHS has philosophies in its mission statement which include incorporating effective health education and illness prevention strategies into all aspects of their work; providing the highest quality support and treatment programs specifically designed to most appropriately meet the needs of particular client groups; employing professional and committed staff who are respectful of clients rights and needs; fostering the continued development of accessible. well organised welcoming centres; and actively engaging in partnerships with clients and colleagues so as to utilise and achieve the best possible health outcomes for individuals. groups and broader community.
- The Service operates from three well located and well-equipped facilities and is thus able to remain locally responsive whilst offering a broad range of programs and services.
- The position funded under the SAAP targets young women 15-24 years of age with particular emphasis on young women 15-19 years of age in the City of Port Phillip, which includes the suburb of St Kilda who are homeless or at risk of homelessness and vulnerable to exploitation in the sex industry.
- Street sex workers are predominantly women and many are young who are homeless women particularly vulnerable to violence and sexual assault and require knowledge of and sensitivity to women's experiences.
- A woman will be better able to communicate with and respond to the needs of these women and they will feel more comfortable with her and more likely to participate in the programs which she can offer.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to advertise for, and appoint a position funded under the Supported Accommodation and Assistance Program ("SAAP") for a female

worker with general responsibility as a community development worker specifically in the area of homeless young women

The Victorian Civil and Administrative Tribunal has considered an application to Section 83 of the Equal Opportunity Act 1995 by Inner South Community Health Service Inc ("ISCHS"). The application for exemption is to enable the applicant to advertise for, and appoint the following four positions funded by the Department of Human Services Blood Borne Virus Program, to specifically target male, female and transgender sex industry workers:

- 1 Male Sexually Transmitted Disease ("STD") Adviser/Outreach Worker to male street sex workers, male escort and private male sex workers; transgender sex industry workers;
- 1 Female STD Adviser/Outreach Worker to female street sex workers. escorts and private female sex workers: and transgender sex industry workers;
- 2 Female STD Advisers/Outreach Workers to brothels, female escort and private female sex workers.

UPON READING the material tendered in support of this application the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 13, 100 & 195 of the Act to enable the applicant to advertise for, and appoint the following four positions funded by the Department of Human Services Blood Borne Virus Program, to specifically target male, female and transgender sex industry workers.

• 1 − Male Sexually Transmitted Disease ("STD") Adviser/Outreach Worker to male street sex workers, male escort and private male sex workers; transgender sex industry workers;

- 1 Female STD Adviser/Outreach Worker to female street sex workers. escorts and private female sex workers; and transgender sex industry workers;
- 2 Female STD Advisers/Outreach Workers to brothels, female escort and private female sex workers.

In granting this exemption the Tribunal noted:

- The ISCHS is a major provider of community based health services in the area. - The ISCHS has philosophies in its mission statement which include incorporating effective health education and illness prevention strategies into all aspects of their work; providing the highest quality support and treatment programs specifically designed to most appropriately meet the needs of particular client groups; employing

professional and committed staff who are respectful of clients rights and needs; fostering the continued development of accessible, well organised and centres; and actively welcoming engaging in partnerships with clients and colleagues so as to utilise and achieve the best possible health outcomes for individuals, and broader groups community.

- The Service operates from three well located and well-equipped facilities and is thus able to remain locally responsive whilst offering a broad range of programs and services.
- The sex industry is not a homogenous industry and requires different approaches to the different streams. The majority of sex industry workers are females providing services for heterosexual male clients. There are approximately 80 legally registered brothels in Victoria which are staffed by female sex industry workers.
- Workers engaged in different aspects of the sex industry often have very different self and professional concepts and relate quite differently to service providers.
- Within the street sex industry workforce there are levels of differentiation relating to gender and experience to be addressed if programs are to effectively reach and meet the needs of street sex workers. Street sex workers, are predominantly women and include young homeless women who are particularly vulnerable to violence and sexual assault and require knowledge of and sensitivity to women's experiences.
- ISCHS program will be able to better cater for and better respond to the needs of male, female and transgender sex workers it is conducted by volunteers either of the same sex as the sex worker, or in the case of transgender six workers, it provides the transgender sex worker with a choice of male or female service providers. ISCHS wishes to be able to provide a program which gives the fullest opportunity to sex workers to participate in a program conducted by those with

whom they feel comfortable to discuss their needs.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to advertise for, and appoint the following four positions funded by the Department of Human Services Blood Borne Virus Program, to specifically target male, female and transgender sex industry workers:

- 1 Male Sexually Transmitted Disease ("STD") Adviser/Outreach Worker to male street sex workers, male escort and private male sex workers; and transgender sex industry workers;
- 1 Female STD Adviser/Outreach Worker to female street sex workers, escorts and private female sex workers; and transgender sex industry workers;
- 2 Female STD Advisers/Outreach Workers to brothels, female escort and private female sex workers.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 29 March 2003.
