- In these residences, two young people aged 16 − 17 who are under Care and Protection live in these premises.
- The residents often suffer from challenging behaviours such as offending, drug usage and difficulty in interpersonal relationships.
- The aim of the service is to prepare the residents for the next step into independent living and to assist them in developing appropriate adult life skills.
- The role of the lead tenant (who lives in the residence provided by MacKillop Family

Services) is to act as a role model to these young residents who are on the verge of leaving care, in providing and assisting with independent living skills such as budgeting, cooking and developing appropriate support networks

- It is the services experience that it is inadvisable to engage a very young lead tenant, because at times they have difficulty in separating their own developmental issues from those of the young residents. Gaining respect of the young people can also be an issue for a young lead tenant.
- The lead tenant needs to have sufficient life experience and maturity to respond appropriately to a range of challenging behaviours, and at the same time be able to role-model a satisfying and independent lifestyle as a young person themselves.
- The upper age limit of 45 years is sought to imply a youthful role model rathen than a parental or authoritative figure.

# ORDER GIVING APPROVAL TO GRANT OF LEASE


Pursuant to sections 17D(1) and 17DA of the Crown Land (Reserves) Act 1978 I, Sherryl Garbutt, Minister for Environment and Conservation, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the Crown Land (Reserves) Act 1978, approve the granting of a lease by the City of Melbourne over parts of Yarra Park described and identified in the Schedule below for the purpose of providing areas for the support services and facilities required to facilitate the staging of the Olympic Football Tournament at the Melbourne Cricket Ground and without limiting the generality of such purpose includes provision of a broadcasting compound and associated cables to the Melbourne Cricket Ground Reserve, vehicle permit and security check points, portable ticket boxes, soil and turf storage compounds and carparking areas, and, in accordance with section 17D3(a) of the Crown Land (Reserves) Act 1978, state that:-

- a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the Crown Land (Reserves) Act 1978.

In stating the above, I also confirm that my approval, taking into the requirements of section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, will also apply to any additional parts of Yarra Park that may be required at short notice to facilitate the staging of the Olympic Football Tournament at the Melbourne Cricket Ground arising out of changed requirements of the Sydney Organising Committee for the Olympic Games, changed surface conditions of Yarra Park or to accommodate changed security measures.

#### **SCHEDULE**

The areas shown shaded on the following plan and identified as Broadcast Compound, Broadcasters/Media Parking, Operations External parking Vehicle Check Point, Vehicle Permit Check, Ticketing Office, cable route sand stockpile and soil stockpile, being parts of the land permanently reserved as a public park by Order in Council dated 9 June 1973 and published in the Government Gazette of 13 June 1873. The above areas are approximate only at this stage and may change subject to any emerging requirements of the Sydney Organizing Committee for the Olympic Games. — Rs 4134.
