ORDER REVOKING TEMPORARY RESERVATIONS OF LAND FOR THE PURPOSES OF THE MELBOURNE CITY LINK PROJECT

The Governor in Council, under section 59 (2) of the **Melbourne City Link Act 1995** and on the recommendation of the Minister for Transport that the temporary reservations of the licensed land described in the Schedule be revoked on the termination of the licences as to that land, revokes the temporary reservations under the **Crown Land (Reserves) Act 1978** of the land described in the Schedule.
