- 6. Elgin Hotel, 27-29 Reid Street, Wodonga;
- 7. Flemington Racecourse, Epsom Road, Flemington;
- 8. Marma Gully Hotel, 53 Marma Street, Murtoa;
- 9. Mount Beauty Workman's Club, 1 Lakeside Avenue, Mount Beauty;
- 10. Mountain View Hotel, Morses Creek Road, Bright;
- 11. Robinvale Hotel, 70 Perrin Street, Robinvale;
- 12. Royal Mail Hotel, McLennan Street, Mooroopna;
- 13. The Wonthaggi Club, 16 McBride Avenue, Wonthaggi;
- 14. York on Lilydale Resort, York Road, Mount Evelyn.

Rules of the Game — Roulette

By this notice, the Victorian Casino and Gaming Authority amends the Rules in respect of the game "Roulette"¹ as set out in the Schedule.

1. Layout

In rule 2.2.1 for 'or diagram "E",' substitute'diagram "E" or diagram "I"".

2. Double zero roulette wheel

Substitute rule 2.3 —

- 2.3 A roulette wheel shall be configured according to one of the options described below
 - 2.3.1 each have 37 equal compartments with one marked zero and the others marked 1 to 36 coloured alternately red and black around the wheel; and
 - 2.3.2 the numbers marked shall be in the same order as that shown in diagram B or —
 - 2.3.3 each have 38 compartments with one marked zero and another marked double zero, and the others marked 1 to 36 coloured alternately red and black around the wheel; and
 - 2.3.4 the numbers marked shall be in the same order as that shown in diagram J.





- 6.4 When the result is zero or double zero all other wagers except those described in rules 6.2 and 6.3 shall be lost.


