## **Crown Land (Reserves) Act 1978**

**ORDER STATING INTENTION TO GRANT A LEASE**

Under Sections 17D and 17DA of the **Crown Land (Reserves) Act 1978**, I Sherryl Garbutt, Minister for Environment and Conservation, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease for a term of 20 years for the purposes of Equipment shelter by the Southern Grampians Shire Council to AAPT Limited over the area of Crown land described in the Schedule below and, in accordance with Section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that:-


- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
  - (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the Crown Land (Reserves) Act 1978.


**Crown Land (Reserves) Act 1978****ORDER STATING INTENTION TO GRANT A LEASE**

Under Sections 17D and 17DA of the **Crown Land (Reserves) Act 1978**, I Sherryl Garbutt, Minister for Environment and Conservation, being satisfied that there are special reasons which make granting a lease reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of a lease for a term of 10 years for the purposes of Telecommunications by the Southern Grampians Shire Council to Telstra Corporation Limited over the area of Crown land described in the Schedule below and, in accordance with Section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that:-

- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**.
