

Charge – Unprofessional conduct. Being unfit to be a registered veterinary practitioner in being found guilty in the Magistrates Court at Melbourne on 20 April 1999 of offences against Drugs, Poisons and the Controlled Substances Act 1981 and without conviction adjourned to Melbourne Magistrates Court on 20 April 2000 were ordered to pay an aggregate of \$2,130.00 to the Court Fund and released upon giving an undertaking to be of good behaviour and to appear if called upon during the period of adjournment and further ordered the sum of \$7,870.00, being the proceeds of sale of drugs, be forfeited and paid to the drug rehabilitation fund.

The charges brought against Dr. Rankin which lead to the Magistrates Court case, related

to the sale, supply, labelling, record keeping and wholesaling of restricted drugs.

Dr. Geoffrey Dorrat Rankin pleaded guilty.

The Board found as follows:

Pursuant to Section 45 (1) of the Veterinary Practice Act 1997 ("the Act"), Dr. Rankin was found guilty of unprofessional conduct of a serious nature within the meaning of paragraphs f(ii) and (iv) of the definitions, Section 3 of the Act.

and made the following determination pursuant to Section 45 (2) of the Act: suspension of registration from midnight 1 March 2000 to midnight 1 September 2000; costs of \$5,445 awarded against (stay of 3 months granted); the hearing and determination to be reported in the Government Gazette; the hearing and determination to be notified to all other veterinary registration authorities in Australia and New Zealand.






