Melbourne City Link Act 1995

NOTICE UNDER SECTION 71(1)

Under section 71(1)(a) of the **Melbourne City Link Act 1995** ("the Act"), Transurban City Link Limited ACN 070 810 678 (the relevant corporation in relation to the Link road) specifies the following toll zones on the Link road:

Toll zone	Area on the Link road
4	That part of the Link road being the Domain Tunnel and the carriageway leading into the tunnel west of Punt Road other than toll zone 7.
7	That part of the Link road - (a) between Burnley Street and Punt Road, other than the eastbound carriageways; (b) being the Monash Freeway between Punt Road and the exit to Boulton Parade, other than the eastbound carriageways; and (c) Boulton Parade.
9	That part of the Link road between Glenferrie Road and Burnley Street, other than the eastbound carriageways.
11	That part of the Link road between Punt Road and Swan Street Intersection, other than - (a) toll zone 4; (b) toll zone 7; and (c) the eastbound carriageways.

For the avoidance of doubt, a reference in this Notice to the specification of a toll zone by reference to Burnley Street refers to that point on the Link road where Burnley Street would cross the Link Road if Burnley Street continued in a straight southerly direction from its southernmost extremity.

The Schedule as attached shows details of the location of toll zones 4, 7, 9 and 11 and is for illustrative purposes only; the Schedule is not to be used for the purpose of construing this Notice.

For the avoidance of doubt, this Notice also:

- (i) revokes or repeals; or, in the alternative
- (ii) amends -

the NOTICE UNDER SECTION 71(1) dated 19 April 2000 and published in the Victoria Government Gazette (Special) No. S49 (pages 1 to 2), dated 19 April 2000 ("the First Notice").

This Notice takes effect on 2 May 2000, and for the avoidance of doubt, the First Notice ceases to have effect when this Notice takes effect, and the revocation, repeal, amendment or ceasing to have effect of the First Notice shall not:

- (a) revive anything not in force or existing at the time at which the revocation, repeal amendment or ceasing to have effect becomes operative;
- (b) affect the previous operation of the First Notice or anything duly done or suffered under the First Notice;
- (c) affect any right, privilege, obligation or liability acquired, accrued or incurred under the First Notice;
- (d) affect any penalty, forfeiture or punishment incurred in respect of any offence committed relating (directly or indirectly) to or in respect of the First Notice; or

- (e) affect any investigation, legal proceeding or remedy in respect of any such right, privilege, obligation, liability, penalty, forfeiture or punishment as is mentioned in paragraphs (c) and (d) -

and any such investigation, legal proceeding or remedy may be instituted, continued or enforced, and any such penalty, forfeiture or punishment may be imposed, as if the First Notice had not been revoked or repealed or amended or had not expired, lapsed or otherwise ceased to have effect.

For the purposes of this Notice, the following definitions apply:

Boulton Parade includes the off-ramp from Monash Freeway to Boulton Parade;

Domain Tunnel means the westbound tunnel between Punt Road and Sturt Street; and

Swan Street Intersection means the intersection between Swan Street and Batman Avenue.

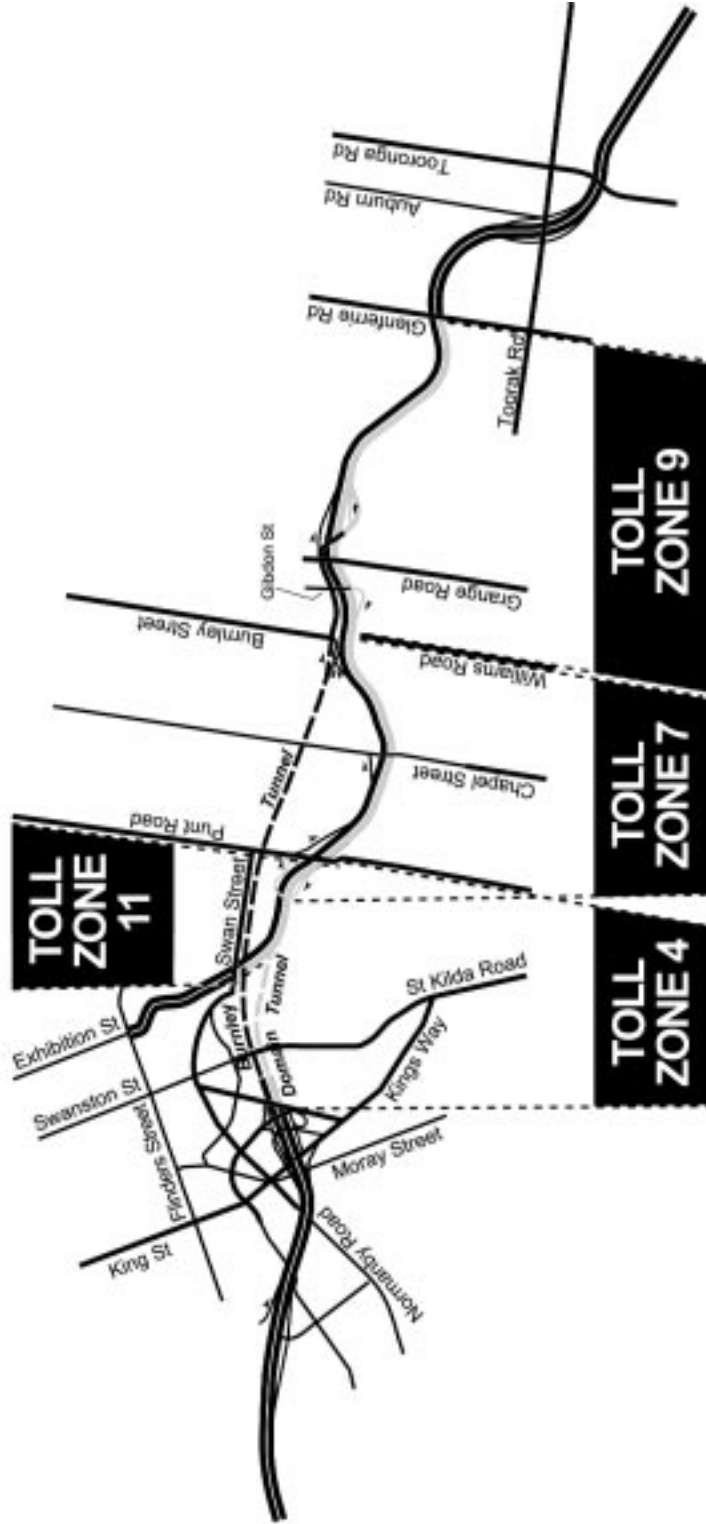

1. This Map does not form part of the formal Notice specifying toll zones 4, 7, 9 and 11, and is published for information purposes only.
2. It is an offence to drive a vehicle in a toll zone unless that vehicle:
 - a. is registered with Transurban City Link Ltd. ("Transurban") for tolling purposes, or
 - b. has been exempted by Transurban from the requirement to be registered, or
 - c. is an emergency services or Defence Force vehicle that is toll exempt under the **Melbourne City Link (General) Regulations 1999**.
