To: Lex Lasry QC GREETINGS: WHEREAS:

- A. By Letters Patent in Our Name by the Governor of the State of Victoria in the Commonwealth of Australia, by and with the Executive Council and acting pursuant to s88B of the **Constitution Act 1975** on 21 December 1999 and which was recorded in the Register of Patents Book No 42, Page No. 50 on that day, you were appointed and constituted to be Our Commissioner to inquire into and report upon the matters referred to in the Letters Patent.
- B. It is expedient that the terms of the inquiry specified in the said Letters Patent be varied to expand one term, remove another term and to correct certain minor typographical errors

NOW THEREFORE the Governor of the State of Victoria, in the Commonwealth of Australia by and with the advice of the Executive Council and acting pursuant s.88B of the Constitution Act 1975 hereby amends the said Letters Patent by:

- 1. Substituting for sub-paragraph (iii) of paragraph 3 the following: "(iii) outsourcing of non-emergency services".
- 2. Substituting for paragraph 5, the following:
 - "5. Whether between June 1997 and December 1999 any member of the staff of Intergraph-
 - (a) was directed to make telephone calls to Intergraph; or
 - (b) engaged in any illegal or improper conduct

for the purpose of enabling Intergraph to appear to meet certain standards included in CSSS or for the purpose of increasing the entitlements of Intergraph under its contract with the Service in any other manner".

- 3. Substituting for the words "paragraph (b)" in sub-paragraph (e) of paragraph 6, the following: "sub-paragraph (d)".
- 4. Omitting paragraph 8.
