## ROAD SAFETY (VEHICLES) REGULATIONS 1999

### Class 2 Notice as to Certain Controlled Access Buses

Regulation 510 of the Road Safety (Vehicles) Regulations 1999 provides that the Roads Corporation may by a notice published in the Government Gazette, exempt a category of class 2 vehicles from-

- (a) A mass or dimension limit, other than a limit that relates to a GVM, or a GCM or a manufacturer's limit; or
  - (b) any other requirement -
- set out in Schedule 2 to the Regulations.

In accordance with that regulation, I, Geoff Klood, delegate of the Roads Corporation, exempt from the axle mass limits set out in Schedule 2 to the Regulations a controlled access bus that has:-

- (a) at least one stairless entry point;
- (b) only two axles;
- (c) a loaded mass that does not exceed 16 tonnes; and
- (d) a mass on the rear axle that does not exceed 11 tonnes.

This Notice is subject to the following conditions:

- (a) that the gross vehicle mass does not exceed 16 tonnes; and
- (b) that the rear axle gross mass does not exceed 11 tonne.

This notice operates from the date of its publication in the Government Gazette until 30 June 2005.

## ROAD SAFETY (VEHICLES) REGULATIONS 1999

### Notice Declaring Certain Buses with Low Floors to be Class 3 Vehicles

Regulation 515(2) of the Road Safety (Vehicles) Regulations 1999 provides that the Roads Corporation may by notice published in the Government Gazette declare a category of vehicles to be Class 3 vehicles.

Clause 39 of Schedule 3 to the Regulations provides that the mass limits for a vehicle in a category of vehicles declared by the Corporation under regulation 515(2), are the relevant mass limits for that vehicle set out in Division 1 of Part 4 of the Regulations except to the extent that the Corporation specifies otherwise in the declaration.

In accordance with those provisions, I, Geoff Klood, delegate of the Roads Corporation, declare that a bus is a Class 3 vehicle if: -

- (a) it has at least one stairless entry point;
- (b) it has only two axles;
- (c) its length does not exceed 12.5 metres;
- (d) its loaded mass does not exceed 16 tonnes; and
- (e) the mass on its rear axle does not exceed 11 tonnes.

I further declare that the mass limits of this bus do not include the limits set out in Division 1 of Part 4 of the Regulations to the extent that they are inconsistent with the above requirements.

This notice operates from the date of its publication in the Government Gazette until 30 June 2005.
