Amendment C15

The Minister for Planning has approved Amendment C15 to the Brimbank Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The amendment zones on about 33 hectares of former Commonwealth land, now known as the Cairnlea Estate generally bounded by Station Road, the Western Ring Road and Western Highway, Albion. The zones to be applied are a Residential 1 zone and a Public Park and Recreation zone. A Development Plan Overlay and an Environmental Audit Overlay will also apply to the land. the amendment relates to stages 6, 10, 14, 15 and 18 of the proposed development.

The amendment places zones on about 38 hectares of former Commonwealth land, now known as the Cairnlea Estate generally bounded by Station Road, the Western Ring Road and Western Highway, Albion. The zones to be applied are a Residential 1 zone and a Public Park and Recreation zone. A Development Plan Overlay and an Environmental Audit Overlay will also apply to the land. the amendment relates to stages 16, 17, 19, 20, 21, 22, 23 and 24 of the proposed development.
