Melbourne City Link Act 1995

TERMINATION OF LICENCE ISSUED PURSUANT TO SECTION 56

1. Purpose

The purpose of this Instrument is to terminate Licence No 152 issued on 21 December 1999 pursuant to section 56 of the **Melbourne City Link Act 1995** ("the Act").

2. Authority for Instrument

This Instrument is made under section 56(6)(a) of the Act and in accordance with the Agreement. In particular, the land the subject of the Licence (being the land shown on the plan numbered LEGL./99-203) comprises Section SL3 within the meaning of the Agreement. That Section has reached Completion within the meaning of the Agreement and the State is now required, by clause 4.13 (a) of the Agreement, to terminate licences as to that land.

3. Termination of Licence

The Authority terminates Licence No 152 issued on 21 December 1999 under section 56(1) of the Act, with effect on Thursday, 4 May, 2000.

6. Definitions

Any word, expression, reference or term used in this Instrument which is defined or given a special meaning in the Agreement, the Act or the licences, shall, unless the context otherwise requires, have the same meaning in this Instrument.

Note

The Order in Council under section 59 (2) of the **Melbourne City Link Act 1995** published in Government Gazette No. S56 on 2 May 2000 revoked the Project reservation in respect of the land shown on the plan numbered LEGL./99-203. Section 59 (3) provides that an Order under section 59 (2) has effect

immediately on the termination of the licences under section 56 as to that land. Consequently, the Project reservation of land referred to in that Order is also revoked with effect on 4 May, 2000.
