Melbourne City Link Act 1995

NOTICE OF DECLARATION OF LINK ROAD — SOUTHERN LINK (PART)

I, Peter Batchelor, Minister for Transport and Minister administering the **Melbourne City Link Act 1995** (“the Act”), in accordance with section 61 (3) of the Act, give notice that I have today made a declaration under section 61 (1) of the Act. A copy of that declaration is printed with this notice.

By operation of the definition of “Link road” in section 3 of the Act, the land the subject of the declaration is part of the Link road.

On the publication of this notice in the Government Gazette, by operation of section 61 (4) of the Act, the road specified in the declaration is deemed to be—

- a. a declared road within the meaning of the **Transport Act 1983**; and
- b. a road open to and for use by the public for passage with vehicles; and
- c. a highway within the meaning of the **Road Safety Act 1986**.

The declaration applies to the land described in the declaration, being the parts of Crown Allotment 22A, Section E, City of South Melbourne, Parish of Melbourne South (as shown on the plan numbered LEGL./99-194) that are shown on the plan numbered LEGL./99-203 (printed in Schedule 1 to the declaration). Both plans are lodged at the Central Plan Office of the Department of Natural Resources and Environment. Copies of these plans are available from the Land and Survey Information Centre, Department of Natural Resources and Environment, Ground Floor, 456 Lonsdale Street, Melbourne, 3000.

Melbourne City Link Act 1995**DECLARATION OF LINK ROAD — SOUTHERN LINK (PART)**

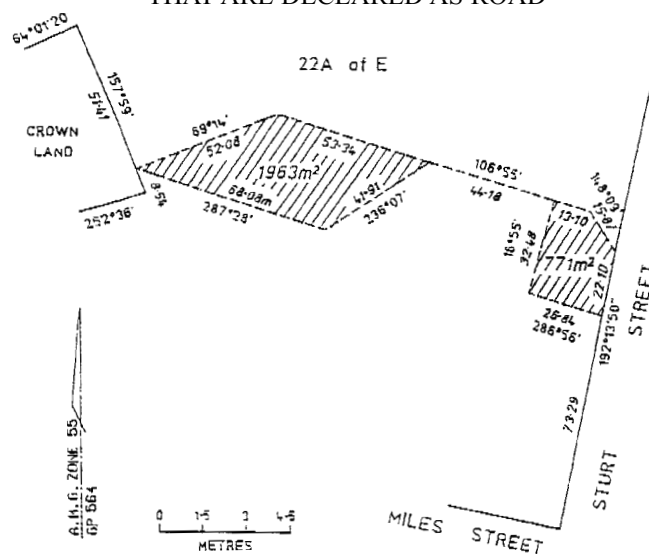
I, Peter Batchelor, Minister for Transport and Minister administering the **Melbourne City Link Act 1995** ("the Act"), acting under section 61 (1) of the Act:

1. Declare to be a road the land and strata of land (being land and strata of land to which section 61 (1) (b) of the Act applies) comprised in the parts of Crown Allotment 22A, Section E, City of South Melbourne, Parish of Melbourne South (as shown on the plan numbered LEGL./99-194 lodged in the Central Plan Office) that are shown diagonally hatched on the plan numbered LEGL./99-203 in Schedule 1 (the original of which is lodged in the Central Plan Office).
2. State that the part of the Link road that is the subject of this instrument is to be treated as a freeway.
