CASINO RULES NOTICE NO. 11 OF 2000

Rules of the Game — Baccarat

By this notice, the Victorian Casino and Gaming Authority amends the Rules in respect of the game "Baccarat" as set out in the Schedule.

This notice operates with effect from 4.00am on 8 June 2000.

Schedule

1. Game definitions using commission model

Substitute rules 11.1.11 and 11.1.12 —

- '1.1.11 "Traditional Baccarat" is a form of Baccarat played where the winning "Banker" hands are paid at odds of 1 to 1 less 5% commission and winning "Player" hands are paid at odds of 1 to 1.
- 1.1.12 "Crown Baccarat" is a form of Baccarat played where winning "Banker" hands are paid at odds of 1 to 1 with the exception of the "Banker" winning with a point score of 6, where winning wagers are paid at odds of 1 to 1 less 50% commission (ie \$100 pays \$50). Winning "Player" hands are paid at odds of 1 to 1.'.

2. Handling of cards

- (1) **Insert**, after rule 7.1.4
 - '7.1.5 A player who accepts the cards may authorise another person seated at the table (whether or not that person has placed a wager) or the Dealer to open one or more of the cards.'.
- (2) **Substitute** rule 7.2.1
 - '7.2.1 If the person with the highest wager on a hand refuses to accept the cards for that hand, the Dealer shall offer those cards to the next highest wagerer on that hand.'.
- (3) **Substitute**, for rule 7.2.6
 - '7.2.6 Only one set of cards, either the player's hand or the banker's hand, shall be handled by a player at any one time.
 - 7.2.7 A player who accepts the cards may authorise another person seated at the table (whether or not that person has placed a wager) or the Dealer to open one or more of the cards.'.

3. Passing the shoe

Insert, after rule 7.3 —

- '7.4 The shoe may be offered to the seated players starting with the player in the lowest numbered seat with a wager on "banker" or "player".
- 1 The Game of Baccarat and its rules were approved by notice published in the Victoria Government Gazette on 24 April 1997 (S44). The rules have subsequently been amended by

 - Casino Rules Notice No. 8 of 2000, published on 20 April 2000 (S51)

- 7.4.1 Should all players decline the shoe then the game shall be dealt in accordance with Rules 7.1, 7.2 or 7.3.
- 7.4.2 The first player to accept the shoe may act as the "banker" or "player" for the purpose only of dealing the cards and receiving and playing the appropriate hand.
- 7.4.3 The dealer shall ensure that a marker denoting "banker" or "player" is placed beside the shoe to denote those cards that are to be retained by the player controlling the shoe.
- 7.4.4 A player who accepts the shoe must only draw and handle the cards at the direction of the dealer calling the game.
- 7.4.5 The player holding the shoe will slide the first card of the player's hand face down in front of them and then slide the first card of the banker's hand face down under the lip of the shoe. The next card to the player will be slid face down and placed next to the first card dealt to the player and the second card to the banker shall be slid face down under the lip of the shoe with the first bankers card.
- 7.4.6 The cards belonging to the player holding the shoe will be retained by that player and remain in clear view of the dealer and game supervisor. The remaining hand shall be passed face down to the dealer who in turn will pass them to the player with the appropriate marker placed next to their wager.
- 7.4.7 When the cards have been turned over by the players the initial banker and player hands will be placed vertically in front of the dealer calling the game in the appropriate area of the layout.
 - 7.4.7.1 Any further cards drawn to either hand will be dealt by the player holding the shoe.
 - 7.4.7.2 The player holding the shoe shall either retain the card belonging to them and once exposed pass the card to the dealer or shall pass the card face down to the dealer.
 - 7.4.7.3 The Dealer shall expose the card or pass it to the relevant player to be exposed.
 - 7.4.7.4 Once the card is exposed the dealer will then place the card/s next to the original cards in a horizontal position.
- 7.4.8 Only one set of cards ie. The banker hand or the player hand may be handled by a player at one time.
- 7.4.9 A player accepting the shoe may retain control of the shoe until either the player elects to relinquish control or the player's wager loses or the player is directed to relinquish control of the shoe by the Pit Boss or above.'.

4. Commission

Substitute, for rules 11.1 and 11.2 —

'11 Settlement

- Settlement of wagers remaining on the table after the completion of a coup shall be as follows
 - 11.1.1 A winning wager made on the player's hand shall be paid at odds of 1 to 1 if the point count on that hand is higher than that of the banker's hand.
 - 11.1.2 A winning wager made on the banker's hand shall be paid at odds of 1 to 1 less 5% commission if the point count on that hand is higher than that of the player's hand.

- 11.1.2.1 Where the version of Baccarat being played is Crown Baccarat, a winning wager made on the banker's hand shall be paid at odds of 1 to 1 except where the banker wins with a point score of 6, where winning wagers are paid at odds of 1 to 1 less 50% commission. (ie \$100 pays \$50).
- Wagers on a tie shall be paid at odds of 8 to 1 if the point count of the player's hand and the banker's hand is equal.
- 11.1.4 The commission shall be collected from a player at the time the winning payout is made, but for seated players only, it may be deferred to a later time.
 - 11.1.4.1 Deferred commission must be settled at the completion of each shoe unless a player requests an earlier settlement. When a player wishes to cease wagering before the end of a shoe any deferred commission must be settled before the player leaves the game.
 - 11.1.4.2 All outstanding commission shall be collected prior to the commencement of the next shoe and in no event shall the collection of any commission be deferred beyond such point.
 - 11.1.4.3 The amount of commission not collected prior to the time of the winning payout shall be evidenced by placing a marker button indicating the amount of the commission owed in the space provided in front of the dealer on the layout imprinted with the number of the player owing such commission.'.

Gaming Machine Control Act 1991 — section 78

AMENDMENT OF RULES (NO. 1 OF 2000)

The Victorian Casino and Gaming Authority amends the Victorian Casino and Gaming Authority Rules 1997 by **substituting**, for rule 3 —

"Gaming periods

- 3. (1) A venue operator may offer gaming to a person only
 - (a) during the period or periods when a licence granted under the **Liquor Control Reform Act 1998** in respect of the premises authorises the consumption on those premises of liquor supplied on those premises; or
 - (b) in the case of premises licensed under Part I of the **Racing Act 1958**, during a race meeting —

but not during any break from gaming that the venue operator takes in order to comply with a condition of a premises approval or a venue operator's licence or section 167 of the Act. *

- (2) A venue operator must, during any period in which the venue operator offers gaming to a person, afford members of the public aged 18 and over unfettered access to the gaming areas of the venue, provided that
 - (a) the venue operator may impose and enforce a code of dress that is reasonable in the circumstances;
 - (b) the venue operator may exclude from the venue a person whose behaviour would be unacceptable in a public place;
 - (c) the venue operator may exclude from the venue a person who has sought to be excluded from gaming venues under a voluntary self-exclusion scheme.".

* Explanatory Note

Compliance with the Act requires a continuous 4 hour break from gaming after every 20 hours of gaming and that there must not be more than 20 hours of continuous gaming each day unless:

- (i) expressly approved by the Authority and indicated in the Notice of Approved Venue; or
- (ii) an application in accordance with the transitional provisions under section 167 of the Act is lodged with the Authority by 6 June 2000 until such an application is determined.
