### **Interpretation of Legislation Act 1984**

#### VARIATION OF ORDER DISCONTINUING CERTAIN BURIALS IN MELBOURNE GENERAL CEMETERY

The Governor-in Council, acting under Section 44 of the **Cemeteries Act 1958** and Section 27 of the **Interpretation of Legislation Act 1984** and on the recommendation of the Minister for Health, varies the Order dated 27 September 1978 relating to the discontinuance of certain burials in Melbourne General Cemetery. The Order is varied to the extent of allowing for the sale of 180 grave sites to accommodate up to a maximum of 540 burials.
