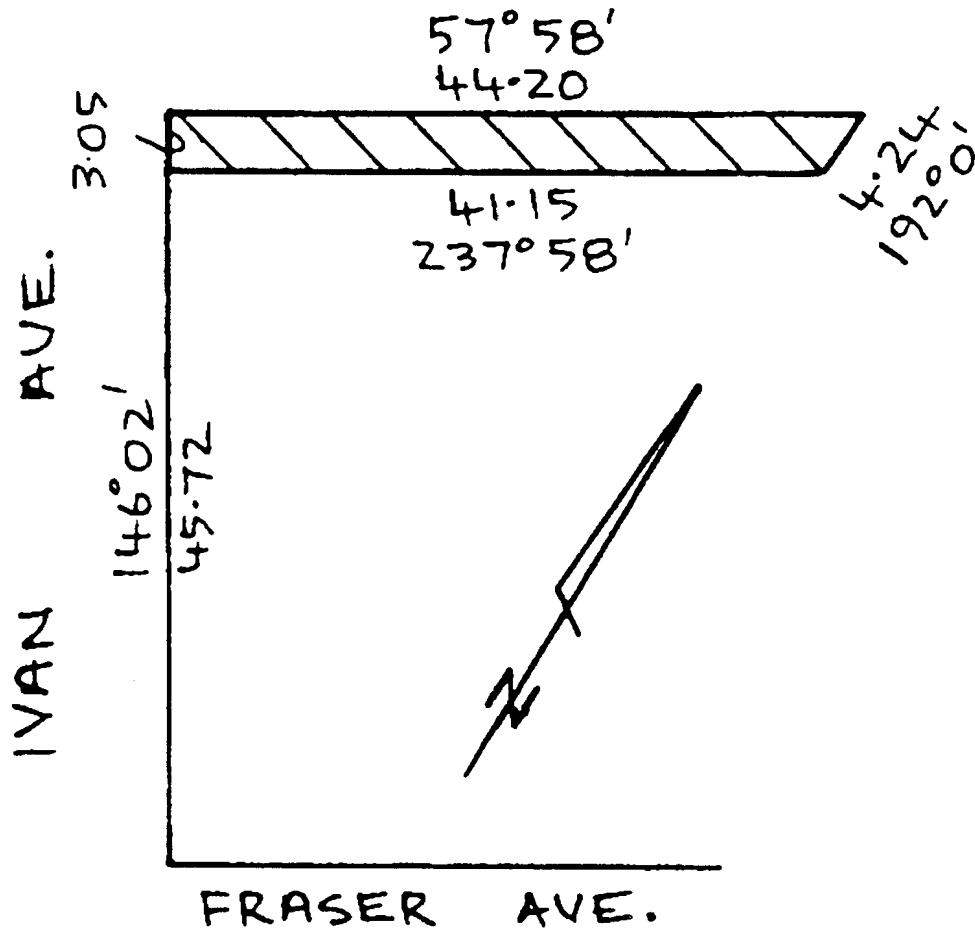

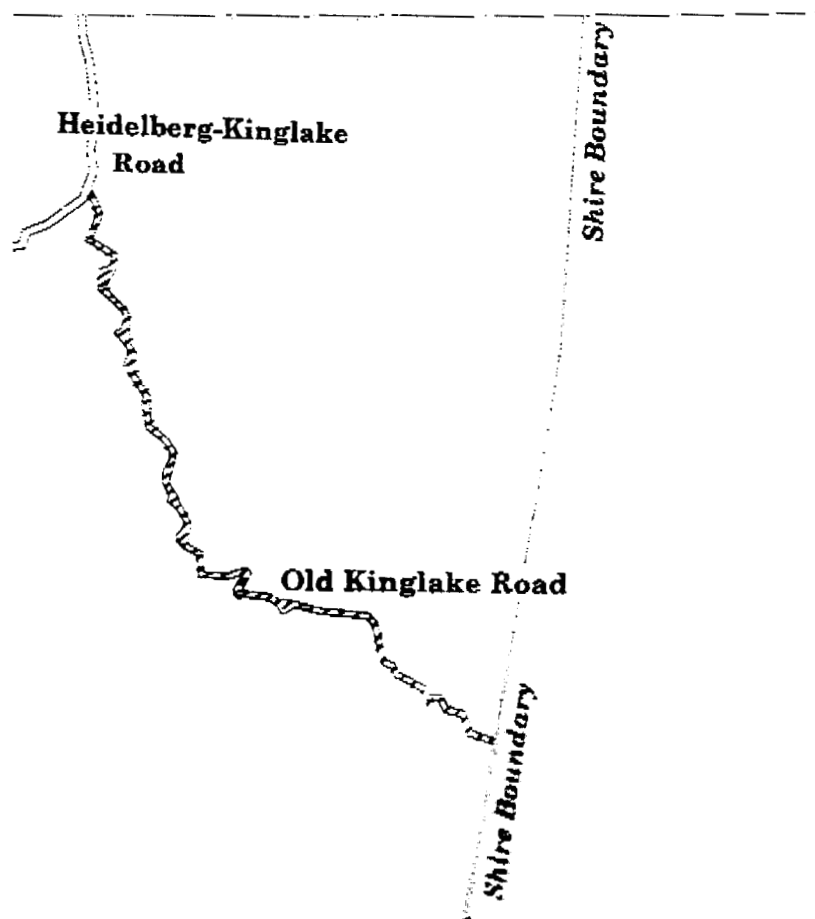


**Discontinuance of Old Kinglake Road**

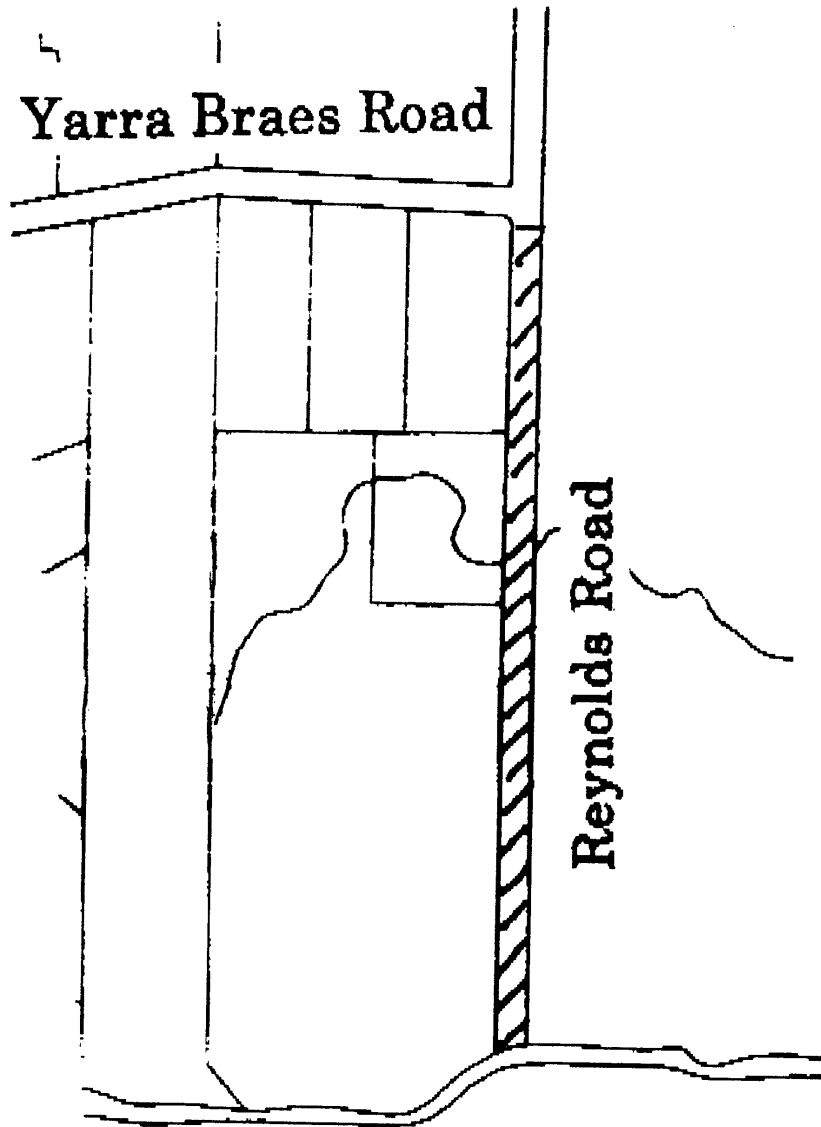

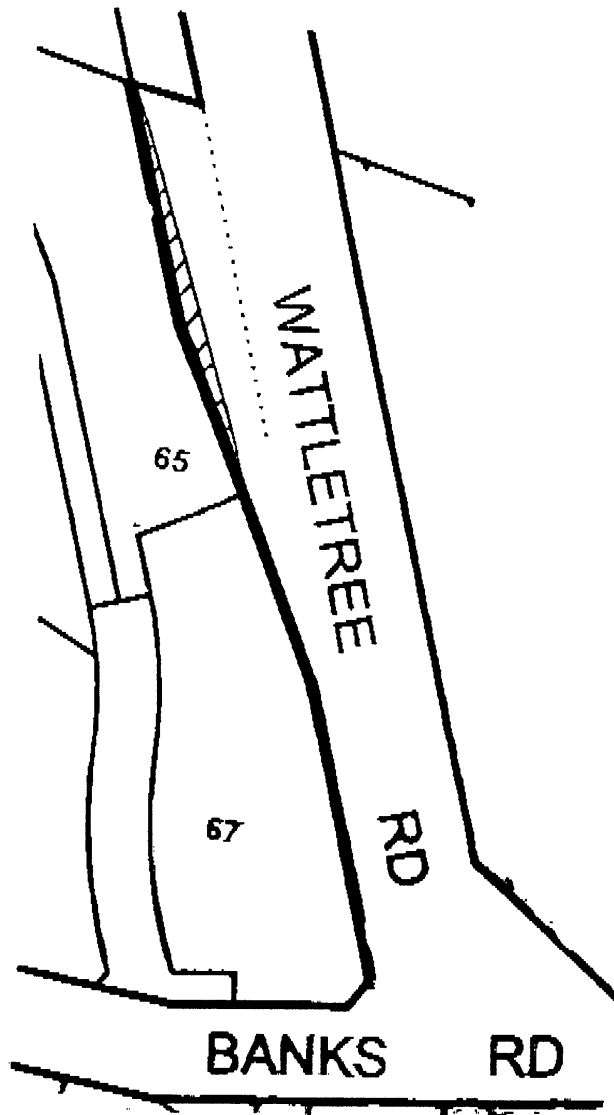

Discontinuance of Part Wattletree Road, Eltham North

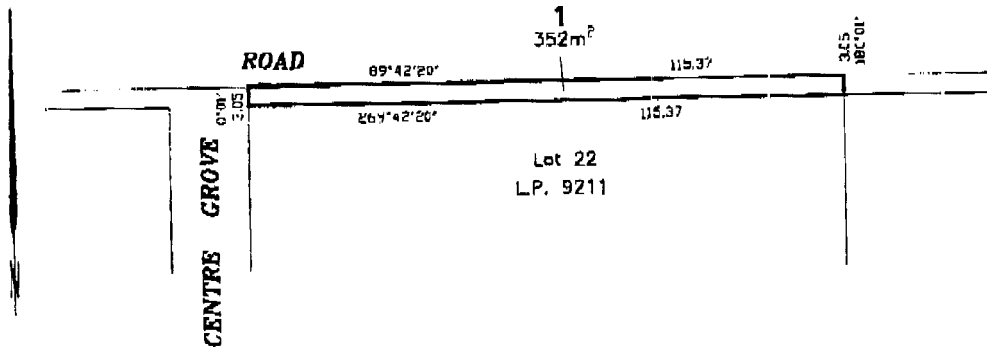

MAKING OF LOCAL LAW NO. 3 –  
ENVIRONMENT

Notice is hereby given in accordance with Section 119(3) of the **Local Government Act 1989** that at a meeting of the Mornington Peninsula Shire Council on 28 June 2000 Council resolved to make Local Law No. 3 – Environment.

The purpose and general purport of this Local Law is:-

- (a) to provide a safe and healthy environment in which the residents of the Municipal District are able to enjoy a quality of life that meets the general expectations of the community; and
- (b) to prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life in the environment of the Municipal District; and
- (c) to facilitate the provision of general public services, health and other community services, property services, recreational and cultural services, and other services in a way which enhances the environment and quality of life in the Municipal District; and

- (d) to control nuisances and noise, odour and smoke emission, and other discharges to the environment which may adversely affect the enjoyment of life within the Municipal District or the health, safety and welfare of persons within the Municipal District; and
- (e) in a way which is consistent with, and in furtherance of, the objectives specified in paragraphs (a) to (d) of this Clause to prohibit, regulate and control activities and circumstances associated with:
  - (i) smoke emission, particularly emission from burning material;
  - (ii) the use of recreation vehicles, particularly recreation vehicles which are not used on appropriate Land or Reserves or which emit excessive noise or air pollution;
  - (iii) dangerous and unsightly land;
  - (iv) private swimming pools;
  - (v) advertising and bill posting;
  - (vi) camping, temporary dwellings and caravans;
  - (vii) festivals;
  - (viii) animals and birds, including restrictions on numbers and the keeping and control of animals and birds;

- (ix) collection and disposal of Waste, including behaviour associated with transfer stations, municipal tips and refuse hoppers;
- (x) objectionable noises at unreasonable times;
- (xi) drains;
- (xii) clothing recycling bins;
- (xiii) storage of machinery and second-hand goods;
- (xiv) open air burning, including burning of offensive materials;
- (xv) trees and plants damaging Council land;

  - (vii) Outdoor eating facilities
 in a fair, equitable and safe manner which does not compromise the primary need for the passage and repassage of people and goods; and
- (g) to control and regulate the naming of roads and display of property numbers; and
- (h) to provide free and safe access for people with sight and movement impairment or disabilities; and
- (i) to control and regulate movable advertising signs and displays of goods on any land and in any public place; and
- (j) to control and regulate roadside trading; and
- (k) to control and regulate the leaving of shopping trolleys on roads, bicycle paths, municipal places or vacant land; and
- (l) to provide for the enforcement of this local law, including issue of notices to comply and infringement notices; and
- (m) to provide generally for the administration of Council's powers and functions; and

(n) to provide generally for the peace, order and good government of the Municipal District.

Local Law No. 6 – Streets and Roads comes into operation on Friday 7 July 2000, and ceases to operate on 7 July 2005 unless sooner amended or revoked by Council.

The Local Law replaces Part 5 – Streets and Roads of Mornington Peninsula Shire Council Local Law No. 1.

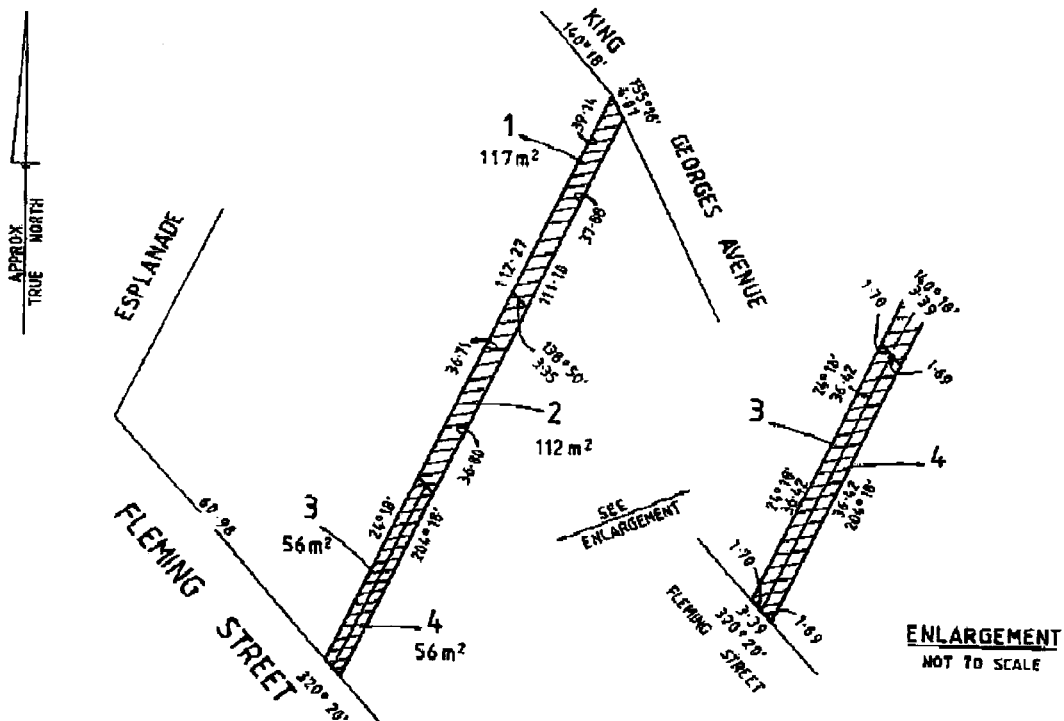

  - The service wants to provide a model of a healthy male and female relationship in the staff team;
  - The service wishes to provide residents with a staff member of the same sex when there is a necessity to teach and provide support in matters of personal and intimate physical care, the staff member being a person with whom the residents feel they have a safe and comfortable relationship; and
  - When away on camping trips as a part of the Electra Street program, it is essential that there be a male staff member who can discretely supervise the male residents when they are using public ablution blocks, and to ensure appropriate behaviour and safety for both the residents and other members of the public.

- SWCHS clients will be those specifically seeking a gender-specific service because they wish to live in a women's-only environment and wish to work through (with female workers) issues associated with their experiences of abuse.

## Amendment C3

The Minister for Planning has approved Amendment C3 to the Campaspe Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The purpose of the Amendment is to provide appropriately zoned land for the future residential and commercial (highway business) growth of Echuca in accordance with the Echuca West Residential Development Outline Development Plan.

The Amendment alters the Campaspe Planning Scheme as follows:

- Deletes all references to the Development Plan Overlay 1 – Echuca West.
- Rezones land north of McSwains Road, west of the Murray Valley Highway, predominantly

south of Echuca–Serpentine Road, and west to the edge of the old Echuca Sewerage Farm from Residential 1 Zone (RIZ) to Business 1 Zone (BIZ), Business 4 Zone (B4Z), Public Use Zone – Education (PUZ2), Public Use Zone – Other Use (PUZ7), and Public Park and Recreational Zone (PPRZ).

- Amends Clause 21.07 to include the Echuca West Residential Development Outline Development Plan as a referred document in the scheme.
- Includes Echuca West Residential Development Outline Development Plan as a Residential Strategy in the Residential Policies at Clause 22.05.
- Rezones Lots 4, 5 and 6 on Plan of Subdivision 406204W from Residential 1 Zone (RIZ) to Business 4 Zone (B4Z).
- Extends DD01 to incorporate all of the land proposed to be zones B1Z or B4Z and all of the RIZ land north of Echuca-Serpentine Road and alters a mapping anomaly.
